FINANCIAL REPORT – YEAR ENDED 31st MARCH 2020 PRESENTED by ROBERT SPEIGHT (Treasurer)

I am presenting this Financial Report prior to an AGM still to be arranged. It is not expected that such a meeting will be able to take place in the near future due to the Covid-19 Virus which has yet to be defeated.

It seems to be quite a while since our charity "temporarily" suspended the operation of its two tea bars on the 19th of March of last year. At this time the Charity was almost at the end of a successful 12 month's trading period which, in retrospect, had fortunately raised sufficient funds to support some very praiseworthy projects.

The Trading Account and Balance Sheets for the year ended 31st March 2020 shows that, together, the Tea Bars had sales of over £ 85,000 with a net profit of in excess of £ 26,000.

At the end of March 2020 when the lockdown occurred, the charity's bank accounts were holding combined balances of just over £ 125.000 even after donations, agreed by the charity's committee, of £57,000 had been made to donors in the year preceding lockdown. These included £ 5025 to the Neuro Rehab Team for an Exercise Machine, £ 9950.00 for a Trolley Pump for Sister Bull of OPD, and 2 Oral Scanners for the Hospital's Orthodontic Treatment Department at a cost of £ 37,318.

Whilst the Tea Bars have been closed, further agreed donations to the value of £ 115,000 have been paid out. These included a £ 96,000 payment to provide five dialysis machines for the use of Dr John Stoves, in his newly reconfigured Renal Department in the Horton Wing of St Luke's Hospital. I'm sure that you must all feel proud that, as Friends of St Luke's Hospital, you are all making an important difference to the hospital you support.
