The Trustees reported that we had 740 members - most new members joined through the website or by word of mouth. The Trustees meet on a regular basis to review activities and solve problems that anse. The Trustees are in regular touch with group coordinators regarding the work of their groups and the costs of hiring venues.

From March 2020 the effects of Covid 19 began to be felt and the Trustees and many groups started using zoom and meeting virtually resulting in substantially reduced costs.

Our AGM was held on 12^{\pm} October 2020, three months later than usual because of the occumstances. This was held on Zoom and 67 members attended. In addition 20 members voted by proxy.

Proposals to extend the subscription year by four months thus creating a new subscription year commencing 1 January and granting four months free membership, and to reduce the membership fee for the year commencing 1 January 2021 by 50% were carried

The accounts for the year were approved by the meeting and the existing Committee re-elected for the following year. Due to the effects of the pandemic the Independent Examiners report was deferred to early in 2021.
