TRUSTEES ANNUAL REPORT FOR 2020

1.REVIEW

1.1 ACTIVITIES

In common with all other parishes the activities of St. Bartholomew's have been severely curtailed by the Covid 19 pandemic. In particular, fund raising has been put on hold and the pattern of services significantly disrupted with a material impact on income. In September the Reverend Sally Epps retired after a distinguished and hugely valued ministry in the Parish and wider Benefice. St. Bartholomew's has been without a Rector since then. The Churchwardens, supported by the PCC, have implemented a policy, when legal and prudent, to open the Church for Sunday services and for private prayer on at least one weekday.

In the united Benefice of St. Bartholomew's, St. Philip's Burwash Weald and St. Nicholas Etchingham, work has continued to bring the three parishes into a coherent whole. Quarterly joint services are planned; however, because of restrictions on Church opening during the year, these have not always taken place. Close relationships are maintained with the two primary schools (Burwash and Etchingham); several Trustees serve as Governors at Burwash.

The Church continues to be maintained through the commitment of volunteers giving freely of their time and talents.

Extensive work has been carried out in the Churchyard and on routine repairs to the fabric of the Church. Additionally, a major project was commenced and completed during the year to re-tile the Nave and the roofs of the North and South aisles. Competitive tenders were obtained and the work was carried out during the Autumn. Upon payment of the final 'retention' monies this will have cost just under £100,000, Significant donations were made towards the costs and in addition, a successful Appeal for funds was led by the Friends of St. Bartholomew's.

PUBLIC BENEFIT AND OBJECTIVES

- 1.1.1 In accordance with Section4(6) of the Charities Act 2006 and the Charities (Accounts and Reports) Regulations 2008 the Trustees confirm that they have given due regard to the guidance on public benefit issued by the Charity Commission when exercising their powers and duties during the period.
- 1.1.2 St. Bartholomew's Church is an inclusive and welcoming community; it exists through the generosity of benefactors of an earlier age and continues under the supervision of the PCC, Churchwardens and the Rector. With the continued generosity of local people, it provides Church of England Christian worship for the parish of Burwash and a place of quiet reflection and solace for all.

Individual members of the congregation make donations to charity through specific collections both within and outside the Church. In addition, donations are made to charities directly by the PCC and also from collections at informal fund raising events. Collections are normally taken in Church for The Royal British Legion Poppy Appeal on Remembrance

Sunday and have been taken for The Children's Society following the Christingle Service. A food Bank continues to operate for the benefit of the Diocesan Association for Family Support Work. Christmas collections were given equally to Emmaus and the Children's Society.

- 1.1.3 One objective of St. Bartholomew's is to be a focal point of the village; the Burwash Village magazine, which is currently published 'online' has now completed its second full year and plays a significant part in this objective. A number of activities designed to provide outreach to the wider community have, sadly, been severely curtailed; notable among these are:
 - 'Tuesday Drop In' providing an informal social occasion for all, but particularly for parents and carers bringing children to school;
 - weekly '3 C's Coffee cake and chat mornings; a popular free event valued especially by those living alone;
 - the 'Children's Corner usually open during the day, enabling children to play with toys in a quiet dry and warm atmosphere;
 - Quarterly Coffee Mornings and second hand book sales;
 - 'Saints & Sausages'
 - Christmas Tree Festival and the School's PTFA Christmas Fair;
 - Remembrance Day 'Act of Remembrance'
 - School Services. Although no formal School services took place in Church due to Covid restrictions, the School did come into Church in their 'bubbles' to lay poppies on the altar for Remembrance Day. Also, some key stage two pupils came in their 'bubbles' to record some of their Carol Service for streaming to parents. Food items were collected from the School for Harvest.
- 1.1.4 The Church is normally open during daylight hours and is visited by many people seeking tranquillity or records of their forebears. Church opening during the year has, however, been severely restricted in accordance with Government guidelines. Many messages of appreciation have been received, in particular that we have continued with services and private prayer when permitted. The following is a small selection of these messages:
 - a lifeline in these difficult times
 - a beautiful church and beautifully kept churchyard, full of quiet reverence
 - lovely church, really lovely feeling of peace and joy
 - very welcoming, lovely service, kind and welcoming congregation
 - thank you for leaving your church open. As Roman Catholics we prayed that we all be one
 - thank you for continuing the Food Bank collections

1.2 FINANCE

The General Fund shows an excess of receipts over payments of £904; additional costs amounting in total to £7316, which related to the routine maintenance of the fabric of the Church and to the Churchyard, were paid from the Curteis and Morris Funds, respectively. Due to Covid Planned Giving and collections in Church have declined by about 10% from 2019 levels. The Parish Giving Scheme continues to operate efficiently supported by 30 members; it is a pity however that more members of the congregations do not take advantage of the benefits of the Scheme. For similar reasons Fund raising income, day to day donations and sundry receipts have decreased significantly.

The level of reserves in the General Fund (£5421) is not considered to be adequate. This determination is made by judging the reasonable likelihood of sufficient income being received to meet liabilities as they arise.
