#### **TRUSTEES' REPORT FOR THE YEAR ENDED 31 DECEMBER 2020**

The past year has been totally different to anything we have experienced in the past. Mainly due to the COVID-19 pandemic, it has been disastrous year for the Welfare in more ways than one. Firstly, over the Christmas (2019) period and into this new year (2020) we were having a lot of problems with the gas boiler which supplies all the Welfare including the steward and stewardess living accommodation. The Trustees decided that it would probably be more practical and economical to get rid of the boiler which was at least 37-year-old. The Trustees decided that 2 boilers would be better than one, one for the Welfare building and one for the living accommodation upstairs. After consulting with our boiler engineers, exploratory work was carried out. This was due to the complexity of the Welfare building and the nature of the work that would have to be carried out to complete the task. The long and short of it all was that it could be accomplished. The Trustees decided to go ahead with the work and the work was completed several weeks later.

Just when we thought things could not get any worse on the 30/03/2020 we received a devastating phone call informing us that Mr. Paul Maciejewski one of our Trustees had sadly died suddenly. Paul was a great asset to the Welfare, with numerous skills sets which were invaluable at times to the Welfare. Paul would never take no for an answer, he was always there ready to help anyone out no matter what it was. He will be dearly missed by everyone at the Welfare. The Trustees are hopeful that soon some type of memorial could be established to honour our great friend Paul.

The Steward had reported to the Trustees that he had noticed water bubbling up between the decade and steps at the back of the skittle Alley. ACB were called out to investigate the problem. Part of the decking and steps had to be removed to repair the leak. Throughout the first lockdown the Trustees along with the secretary and staff have all worked tirelessly to maintain the upkeep of the Welfare, both inside and outside. Also, in preparation for the reopening we are implementing every single rule and regulation stipulated by the Government and local authorities to try and safeguard our members to the best of our ability. We would eventually reopen on the 26th of July but not on the scale we are accustomed to due to all the restrictions imposed by the Government. The Welfare was losing a considerable amount of income each week one of the main reasons being all the functions that had been booked were cancelled, deposit refunded, and no more bookings would be taken for the rest of the year. Regrettably, we would go into lockdown again on the 4th of November with a lot uncertainty about whether we would be open for Christmas. On the 4th of December, of the Trustees held their last meeting of the financial year 2020. The main topic being Christmas with no guarantees at the time of the meeting that we were going to be open or closed. After analysing the figures, the Trustees decided to remain closed, as it would not be financially viable to open the Welfare at this moment in time, we also wanted to keep our staff and members safe. The Trustees along with the secretary /treasurer are doing everything feasibly possible to keep the Welfare a viable business, for the present we remain financially sound.

I would like to take this opportunity on behalf of the Trustees and myself, to thank all the members that supported the Welfare while we were open. We would also like to thank Garry

Once again on behalf of the Trustees I would like to thank all members and staff for their continuing support given to the Welfare.

#### 1 Accounting policies

#### BASIS OF ACCOUNTING

The accounts of the Welfare are prepared in accordance with the historical cost accounting rules.

#### DEPRECIATION

Fixed assets are depreciated by annual instalments over their estimated useful lives at the following rates : Furniture and fittings - 10% on net book amount

Equipment - 10% on net book amount

#### STOCKS

Stocks are stated at the lower of cost and net realisable value. Cost is computed on a first in first out basis. Net realisable value is based on estimated selling price less the estimated cost of disposal.

#### INDEPENDENT EXAMINER'S REPORT TO THE TRUSTEES OF HEANOR MINERS' WELFARE TRUST

I report on the accounts of the Trust for the year ended 31 December 2020, which are set out on pages 4 to 11.

#### Respective responsibilities of trustees and examiner

The Welfare Trustees are responsible for the preparation of the accounts. The charity's Trustees consider that an audit is not required for this year under section 144 of the Charities Act 2011 (the Charities Act) and that an independent examination is needed. It is my responsibility to :

- examine the accounts under section 145 of the Charities Act,

- to follow the procedures laid down in the general Directions given by the Charity

Commission (under section 145(5)(b) of the Charities Act, and

- to state whether particular matters have come to my attention.

#### Basis of independent examiner's report

My examination was carried out in accordance with the General Directions given by the Charities Commission. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts, and seeking explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit, and consequently no opinion is given as to whether the accounts present a "true and fair" view and the report is limited to those matters set out in the statement below.

#### Independent examiner's statement

In connection with my examination, no matter has come to my attention:

- to keep accounting records in accordance with section 130 of the Charities Act;
