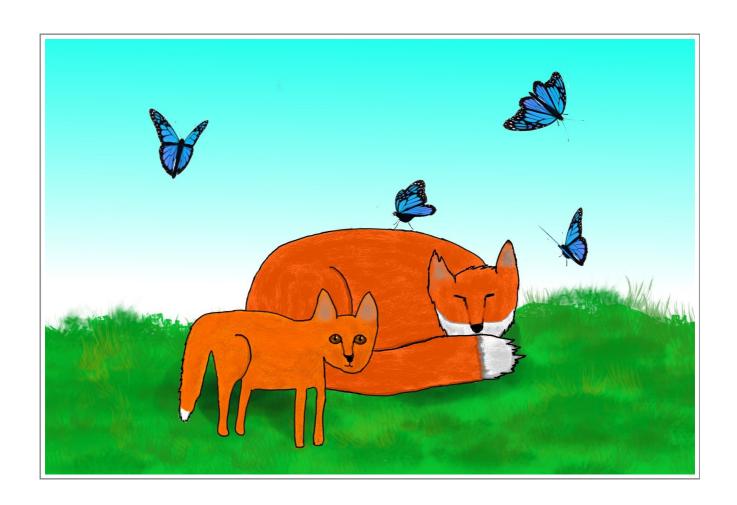

Chairman's Report For the year ending 31st March 2020

The past year has been a successful year for the charity, We have continued to offer a secure environment for our families and to provide a wide range of stimulating, challenging and enjoyable activities both outside and within the venue. Our relationship with our landlord continues to be very positive and we are able to meet regularly and discuss any issues as and when they are identified.

Volunteer number have been steady over the year. some volunteers have moved on to other things but we have been fortunate in being able to replace them. We can always use more volunteers so we continue to actively seek to recruit.

The Trustees continue to work together for the benefit of the Charity and the people it supports. The trustees have reviewed the charities aims and Objectives referring to the Charity Commission's general guidance on public benefits. The trustees have also reviewed the session charges and agreed to leave them at the same level, but will be encouraging our families to pay by standing order to reduce cash transactions. The Charity continues to be inclusive and therefore affordability is always in the front of our minds.

We have had a number of changes to our Trustees this year. One trustee left due to work commitments and two others left due to a posting overseas. We successfully managed to replaced them and also increased out number. We now have six, very committed, Trustees.

During the summer of 2019 we again worked with Students from Bath University on their Practice Track Program. We worked with two teams to promote the work of the Charity and Autism in general. It was very successful and everyone took some learning from the program. We look for to continuing and building on this relationship.

We continue to enjoy a very positive relationship with both BaNES and Keynsham Town Councils and regular work with other Charities in the local area. Towards the end of the year, we were very fortunate in obtaining a Lottery Fund grant. The grant covers four years core funding which puts the Charity on very secure footing for the next few years and gives the Trustees a bit of breathing space so we can concentrate on moving the Charity forward. I would like to say a very big THANK YOU to the National Lottery Fund for the grant and their continuing support also, everyone involved in making the bid successful.

As I write this there is the possibly of a pandemic effecting the country. There is talk of possible lockdowns. This leaves a lot of unknowns for the coming year. Whatever happens, we will do best to continue to offer a service to our families.

I would like to say a big thank you to all our volunteers, Trustees, Funders and St Francis Church for all their support during the last year. Also a big thank you to our Parents/Carers, children and young people for their continuing support.
