Objects of the Charity and principle activity

The objects of the Charity are the advancement of education through the provision of resources and facilities and the provision of further residential care at Bleasdale School, Carnforth, Lancashire.

Results

During the financial year 1st April 2018 to 31st March 2019 income exceeded expenditure by £28,519.51.

Developments during the year

The Charity continues to fulfil its primary objectives to provide resources and facilities for the advancement of education.

The focus for the year was to fundraise for a new fully inclusive playground. This has been successful and with joint funding from the Charity and the School Budget the playground was installed in June 2019. The new Rebound Therapy Suite and Sensory Room refurbishment were both completed in 2018 as proposed.
