The trustees have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the charities aims and objectives, and in planning future activities.

In Pursuit of the purposes of the charity, which is to advance the Christian faith for the public benefit, Bethel Prophetic Centre has reached the Preston area during 2020, but also further afield including overseas, by the provision of facilities for public worship and prayer. However, during the period beginning March 2020, services have been adapted in order to keep within the restrictions brought about by difficult circumstances due to the outbreak of COVID 19.

Trustees and Elders had to make decision to adjust to the guidelines given by the Government during the first Lock Down and delivered all services online. This presented challenges for the congregation as well as the church leadership, where congregation members could not have the opportunity to benefit from the usual services offered by the Charity.

Once lockdown was lifted, services resumed, but again with restriction in attendance numbers. The impact of this meant that some members were reluctant to attend and therefore were unable to engage in activity that has given them the benefits of the services offered by the Charity. This situation has continued to impact the Charity in that numerous members have not returned to the receive the offering set out by the Charity. The consequences of which are being felt by the communities that can and have benefitted.

To this end, throughout the year, we have attempted to engage with the community in the best possible way, in line with guidelines. We have maintained public worship and prayer on a weekly basis. We hold midweek Wednesday meetings to reach out to the needy, who require material assistance. We have also continued to teach the biblical view on Prophecy and to activate people.

We aim to continue with our normal operations throughout the coming year.
