## 2 Structure, Governance & Management

## 2.1 Type of Governing Document

Constitution – based on the Charity Commission's model governing document for Foundation Charitable Incorporated Organisations, *i.e.*: where the Trustees are the only Members of the charity.

#### 2.2 Charitable Objects

As defined in My Charity's Constitution (Governing Document): The charity's objects ("objects") are:

To relieve financial hardship, distress and suffering amongst Poor People, Orphans and other people in need by means of, but not exclusively making grants or loans for providing or paying for items, equipment, services and facilities, including the provision of food, water and clothing, costs for medical treatment and costs for attending School for the benefit of the said persons. To advance education for the benefit of the general public by means of, but not exclusively, the provision or assistance in the provision of educational activities and facilities, such as schools and training centres for the benefit of the persons.

To advance the religion of Islam, by means of, but not exclusively, promoting teachings and the tenets of Islam via the assistance in the provision of facilities for Islamic education in accordance with the teachings of the Quran and Sunnah of the Prophet Mohammed (Peace and Blessings be Upon Him) as interpreted by the Ahle- Sunnah Wal Jamaah School of Thought.

#### 2.3 Trustee Selection Methods

There must be at least two charity trustees. The maximum number of trustees is 5.

In accordance with the Constitution, Trustees are appointed or re-appointed for a term of three years by a resolution passed at a properly convened meeting of the charity trustees.

In appointing Trustees due consideration is given to ensuring that the Trustees have, between them, the skills and experience necessary to manage the charity effectively and in accordance with charity law.

## 3 Activities

#### 3.1 Activities

Hijaz Welfare Trust (HWT) delivered an 'Eye Camp' in rural area in District Rawalpindi, Pakistan during March 2020. A lot of People in this area are poor, costs of medical treatment is unaffordable for them. The object of the Camp was to screen, remove Cataracts and provide glasses where necessary over the three-day Camp.

The Camp was preceded with advertisement campaign in local newspaper, cable network, social media, banners, posters and announcements in mosques at Friday congregational prayers.

We collaborated with team of Doctors from U.K who operate a charity themselves (Optimed). They hold Eye camps throughout Pakistan as part of their sponsored charity work.

The object of Hijaz Welfare Trust's Ramadan Food Programme was to deliver food packs to families who are in most need this year. Under this programme HWT delivered food 450 packs consisting of Rice, flour, oil, pulses, tea, sugar and other food items based on the need of beneficiaries. These vital food supplies supported those fasting without needing to worry about finding funds for their family's meals.

This programme was successfully implemented in and around the villages of Tehsil Kallar Seydan, Pakistan.

Soon after the extremely successful Ramadan Campaign. During the months of April and May 2020, at onset of Coronavirus Pandemic the effort was extended to the delivery of food packs to families whose source of income was from daily works of its member(s).

This programme adequately supported families whose members found themselves out of job because of lockdown and no way of providing for families meals. HWT responded by funding and implementing the distribution of 800 food packs to families who were severely affected by the lockdown. These families were not getting any support from Government of other Humanitarian agencies.

During the month of June/July. There was appeal from One Nation; a U.K registered Charity to support their Humanitarian effort by providing the Food packs and water to people in Yemen. Hijaz Welfare trust donated £1800.00 towards provision of Food packs and four water tanks.

### 3.2 Statutory Declaration

The Trustees of the charity confirm that they have paid due regard to the guidance issued by the Charity Commission on public benefit in deciding what activities the charity should undertake.

## 4 Achievements & Performance

#### 4.1 Achievements

The Eye Camp was huge success, with turn-out of about 1600 people to be screened of which 118 people receiving cataract operations. These people would have otherwise not been able to afford the corrective Operations. As result of screening 545 people received reading glasses. Many were sign posted for other eye ailments.

The Ramadan Food Pack project was another big achievement for HWT. 480 families benefitted from food pack assistance. These families would otherwise would have suffered hardship during the month of Ramadan.

The Pandemic Food assistance programme was even better success for Hijaz Welfare trust. With tremendous hard-work from our local volunteers we were able to distribute 760 food packs to families most affected by lack of work and probable food shortage.

The financial contribution from Hijaz welfare trust assisted in allowing ONE NATION to deliver the food packs and water tanks to Yemeni people in ongoing Humanitarian crisis.

## 4.2 Outputs and Outcomes for the Charity's Beneficiaries

Out of the 1600 or so men and women screened 118 got free Cataract operations. These people would otherwise have gone without treatment.

The food and water programmes helped families at their time of great need.

#### 4.3 How the Public Have Benefitted.

With setting up of the Eye Camp 118 poor people received Cataract operations. 535 people received glasses for long Sight.

The food and water programmes; in all three cases has benefited a significant number of poor people; it evidently helped people in crisis.

## 4.4 Contributing to Activities Run by Other Organisations

Hijaz Welfare Trust responded to the appeal sent out on media and Social Media regarding the Humanitarian crisis in Yemen. The appeal was for the provision of food and water. The monies donated by Hijaz Welfare Trust enabled ONE NATION to provide food packs and 4 water Tanks.

## 4.5 Trustee Development

Trustees are encouraged to participate in development opportunities as and when appropriate.

## 5 Financial Review

## 5.1 Details of Any Funds Materially in Deficit

The Charity has no funds which are materially in deficit.

## 5.2 Policy on Reserves

The Charity's policy on reserves is to generate and maintain a balance which is sufficient:

- a) to preserve the financial viability of the Charity in the event that unforeseen and/or unavoidable circumstance precipitate a short-term fall in its income;
- b) to enable the Charity, in the interests of meeting its objectives, to undertake from time to time the setting up of new and innovative projects on a pilot basis to demonstrate the viability and potential benefits of such activities as a precursor to securing the external funding necessary to maintain such projects on an on-going basis.

For these purposes the Charity will endeavour to generate and maintain reserves to the initial amount of £500.

## 5.3 Principal Sources of Funding and Outgoings

The principal Sources of funding will be from family, friends and business community. The funds of the charity will be spent on charitable causes

#### 5.4 Remuneration of Trustees

All Trustees act in a voluntary capacity and receive no remuneration or other material benefits from their services to the Charity.

Out-of-pocket expenses necessarily and reasonably incurred by Trustees in promoting the purposes of the Charity are reimbursed at cost.

#### 5.5 Financial Status

Though modest, Small Charity Support's current resources from unrestricted donations are more than sufficient to meet its outgoings for at least next year. All the indications are that this will remain the case for the foreseeable future.
