# **Annual Report of the Parochial Church Council 2020**

## Structure, Management and Governance

The Parochial Church Council of the Ecclesiastical Parish of St. Peter, Formby (St Peter's PCC) was registered as a charity on 4<sup>th</sup> March 2009 - Registration No 1128383.

St. Peter's PCC operates under the Parochial Church Council Powers (Measure) 1956, the Charities Act, the Church Representation Rules & the Church Accounting Regulations 2006.

The format of the financial statement and the scrutiny required is in compliance with the Charities Act and the associated regulations and the Charity Commission's Statement of Recommended Practice (SORP 2017 FRS 102)

The method of appointment of PCC members is set out in the Church Representation Rules. All church members are encouraged to register on the Electoral Roll and stand for election to the PCC.

PCC members are made aware of issues such as trustee responsibilities, basic health and safety, risk assessment and management, and child protection procedures. Individual members of the PCC receive external training as and when deemed appropriate by the PCC

Day to day management of the Church is exercised by the Standing Committee which is the only committee required by law. It has the power to transact PCC business between PCC meetings and considers strategic issues which may affect the Church

Other related trusts: **St. Peter's Formby Educational Trust 2015**— registered charity 1168392. The trustees are the Vicar and Churchwardens for the time being of St Peter's Church.

#### **Risk Assessments:**

To identify their major risks, the PCC has undertaken a programme of assessments. Procedures were then put in place to manage those risks and minimise their impact on the life of the church. Action in the main areas of risk has been taken as follows:

## i) Financial Risk

An annual budget is prepared to ensure short term viability. Actual results compared with budget are considered at every meeting of the Finance Committee and reported to the full PCC. The investments held by the PCC are reviewed regularly by the Finance Committee. Investments are only made through the CCLA. All assets are insured and levels reviewed annually and approved by the PCC. The PCC has approved internal controls for annual accounts, cash and cheques handling and these controls are regularly monitored. Also, the banking arrangements and the operation of electronic banking are subject to regular monitoring.

## ii) Health and Safety

The Fabric Committee regularly reviews health and safety issues and reports to the PCC. The PCC has been appraised of the risks and the necessary compliance requirements and these are being complied with.

## iii) Child and Vulnerable Adult Protection

All those working with children and vulnerable adults have been formally checked under current legislation. It is the policy of the PCC that all those who work closely with children or vulnerable adults are vetted and cleared through the Disclosure & Barring Service and Online Safeguarding Training. David Johnson is the PCC Safeguarding Co-ordinator and the PCC policies are maintained in line with legislation and with Diocesan advice.

#### iv) Operational Risk

In the event of the church becoming unusable for a limited period the Church Hall would be available.

## Objectives and Activities

The general functions of the PCC are stated within section 2 of the Parochial Church Councils (Powers) Measure 1956.

St Peter's Parochial Church Council (PCC) has the responsibility of co-operating with the incumbent, in promoting in the ecclesiastical parish, the whole mission of the church, pastoral, evangelistic, social & ecumenical. The PCC is also responsible for the maintenance of:-

- The Church and graveyard
- The Bier House
- The Curate's House

## **Achievement of Objectives for 2020**

## Objectives for 2020:

- 1. In 2020 there will be a new Stewardship campaign focusing on skill and time. Due to the national pandemic it was not possible to run a new Stewardship campaign in 2020 and it has been deferred until an appropriate time.
- 2. To encourage and support Revd Nathan Thorpe as he is licenced as Vicar of St Giles Aintree. The people of St Peter's said a sad but thankful farewell to Revd Nathan Thorpe as he was licenced as Vicar of St Giles Aintree. Nathan's ministry throughout his curacy has been very much appreciated. His curacy also shows how St Peter's embraces the opportunity to be involved in the training of curates and can give the encouragement and experience needed to give a good foundation for future ministry.
- 3. Finance to continue to explore new income streams and ways of reducing unnecessary expenditure.
- 2020, when there could be no services held in church for many months, highlighted the importance of the Parish Giving Scheme along with other ways of giving which do not rely on the plate collection. We are thankful for the work of the Finance Committee during this difficult time. New ways of giving have been introduced which include the option of donating through the website and contactless giving. We are very thankful for the generosity of so many during this difficult time. The equipment for live streaming was installed and a fee will be charged for when it is requested for weddings and funerals.
- 4. To continue to look at ways the parish can be more active beyond our boundaries and to help individuals to be able to be involved in mission, particularly the Uganda Project.

When the church building was closed for services in March we did what we could to utilise the porch and grounds for mission and ministry. There were prayers in the porch, the cross of hope in the churchyard and our prayer tree. Plants were delivered to parishioners on Mothering Sunday and at Harvest Thanksgiving. At the beginning of the first lockdown cards offering assistance were delivered to our more vulnerable parishioners and many phone calls were made; as well as helping those coping with bereavement, postponed weddings and baptisms and general isolation. The porch is now a Foodbank Collection point and has helped keep our ministry visible. There has been an incredible response of items donated and financial support given. The Easter garden was a witness when we could not open our church for Holy Week and Easter and the churchyard became a daily mini pilgrimage for so many. The children's ministry continued and there was Sunday Club at Home on the website and zoom services. The Magazine is an important outreach tool and was continued and delivered to homes. Chocolates were delivered to the fire station, pharmacies, care homes on behalf of St Peter's saying thank you to those who worked on the front line. The website became a very important means of communication.

We are able to keep up our support of our overseas project in Uganda - St Peter's Primary School, St Peter's Church and the Women's Project in Kalule, Uganda. The work began on establishing a chicken project which has been maintained even though the people of Uganda were also in lockdown. Due to the involvement of St Peter's, Formby, the Ugandan government have built two new school buildings.

5. To be aware of the new people attending St Peter's services and how to encourage them beyond the initial welcome to feel part of the St Peter's community.

We have new people now attending St Peter's both in person when the church building has been open and worshipping with us on the zoom services. It is hoped that in 2021 we can continue to encourage those who join our community.

6. To continue our commitment as a training parish and support a new Curate, Simon Macaulay.

Simon Macaulay began as our Curate in July 2020 but due to restrictions was not ordained deacon until 26<sup>th</sup> September 2020. Simon has settled into parish life even though personal interactions have not been possible and services and meetings have been held remotely.

7. To begin work towards a Gold Eco Church Award and so reduce our carbon footprint.

Work towards a Gold Eco Church Award was difficult during 2020 though we continue to do all that we can to be an environmentally friendly parish. We are now part of a Deanery Eco Group which encourages all the churches in the deanery.

8. To assist and support our new churchwarden as he/she undertakes his/her role and responsibilities.

We are delighted that Sarah Gorman became Churchwarden in October 2020 and we are committed to continuing to supporting both our Churchwardens in their roles.

#### The Electoral Roll

The revised Electoral Roll contains 186 names (119 resident, 67 non-resident). It has been on display since 1 October. Since the last APCM there has been one deletion and one addition. Of the 164 who declared their date of birth: Age 16-40 - 9; Age 41-65 – 40; Age 66+ - 115. The average age on the Electoral Roll is 70.4.

## Worship: Average Attendance

Due to the church building be closed it is not possible to give accurate average attendances for 2020. The church building closed for public worship on Sunday 22<sup>nd</sup> March and remained closed until 5<sup>th</sup> July.

In 2020 there were 8 baptisms, 0 weddings, 30 funerals and 19 interments.

Christmas Services: approximately 225 attended the five restricted Christingle services. 84 people attended the Christmas Eve Midnight Eucharist and Christmas Day.

During 2020 an increasing number engaged with the pre-recorded services, the zoom services and the live-streamed services. This way of worshipping in the pandemic has been extremely important to our community and beyond.

**Church Fabric:** repair and maintenance is done on a regular basis. In 2020, expenditure totalled £13,765 -the major items included installation of live streaming equipment in Church (£5,137) and the church flooring being refurbished (£2,874).

**Church yard**: Total expenditure was £4,903 which included tree work (£960), gardening contractors (£2,470), tree work (£685), bench (£468) and gravestone work (£445).

**Finance, Giving and Fundraising:** Our Parish Share in 2020 was £93,223 which was an increase of over 7.0% over the previous year. The Parish Share contributes towards the cost of ministry both in our own parish and other churches less fortunate than us. The amount we received in Planned Giving was £78,228 plus an additional £2,336 received via the collection plate. Gift Aid Tax reclaimed was £22,655 which includes £624 under Gift Aid Small Donations Scheme on loose plate collections.

A large number of givers now use the Parish Giving Scheme which allows direct debit payments to be made from their bank. The Scheme provides many benefits and supports an annual review of giving. We would encourage all givers to take up this system of giving.

A total of £10,300, which incorporated 10% of voluntary income received, was donated to many local, national and overseas charities during the year. Additionally, £1,000 was set aside for the Uganda Overseas Development Project.

Additionally; seasonal collections collected during the year raised funds totalling £3,586 including gift aid which benefitted the following charities

- Train a Priest
- Church of England Children's Society

50% of donations received at baptisms are shared by the PCC with a nominated children's charity. This resulted in a total during the year of £187 being given to Sefton Young Carers.

During the year a fund was set up (Horizons Reserve fund) to assist with pastoral needs in the Parish due to the impact of Covid19. Income was £1545 and expenditure £751. Income was largely due to a substantial anonymous donation.

Our major fund raising activity was for the Oversea Development project – Uganda Appeal and a magnificent total figure of £7,003 for 2020 was received. Expenditure on this project amounted to £4,716. This is an ongoing project with more developments over the coming months.

#### **Financial Review**

Each year a Budget Plan is approved by The Parochial Church Council and performance is monitored regularly throughout the year at meetings of the various committees. Any variations from the budget are addressed and appropriate actions taken

Our budgeted figures in 2020 have adversely impacted by the coronavirus epidemic resulting in closure of the Church, Parish Hall and Bier House for an extended period. Plate collections have reduced by £4,007 from 2019. Show me this number

However the voluntary income level underpinned by the Parish Giving scheme has maintained a remarkable resilience during the year although there was a reduction of £5,288 from the previous year.

As the Church office was closed for the months of April to July 2020 two of our employees i.e. one Parish secretary and our cleaner were placed on the Coronavirus Job retention Scheme which offset their salary costs for the period.

In order to simplify the position we transferred the 'ownership' of the Curates House in Kenton's Close to the Heywood Bequest. In future all income will accrue to the Bequest and it will also cover all expenditure on the property. In order to achieve the transfer Heywood Bequest funds were sold and transferred to the Rowlandson Bequest and the PCC.

We are fortunate at St Peter's to have substantial Trust funds which have provided a regular stream of income over the years. This income has enabled us to undertake repairs and maintenance to the Church and Church properties. However, Trust fund capital or income is not available for us to use towards the payment of our Parish Share.

Our planned Stewardship campaign was cancelled due to the pandemic which we hope will happen in 2021 as we need to increase our voluntary income to meet our ongoing commitment.

Our overall position in 2020 resulted in a net loss of £29,316 however this was offset by gains in investment assets of £32,465 giving a positive outcome of £3,149

#### Funds held as Custodian Trustees on behalf of others

### a) Agent transactions

DBF (Statutory) fees remitted to Liverpool Diocesan Board of Finance amounted to £5,938. PCC Fees distributed to Clergy as fees for Weddings and Funerals was £309.

## c) Third Party Charity- Funds Held

Funds received and disbursed in respect of the Church Hall managed by St Peter's PCC on behalf of St Peter's Educational Trust amounted to £4,754.

**Performance of investments** is seen in the long term and is subject to on-going monitoring.by the Finance Committee.

CCLA is our fund manager who manages CBF funds recognise that the business cycle is over a period of years and their aim is to grow the capital in the CBF Investment Fund and also generate an income, which will protect against inflation.

Overall all Trust funds showed an increase in value of 7.0% during 2020

Investment income in 2020 amounted to £12,255.

The performance of our investments continues to be reviewed regularly by the Finance Committee and is subject to recommendations following appropriate professional advice.

The rental income from Victoria Hall was £9,656.

The contributions relating to our Curate's house have been agreed between ourselves and Holy Trinity finished in May 2020. In 2020 we received income of £1,835

The low interest environment is continuing and it is not possible to maintain the income levels historically seen on our cash deposits. This position is under regular review by the Finance Committee.

## **Reserves Policy**

It is the policy of the PCC to maintain a balance on unrestricted funds which equates to approximately six month's unrestricted payments, to cover emergency situations that may arise from time to time. Due consideration in this calculation has been given to the potential high costs arising from repairs due to the age of the Church.

#### Plans for the Future

The general functions of the PCC are stated with section 2 of the Parochial Church Councils (Powers) Measures 1956.

When planning our objectives for the year, the PCC gave consideration to the Charity Commission's guidance on public benefit and, in particular, the specific guidance to charities with the advancement of religion.

## **Objectives for 2021**

- 1. In 2021 there will be a new Stewardship campaign focusing on skill and time. A major focus is to look at how we can develop new leaders involved in children's ministry.
- 2. Finance to continue to explore new income streams and ways of reducing unnecessary expenditure and to be aware of the impact of 2020.
- 3. To continue to look at ways the parish can be more active beyond our boundaries and to help individuals to be able to be involved in mission, particularly the Uganda Project.
- 4. To encourage new people attending St Peter's services including those who have connected through zoom, live stream and pre-recorded services.
- 5. To continue our commitment as a training parish and support our Curate, Simon Macaulay.
- 6. To begin work towards a Gold Eco Church Award and so reduce our carbon footprint.

#### PAROCHIAL CHURCH COUNCIL OF ST PETER'S, FORMBY NOTES TO THE FINANCIAL STATEMENTS For the year ended 31 December 2020

#### 1 Accounting policies

The financial statements have been prepared in accordance with the Church Accounting Regulations 2006 together with applicable accounting standards and the current Statement of Recommended Practice, Accounting and Reporting by Charities and applicable accounting standard FRS 102

The financial statements have been prepared under the historical cost convention except for investment assets which are shown at market value. The financial statements include all transactions assets and liabilities for which the PCC is responsible in law. They do not include the accounts of church groups that owe their main affiliation to another body, nor those that are informal gatherings of church members.

#### **Funds**

Endowment funds are funds, the capital of which must be maintained; either permanently or at the PCC's discretion; the income derived from the endowment may be used either as restricted or unrestricted funds depending upon the purpose for which the endowment was established in the first place.

Restricted funds comprise (a) income from endowments which may be expended only on the restricted purpose intended by the donor, and (b) revenue donations or grants received for a specific PCC activity intended by the donor. Where these funds have unspent balances, Interest on their pooled investment is apportloned to the Individual funds on an average balance basis

Unrestricted fund's are general funds which can be used for PCC ordinary purposes.

Designated funds are general funds set aside by the PCC for use in the future. Project funds are designated for specific project for administation purposes only. Funds designated as invested in fixed assets for the PCC's own use are abated in line with those assets' annual depreciation charges in the SOFA. Designated funds remain unrestricted and the PCC will move any surplus to other general funds.

#### incoming resources

Planned giving, collections and similar donations are recognised when received. Tax refunds are recognised when the incoming resource to which they relate is received. Grants and legacies are accounted for when the PCC is entitled to the use of the resources, their ultimate recept is considered reasonably certain and the amounts due are readily, quantifiable. Dividends are accounted for when declared receivable, interest as and when accrued by the payer. All incoming resources are accounted for gross.

#### Resources expended

Grants and donations are accounted for when paid over, or when awarded, if that award creates a binding or constructive obligation on the PCC. The diocesan parish share expected to be paid over is accounted for when due.

All other expenditure is generally recognised when it is incurred and is accounted for gross.

#### Fixed assets

Consecrated and benefice property is not included in the accounts in accordance with s.10(2)(a) & (c) of the Charities Act 2011.

Movable church furnishings held by the vlcar and churchwardens on special trust for the PCC and which require a faculty for disposal are inalienable property, listed in the church's inventory, which can be inspected (at any reasonable time). For anything acquired prior to 2000 there is insufficient cost information available and therefore such assets are not valued in the financial statements. Subsequently, no individual item has cost more than £1000 so all such expenditure has been written off when incurred.

The Curate's house - 3 Kenton Close Formby, is Included at deemed cost.

Equipment used within the church premises is depreciated on a straight-line basis over four years. Individual items of equipment with a purchase price of £500 or less are written off when the asset is acquired.

Investments are valued at market value at 31 December.

#### **Investment Property**

Investment property is included at fair value. Gains are recognised in the Statement of Financial Position.
