Chairman's Report on behalf of the Trustees for Capheaton Village Institute

We continued in 2019 providing a local facility for all and everyone to use. The structure of the hall has not changed during the year. There have been no changes to either the trustees or management team in 2019.

Our main source of income continues to be our successful weekend Tearoom which operates for 50 weekends per year. We have five local people employed part-time on a regular basis and try to use suppliers who have a link to our community. As always trade is very weather dependant and the atrocious weather in the autumn and early winter has had a detrimental effect upon takings. However, we have an extremely loyal customer base who very much appreciate what we offer and we are very grateful to them. Ellie, our Tearoom manager, has introduced a lot of new cakes and traybakes to revamp what we offer and to make us differentiated from other tearooms in the district. These are proving to be very popular.

The bar facility we provide on a Thursday evening is proving to be more of a concern for the Trustees. Customer numbers have fallen considerably and Andrew our bar supervisor has become somewhat disillusioned, we wonder if it is a "sign of the times" in that people will come to a daytime tearoom but not an evening bar. We shall monitor the situation going forward and financially we are not too exposed so are keen for it to continue but it has to work for all concerned.

The hall was used a few times for other events and we continue to offer the building at very favourable hiring rates for anyone in our community.

On behalf of the Trustees I would like to thank everyone who contributed to the ongoing success of our village hall.
