**(a)** Providing or assisting in the provision of education, training, and necessary support to enable individuals to generate a sustainable income and become self-sufficient **(b)** The relief and assistance of people who are victims of war or natural disaster or catastrophe by the provision of emergency aid, food, clothing and shelter **(c)** The advancement of animal welfare for the public benefit by the provision of programmes to increase access to veterinary care and treatment **(d)** The advancement of environmental protection and improvement by the provision of access to sustainable waste management and the provision of programmes to increase awareness on environmental conservation and biodiversity


