### Report of the Trustees for the Year ended 30th June 2020

The Trustees present their Annual Report and Financial Statement for the year ended 30th June 2020. The Financial Statement has been prepared in accordance with the Constitution of Severn Dean Lions Club (CIO) dated 19th April 2018 and the requirements of the Charities Act 2011.

### Structure, Governance and Management

Severn Dean Lions Club achieved Registered Charity Status on 19th April 2018 as a Charitable Incorporated Organisation (CIO), part of Lions Clubs International. The Club is managed in accordance with its Constitution and Grant making Policy, approved by and registered with the Charities Commission. The Club elects a minimum of 3 Trustees annually, normally at the Annual General meeting held in April each year. As a result of the Covid 19 pandemic, it has not been possible to hold routine business meetings in person, since March 2020. The planned Annual General Meeting was also cancelled. Routine business has, since March 2020, been conducted by e-mail correspondence; expenditure being approved by a quorum of members and the approval of Trustees as indicated in e-mails agreeing courses of action. The Trustees volunteered to continue in post until such time as elections may be held in person at an Annual General Meeting. For personal reasons, one Trustee, TREVOR LEONARD FIRMAN, stood down at the end of the Financial Year (FY).

Routinely Members and Trustees meet monthly to receive reports from Officers and Trustees; to consider business matters and to decide on:

A Programme of Events

Volunteering Activities

Grants and applications for Assistance from organisations and individuals in need.

This year meetings have continued using Zoom since the lockdown began; however since some members are unable to access Zoom-type meetings, all Financial Decisions and other Organisational Decisions have been reached by the aforementioned e-mail process seeking a quorum of views. Records of Decisions reached in this way have been kept for audit purposes.

#### The Year's Activities in Summary

#### Incomes

The Club enjoyed income from just one event in the FY, the annual Lions Speech House Bonfire and Fireworks, organised jointly with Forest of Dean Lions, held in this FY on 2nd November 2019. Inclement weather resulted in reduced attendance and therefore reduced income for the 2 Lions Clubs of £1500 each, whilst maintaining a working reserve of £7918 for the staging of any future Bonfire event.

The subsequent cancellation of fund-raising events, as a result of the Covid-19 Restrictions, including: the Forest of Dean Office Chair Racing Championships due to be held on Easter Sunday, 12th April 2020; the annual Wild Boar Chase postponed from May to September in 2020 and subsequently also cancelled; and other minor fund-raising activities; has significantly affected the Charity's income in the FY.

One small addition was the support of an initiative called "Packed in Case'. A local volunteer had coined the idea of a "Packed in Case" Leaflet which encourages people to be prepared in case of hospital admission by having a check list of "Packed in Case" essential items ready to take with you, as well as a check list for items to add at the last minute, and their location, to assist Paramedics or family members to gather the essentials for the patient. The Club initially supported a trial print run and subsequently successfully applied to the Government's Covid-19 Contingency Funds managed by the Forest Volunteer Action Forum for a Grant of £1000 for a production run of the leaflets. These funds are shown as Restricted Funds in the Annual Accounts and were subsequently spent in full in the next FY which will be shown in next year's accounts. The leaflets were distributed throughout the Forest of Dean through Doctor's Surgeries, Chemists, Supermarkets and NHS agencies. They have been taken up in other parts of the United Kingdom including Northern Ireland, often being produced locally.

Having successfully registered for Gift Aid, the Club Accounts now show membership subscriptions and disbursements. Although these funds are held in a separate Bank Account to comply with Lions Clubs International requirements, they are now aggregated in to the overall Charity's Accounts.

#### **Expenditure, Grants and Assistance**

The accounts show the details of various Expenditure, Grants and payments totalling  $\pounds 23,004$ . Notably, a number of organisations and people in need have benefited from the Club's reduced ability to provide Grants and Support:

A number of Welfare cases, where the Club's early intervention has supported families in need with White Goods, furniture and furnishings.

Schools and young people in the Forest have benefited from specific support for projects; including continued Sponsorship of the Mitcheldean Festival Forest Young Poets competition, held this year by e-mail submission and judging.

Donations were made to a number of other Charities in the Forest, including the Forest Foodbank, and the local Dilke Hospital for inpatients comforts. The Club also supported individual childrens' special needs through other Charities such as Toucan.

The Club has maintained a working balance of £13,186 at year's end; which includes the Restricted Funds of £1000 for Packed in Case; and the Bonfire and Fireworks Account future Reserve of £7,918. Actual Cash Funds, available for disbursement going forward stood at £4, 268.
