Description of the charity's trusts	
Type of governing document	The Group's governing documents are those of the The Scout Association. They consist of a Royal Charter, which in turn gives authority to the Bye Laws of the Association and The Policy, Organisation and Rules of The Scout Association.
How the charity is constituted	The Group is a trust established under its rules which are common to all Scouts.
Trustee selection methods	The Trustees are appointed in accordance with the Policy, Organisation and Rules of The Scout Association.
	The Group is managed by the Group Executive Committee,
	the members of which are the 'Charity Trustees' of the Scout Group which is an educational charity. As charity trustees they are responsible for complying with legislation applicable to charities. This includes the registration, keeping proper accounts and making returns to the Charity Commission as appropriate.
Policies and procedures adopted for:	The Committee consists of 4 independent representatives, Chair, Treasurer, Secretary and Subscription Secretary together with the Group Scout Leaders, individual Section Leaders, parent's and supporters representatives and meets every month.
	Members of the Executive Committee complete ' <i>Essential</i> <i>Information for Executive Committee</i> ' training within the first 5 months of joining the committee.
	This Group Executive Committee exists to support the Group Scout Leader in meeting the responsibilities of the appointments and is responsible for: The maintenance of Group property;
	The raising of funds and the administration of Group finance; The insurance of persons, property and equipment; Group public occasions;
	Assisting in the recruitment of leaders and other adult support; Appointing any sub committees that may be required; Appointing Group Administrators and Advisors other than those who are elected.

Section B	Structure, governance and management (continued)
	Risk and Internal Control The Group Executive Committee has identified the major risks to which they believe the Group is exposed, these have been reviewed and systems have been established to mitigate against them. The main areas of concern that have been identified are:
	Damage to the building, property and equipment. The Group would request the use of buildings, property and equipment from neighbouring organisations such as the church, community centre and other Scout Groups. The Group has sufficient buildings and contents insurance in place to mitigate against permanent loss.
	Injury to leaders, helpers, supporters and members. The Group through the capitation fees contributes to the Scout Associations national accident insurance policy. Risk Assessments are undertaken before all activities.
	Reduced income from fund raising. The Group is primarily reliant upon income from subscriptions and fundraising. The group does hold a reserve to ensure the continuity of activities should there be a major reduction in income. The Committee could raise the value of subscriptions to increase the income to the group on an ongoing basis, either temporarily or permanently.
	Reduction or loss of leaders. The group is totally reliant upon volunteers to run and administer the activities of the group. If there was a reduction in the number of leaders to an unacceptable level in a particular section or the group as a whole then there would have to be a contraction, consolidation or closure of a section. In the worst case scenario the complete closure of the Group.
	Reduction or loss of members. The Group provides activities for all young people aged 6 to 18. If there was a reduction in membership in a particular section or the group as whole then there would have to be a contraction, consolidation or closure of a section. In the worst case scenario the complete closure of the Group.
	The group has in place systems of internal controls that are designed to provide reasonable assurance against material mismanagement or loss, these include two signatories for all payments and a comprehensive insurance policies to ensure that insurable risks are covered.

Financial Review

Reserves Policy

The Group's policy on reserves is to hold sufficient resources to continue the charitable activities of the group should income and fundraising activities fall short. The Group Executive Committee considers that the group should hold a sum equivalent to 3 months running costs, circa £4K.

Investment Policy

The Group's Income and Expenditure is required for day to day operations and as a consequence the Group does not have sufficient funds to invest in longer-term investments such as stocks and shares. The Group has therefore adopted a low risk strategy to the investment of its funds. All funds are held in cash using only mainstream banks or building societies. The Group Executive regularly monitors the levels of bank balances and the interest rates received to ensure the group obtains maximum value and income from its banking arrangements. Occasionally this may involve using an account that requires a period of notice before funds may be withdrawn, before doing so the Group Executive considers the cash flow requirements.

Plans for future periods (details of any significant activities planned to achieve them)	The COVID-19 outbreak has meant all activities and income is supended. This is likely to have a significant effect of income from subscriptions, fundraising and rental income in the next financial year. Our reserves are sufficient to survive the current difficulties.

Our Leadership numbers have taken a dip this year with younger leaders choosing not to return as often (due to their university courses). I would like to say a huge thanks to all the Leaders for their hard work and dedication to our youngsters and scouting. They give up an enormous amount of time to ensure that we are able to provide a varied programme of events.

We have welcomed Darren Betteridge to our Leadership team. Lewis Grinham, Jack Eustace and Adam Jones, who have progressed from being at least a Cub (one having joined as a Beaver) through the sections to a Young Leader and have now chosen to take on a full leadership role. Sections are still struggling to run due to the shortage of leaders and are having to close more often than they would like. We now require more section leaders, assistants or occasional helpers. Are you able to help, are you interested or know someone who is? Please talk to any of the leaders or me and we will happily inform you of what is/is not involved. Thank you to those parents who have already volunteered to be an occasional helper. If we fail in recruiting more leaders then we will have no alternative but to enforce a parent's rota.

From March onwards we have been unable to meet Face to Face due to Covid 19. I have to thank all Leaders for their support and engaging in meetings online via either Zoom or GoggleMeets. Thanks to all members and their parents for helping to facilitate these meetings and joining in whilst still engaging in completing badges at home.

Thank you for all your support, especially those that attend or help with our fundraising. I have to say that, as usual, I am very disappointed with the uptake of parents who attend our fund-raising events. For any scout group to run efficiently it relies on support at fundraising events, without it we will at, sometime in the future, have to increase subscriptions substantially! With this in mind I would point out that

we currently have a Cheese and Wine event and a live music evening in June. Please support these, it is very demoralising when the events are not supported.

We have had a fantastic year and we have invested 26 new Beavers. We have been awarding lots of badges including 1 Chief Scout Challenge (the highest Beaver award), 5 Adventure Challenges, 3 Outdoor Challenges, 5 Personal Challenges, 5 Skills Challenges, 9 Teamwork Challenges, 5 World Challenges, 2 Book Readers, 5 Collectors, 1 Creative, 1 Cyclist, 13 Disability Awareness, 1 Experiment, 1 Explore, 4 Faith, 1 Gardeners, 1 Photography, 1 Safety, 17 Space, 3 Sports. 9 Air Activity, 13 Hikes, 2 Musician, 10 Nights Away and 7 Joining In Badges. These have all been achieved with a lot of hard work from the Beavers and the Leaders.

The Leaders provide a varied, exciting group of activities, dedicating a lot of their time, outside of the normal meeting time, to ensure that the programmes meet with the requirements of the badges and the rules set by the Scouting organisation. We have had sleepovers, visited parks, RAF Cosford, joined in District events, worked on our Camp Crafts (just a visit to a Cub camp to go) and had a Santa craft activity day. We have had several visitors Kreepy Critters, who brought along a variety of creepy animals, spiders, snakes, lizards and frogs, the Police, who spoke to the Beavers about Safe Strangers and allowed the Beavers to dress up in their gear.

We have had a consistent leadership and my thanks go to Cathy, Sarah, Liz, Hannah, and Young Leaders Poppy, Lydia and Millie. They all work tirelessly and without them Beavers wouldn't work as well as it does. This could take the form of an Occasional Helper (someone who takes out a DBS with the group but doesn't progress to a full leaders warrant and only helps occasionally) or, you could opt to become a Full Leader with a progressive training programme. If we don't get any new Leaders we will have to start operating a parents rota.
