Committee members are appointed annually at the Preschool Annual General Meeting, by the members of the Preschool.

C. Objectives and activities

The aims of the Preschool are to enhance the development and education of children primarily under statutory school age by encouraging parents to understand and provide for the needs of their children through community groups and by offering appropriate play, education and care facilities for all children whatever their race, culture, religion, means or ability.

D.Achievement and performance

Occupancy continues to fluctuate as pre-school children movie up to infant school. During this year numbers have picked up.

Fundraising is going well again for the pre-school.

We have continued to put plenty of effort and time into getting the pre-school to achieve an improvement in the Ofsted rating.

It is Preschool policy to maintain a balance on unrestricted funds, if possible, which equates to at least one months unrestricted payments, equivalent to £4 400. The balance held of £13,298 exceeds this target.

Financial Review

Total receipts were £62k, up from E45k last year — while childcare fees were reduced, the DCC payment for the first term in September 2018 was received early.

There was no grant income received during this year.

We rely on fundraising for the pre-school to enable improved equipment and resources for the children.

The net result for the year was an excess of receipts pver payments of £9,395.

South Wingfield preschool playgroup bank account with Yorkshire Bank, fell victim to fraud in May 2018. The fraud team managed to trace all funds and were refunded within a matter of weeks.
