Plans were made in the first part of the year for video clips to be made documenting current attitudes to equality for uploading to the website. Unfortunately the Covid pandemic hit in March 2020. This immediately put an end to face to face meetings and planning. Making videos remotely was not possible with the technology available to the charity. It soon became clear that central funds would be directed to helping established arts and equalities institutions to maintain their financial position in light of lockdown and the closure of theatres etc. The decision was taken (via electronic means) to suspend activity pending the outcome of various government initiatives.
