Summary of the purposes of the charity as set out in its governing document	Para 1.17	The Parochial Church Council (PCC) of the Ecclesiastical Parish of St Mary's Frittenden has the responsibility along with the incumbent, Revd Peter Deaves, in promoting the whole mission of the church pastoral, evangelistic, social, and ecumenical. St Mary's Frittenden is united as a benefice with Trinity Church, Sissinghurst with whom we work in close partnership.		
Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.	Para 1.17 and 1.19	The PCC OF St Mary's Frittenden is committed to encouraging as many people as possible to worship at the church and to become part of the parish community. Our services and worship put faith into practice through prayer and scripture, music and sacrament.		
Statement confirming whether the trustees have had regard to the guidance issued by the Charity Commission on public benefit	Para 1.18	When planning our activities for the year, the Rector and the PCC have considered the Charity Commission's guidance on public benefit and, more specifically, the guidance on charities for the advancement of religion. In particular, we try to enable ordinary people to live out their faith as part of our parish community in a number of ways. These include: 1) worship and prayer. 2) learning about the gospel. 3) developing their knowledge and trust in Jesus. 4) provision of pastoral care for people living in the parish.		

Achievements and Performance

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	In a normal (COVID-19 free) environment, the PCC holds a wide range of church services every month that those attending find beneficial and spiritually fulfilling. These services also offer Sunday Club for children, while a new "Families Together" initiative was introduced during the year to reach out to this age group and replaced Messy Church. There are also other opportunities for parishioners to learn about the gospel with a regular weekly home group and a course held during Lent (both currently via Zoom). The PCC also looks after the wider community (when restrictions allow) with a lunch planned twice a year to which those most in need in the village are invited. St Mary's Frittenden has undergone some major capital improvements over the last few years which has involved moving the organ to make way for the provision of kitchen and toilet facilities as well as a new meeting room on the mezzanine floor. Some pews have also been removed to create a larger area for social interaction after each service as well as an additional meeting area if so required. The final retention payments for these improvements were made during the year. A new Rector was appointed in November 2019 and was installed on 27 February 2020. At the beginning of the year, during the interregnum phase, the Church continued to run a normal programme of services and events. Although it was not possible to hold services in church for a large part of the year, an online service was offered every Sunday (in conjunction with Trinity Church in Sissinghurst) while, for the initial lockdown, there were also two Compline services during the week. The number or people accessing these services held up over the year and it was evident from the website metrics that they appeared to be reaching a wider audience than just the regular congregations.

Although 'Open the Book' assemblies in the schools has not been able to take place the Rector has been back into both schools since they have reopened and is providing pastoral support.
At the beginning of lockdown, the churches in both parishes organised support for village residents who were isolating or not able to travel to collect prescriptions and day to day food shopping. In addition, a programme of pastoral care was put in place to look out for the isolating, the vulnerable and any in need.

Review of the charity's financial position at the end of the period	Para 1.21	Total receipts on an unrestricted basis were marginally ahead at £69,553 while total unrestricted payments were £66,285 resulting in an unrestricted surplus of £3,268. After allowing for restricted receipts and payments, total receipts amounted to £77,368 and payments £83,944 giving an overall deficit of £6,576.				
Statement explaining the policy for holding reserves stating why they are held	Para 1.22	The PCC agreed a policy in 2019 of transferring up to £5,000 into a restricted Church Fabric Fund to provide for future works when surplus funds are available. In 2020, we transferred a further sum of £3,000. In particular, our Quinquennial inspection in 2018 identified some major work which will be needed to the Church spire in the next few years. The Restoration Fund represents the balance of the funds left over from our recent redevelopment programme. A large part of the overall cash reserve is held in a low-risk interest-bearing deposit account.

A description of the principal risks facing the charity Para 1.46		The principal risk is having enough income to cover our regular outgoings (such as Parish Share) which is dependent on our regular giving and other donations. This is more of a risk when we are unable to hold church services or hold fund-raising events (such as during the current COVID-19 pandemic) but some of this additional risk has been offset by a lower level of day-to-day running costs.

It also includes the Churchwardens and any lay representatives on the Deanery Synod, Diocesan Synod or General Synod who are on the Electoral Roll of the Parish. The number of elected representatives on the PCC depends on the size of the Electoral Roll. As our church has between 50 and 100 members on the Electoral Roll, we are currently able to have up to 9 members on the PCC who serve a 3-year cycle.
