Review of Activities

The main activity of the charity has continued to be the provision of holiday facilities to provide respite for children with cancer and for their families. Grants are also made to help with the cost of respite holidays. During the year 27 such grants were made. In addition, the charity organised a further trip to Euro Disney for children suffering from cancer and for their immediate families. Other grants have been made to alleviate hardship for those falling into the target group of the charity.

A donation of the Sterling equivalent of £565 was made to the International Society of Paediatric Oncology European Neuroblastoma Research Network (SIOPEN)to assist with a project to build a research network to ultimately improve the survival in children suffering from neuroblastoma.

The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the Trust's aims and objectives and in planning future activities.

The charity had a successful year in terms of fundraising. The charity continues to receive the support of many companies, organisations and individuals who have assist the charity by making direct donations, by sponsored events and by attending the various fundraising events organised by the charity during the year.
