# **Thurmaston Old School Community Centre**

# Report of the Trustee Board for the period 1 January 2020 to 31 December 2020 inclusive

#### Scope of Annual Report 2020

The Annual Report usually covers only the financial year 1 January to 31 December inclusive. However, it is difficult to write the Annual Report 2020 without referencing significant events in the life of the charity which fall in part after the end of the financial year:

- 1. The closure of the community centre on 23 March 2020 to comply with COVID lockdown rules.
- 2. The decision of the Trustee Board on 26 May 2020 that the closure should be permanent, and that the premises and site should be sold.
- 3. The subsequent sale of the premises and site on 7 January 2021.
- 4. The decision of the Trustee Board on 15 February 2021 that application should be made to the Charity Commission to dissolve the charity and remove it from the Register of Charities, once appropriate formalities had been concluded.

#### Formation and financial year

Thurmaston Old School Community Centre is a Charitable Incorporated Organisation and Registered Charity 1175521. The charity was registered with the Charity Commission for England and Wales on 2 November 2017.

## **Objects of the charity**

The objects of the charity are, for the public benefit: 1. To promote the whole mission of the Church of England, pastoral, evangelistic, charitable, social and ecumenical for the benefit of the ecclesiastical parish of Thurmaston, St Michael & All Angels; and 2. To further or benefit the residents in the ecclesiastical parish of Thurmaston, St Michael & All Angels and the neighbourhood including visitors, without distinction of sex, sexual orientation, race or of political, religious or other opinions by associating together the said residents and the local authorities, voluntary and other organisations in a common effort to advance education and to provide facilities in the interests of social welfare for recreation or other leisure time occupation with the objective of improving the conditions of life for the residents and visitors.

#### **Constitution and Rules**

The charity operates in accordance with a constitution registered with the Charity Commission for England and Wales. The Trustee Board exercised its power under Article 26 of the Constitution to modify Rules on 19 October 2020.

#### Trustee Board

The charity is led by a volunteer Trustee Board, supported by other volunteers. The charity employs no staff.

The Trustee Board had delegated some day-to-day management functions to an Executive, comprising the Officers and other Ex-Officio Trustees. The Executive was abolished when the rules were modified on 19 October 2020.

## Policies

The Trustee Board maintains policies for the charity. Policies required by law, including those listed below, have been adopted and are reviewed annually.

## Safeguarding

The charity provided the facility of a community centre for church and community groups, family occasions, etc. The charity does not itself provide any activities for children or vulnerable adults. The charity required evidence of safeguarding arrangements from regular hirers who provided activities for children or vulnerable adults within the facility owned and managed by the charity until the premises were closed and subsequently sold.

#### Ownership of the premises

The charity owned and managed the premises known as Thurmaston Old School Community Centre, situated at 736 Melton Road, Thurmaston, Leicester LE4 8BD until 7 January 2021. The Leicester Diocesan Board of Finance (Registered Charity 249100, Company number 227087) acted as Custodian Trustee for the premises on the charity's behalf.

#### Management of the premises

The premises owned by the charity until 7 January 2021 were built in 1844 with subsequent extension and alterations. The charity was committed to providing a safe environment for premise users and volunteers. The following were completed in accordance with statutory / best practice requirements, and appropriate remedial actions were taken as required.

- Fire Safety Risk Assessment
- Periodic Electrical Inspection
- Portable Appliance Testing
- Gas Safety Certificate
- Asbestos Management Report

The premises and users were protected by a fire alarm system and emergency lighting which was regularly serviced and tested. The premises were inspected regularly in terms of fire safety and general health and safety compliance. Repairs and maintenance to the fabric of the premises were undertaken both reactively as required and proactively as part of a planned programme of works.

## Use of the premises

Thurmaston Old School Community Centre was a popular venue for a wide variety of church and community activities and family occasions until the premises were closed.

# **Closure of the premises**

The premises were closed on 23 March 2020 to comply with COVID lockdown rules. The Trustee Board subsequently decided on 26 May 2020 that the closure should be permanent and that the premises and site should be sold "given the condition of the building, the repairs that would be required to maintain the building to a satisfactory standard, the significant cost of such repairs, and the limited finances available – particularly in the current economic climate".

## Sale of the premises

Following a Valuation Report produced by Innes England, the premises and site were marketed for sale by Innes England, and subsequently sold on 7 January 2021. The net proceeds of the sale were received by the charity.

## Application to dissolve the charity

The Trustee Board decided on 15 February 2021 that application should be made to the Charity Commission to dissolve the charity and remove it from the Register of Charities. In accordance the constitution of the charity, the net assets of the charity will be applied to Thurmaston Parochial Church Council, the legal entity of the Parish Church of St Michael & All Angels, Thurmaston.
