

AGAPE COMMUNITY CHURCH TY SIGN ANNUAL REPORT 2020-2021

We continue to function as a community church seeking to help the local community of Ty Sign. This has been challenging with the Covid 19 restrictions. However, we continue to have a committed regular attendance at our zoom services every Sunday and have provided a range of opportunity online for worship, prayer, Bible study and social interaction. We have welcomed guests from other churches in the UK & India. Our Toddlers group is growing, despite lockdown, with Facebook and contact in the park and the group has just returned to Channel View Centre in person on June 14th. We attract several Mums & Dads, grandparents and childminders and there is a healthy community atmosphere. We have tried to maximise our activities within the changing alert levels in Wales. This has included hosting Prayer meetings for Risca Street Pastors and Metropolitan Mission India and meeting in private gardens. We are a local Debt centre for Christians Against Poverty (CAP) and work with two local Baptist churches in this. We have seen individuals go debt free on a regular basis despite Covid 19 restrictions. We continue to support Shade (Self help group for those with anxiety and depression) Risca Street Pastors has

been on hold as Pubs have been shut. We support Vision of Hope (drug addiction), Wycliffe (Bible translation), and the Metropolitan Mission India (Pastors & health)We are linked in with the New Wine Cymru network and attend the regional leadership meetings and their conference in June all on zoom in the last year. We have good relations with several local church leaders. We continue pastoral visiting and support for people within Covid guidelines. We are raising funds at present towards a new facility for the community on Ty Sign Estate as the Channel View building is in poor condition. Our finances are healthy.
