**REPORT OF THE TRUSTEES
FOR THE YEAR ENDED 31 AUGUST 2020**

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 August 2020. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

The Edmonton Community Partnership (ECP) is a charitable company set up by a group of Headteachers and members of the local community to provide valuable enrichment opportunities, predominantly outside of the curriculum, for young people and their families in Edmonton in order to raise aspirations and improve outcomes for those most in need. The organisation has been set up in this way, as its purposes are charitable and mainly centred on advancing the health, education, safety and wellbeing of families in deprived communities.

ECP provides a service to schools which includes income generation for enrichment activities, project management and network management/administration to facilitate collaborative working.

OBJECTIVES AND ACTIVITIES

Our Vision, Mission and Values

The organisation's overarching purpose is to **"raise aspirations, outcomes and standards for children and their families within deprived communities"**. More specifically the company's objects, as outlined in the Articles of Association, are as follows:

(1) to advance in life and relieve the needs of young people in the United Kingdom by:

- a) providing advice and assistance and organising programmes of physical and other activities that develop their skills, capacities and capabilities to enable them to participate in society as independent, mature and responsible individuals;
- b) providing advice and assistance and organising activities that enhance their health, safety and well-being;
- c) providing information about other organisations which provide activities, services, and facilities and which are established for the relief of need of young people and their parents and carers; and
- d) providing recreational and leisure time activities in the interests of social welfare, designed to improve their conditions of life.

(2) to advance the education of children, young people and their families and carers for the public benefit in the United Kingdom in particular but not exclusively by:

- a) promoting co-operation and collaboration between schools and other educational bodies and the wider community in which the schools operate;
- b) the provision of services, facilities and activities to develop the capacity and skills of parents and carers of children and young people to enable them to engage more with the education of, and to identify and help meet the needs of, the children and young people in their care;
- c) the provision of training to individuals involved in the education and pastoral care of children and young people in order to equip them with the skills required to deliver such education and to support the social and emotional wellbeing of the children and young people in their care.

(3) to promote the efficiency and effectiveness of schools and other educational bodies which have charitable purposes and the effective use of the resources of schools and other educational bodies for the charitable purpose of the advancement of education for the public benefit, by providing services for schools and other educational bodies to promote good practice and enhance and improve their procurement activities; and

(4) to advance any other purpose for the benefit of the public that is charitable according to the laws of England & Wales.

Edmonton is an area in which many people live in deprivation, with new immigrants struggling with social isolation, child poverty rates of 53% (well above the national average of 21%), and issues around youth violence. This means there are many who need extra support to gain access to available opportunities.

OBJECTIVES AND ACTIVITIES

What we provide

Income generation: This includes the expertise of experienced bid writers who submit funding applications for projects that support disadvantaged communities. These are based on the identified needs of the community and have included funding applications towards counselling for children and families, improved play spaces, library books, speech and language therapy, Saturday schools, ESOL and family learning programmes as well as music, sports and art-based projects.

Project management: ECP provides project management from start to finish including set up, procuring/commissioning appropriate service providers to deliver projects (carrying out due diligence), budget monitoring of grants, monitoring and evaluating project outcomes, quality assurance and returns to funders. ECP also arrange inter school/community experiences, festivals, competitions and cluster events to bring the community together and promote social inclusion.

Networks: ECP organises and facilitates partnership working groups according to the needs of its member schools. This includes setting up and funding training courses in response to identified needs, setting agendas, writing minutes, sending invites, organising speakers, providing papers and carrying out follow up actions.

In addition to providing network and training, we also set-up working group parties for particular projects. These networks have allowed different levels of leaders to work together to share best practice, improve provision, set up joint projects and access training and other valuable opportunities. The networks and training opportunities are provided so that children and communities have access to the best services possible.

OBJECTIVES AND ACTIVITIES

Achievements and Performance

The Edmonton Community Partnership has managed a range of projects throughout the academic year 2019/20 .

All projects are in line with our charitable aims.

2019/20 Highlights

During the height of the pandemic through our alliance with 20 schools, we identified 400 of the most vulnerable children and young people (CYP) in our community, especially those who were at risk of dropping out of school or in transition in an effort to create emergency projects that directly addressed their needs; re-profiled one of the elements to support 60 of the most vulnerable young people aged 10 years who were going through a transition stage at school and that were at risk of becoming involved in crime. They needed resocialisation activities with insight into what to expect when moving into Year 7. It was a success with 43 of the CYP having continued support to date via a personal mentor.

Program Achievements/Highlights

Communication is Key (BBC Children in Need speech and language project).

Aim: To support small groups of children with communication needs who are not entitled to statutory support.

Find Your Voice workshops

Outcome: Improved communications, improve peer relationships, increased confidence.

Positive results reported for the children who completed the course. Children reported to make progress in all outcomes. Overall improvement was reported at 87% of participants, improved their overall communication skills.

Bulgarian Voices

Aim: To support referred families with shopping (40) and laptops (10)

Reach: Offered to the above schools initially but had limited scope.

Schools Engaged:

Eldon ,Wilbury , Starks Field , Houndsfield

Galliard (1 laptop only).

Outcome: Families received shopping and loaned laptops. Many of these families also received free meals through council schemes and other charitable groups.

ARTiculate (intergenerational creative project)

Aim: To deepen our community's sense of togetherness through the creation of art pieces on the theme of identity created in intergenerational collaboration.

OBJECTIVES AND ACTIVITIES

Outcomes: Young people explored their identity with and in relation to their elders, increasing awareness of their individual heritage. All participants expressed themselves and their identity in their own way, increasing self-belief through creation.

GANGS - Making the right choices

Aim: An early intervention programme aimed at children and young people aged 10-14 to highlight the dangers of becoming involved in gangs and gang activity and how to identify the risks by improving confidence and knowledge to make the right choices.

Children Reached - 674

ESOL & lifelong Learning Classes

Aim: This project encourages social integration amongst disadvantaged adults, by bringing together people from various ethnic groups, cultures and backgrounds to enhance their opportunities for employment and progression, as well as give them the confidence to succeed and achieve more in life.

Courses are run by Barnet & Southgate College, are offered for free, and include:

- ESOL English to Speakers of Other Languages.
- Keeping up with the children English & Maths.
- Accredited first aid courses including paediatric first aid.
- Sewing classes.
- Hairdressing courses.

On March 23rd we went into a national lockdown due to Covid-19. But that didn't stop ECP. In fact it just reinforced the need for why we exist; Helping our schools to help their pupils and communities with what they need, by always asking two simple questions?

What do you need?

They told us about

- o The Digital Exclusion of your children and families
- o Food Poverty
- o The importance of Resocialising of pupils in the summer
- o Helping children with their physical health, wellbeing and mental health
- o Creating projects to talk about inclusion and diversity due to the Black Lives Matter Movement
- o Help to support EU families to get settlement status
- o Support 'at risk' children and young people with intervention programmes

How can we help?

We helped by listening to our schools and finding the partners or funding to address their needs.

We ran the following projects during the lockdown and over the summer.

Project: Dream, Believe, Succeed (Young Londoners Fund Project)

Aim: An alliance of local partners using performing arts and creation to ensure that children and young people (CYP) in Edmonton are listened to, inspired, enabled to meet their full potential and express the matters that mean the most to them.

Children Reached - 280

Schools Engaged (to date):

St John & St James, Raynham, St Edmunds, Houndsfield, Eldon, Cuckoo Hall, Flecccefield, Oakthorpe, Meridian Angel, Latymer All Saints, Starksfield, Cuckoo Hall, Churchfield, Galliard, Edmonton County Primary & Edmonton County Secondary.

Outcomes: Increased engagement, improved self-esteem, better relationships with peers, improved mental health and wellbeing. Through all of our work as a part of this project we are seeing young people grow in confidence as they are encouraged to create and shown the value of their own ideas. New relationships have been formed in sessions with DJMC, Blingwear and PPA. This is particularly true of DJMC, who have been working in public spaces in the community and bringing different people together for their workshops. Our Youth Mentors have been dedicated to working on confidence and mental health with their caseloads.

ReBoot - Glee

Aim: GLEE is our yearly flagship performing arts enrichment programme run by Pineapple Studios. Summer Play Scheme

Aim: To offer free enrichment activities to children of key workers and the most vulnerable in the context of school closures as a result of government lockdown. Activities included, sports, drama and arts and crafts.

Children Reached - 45 CYP.

Schools Engaged: 9 schools*.

St John & St James, Raynham, St Edmunds, Houndsfield, Eldon, Cuckoo Hall, Fleecefield, Oakthorpe, Meridian Angel.

Outcomes: Increased confidence and self-esteem. Increased engagement. For many young people in attendance this was their first chance at social interaction since school closure 4 months prior. It was therefore a great success to see new friendships being formed and positive experiences taking place inside schools once again.

Flower Pots and Seeds

Aim: A project to engage families during lockdown/key worker children in school

Reach: Eldon school (Eldon school was in the funding area for this project). Over 200 kits were handed out and the school were very proactive.

Outcome: School very proactive and shared pictures of the plants and replanted many in school allotment site.
raised over £72K

During the lockdown we had a fundraising target of £70k. We raised over £72K

Environmental grants to support health and wellbeing of your pupils £2250k

A project during lockdown saw 200 key work children in Eldon school each receive a plant pot kit.

A new project is due to start in 2021 for EYFS children with an experienced practitioner to learn about the natural environment.

Forest School - £4k

Aim: To offer a new experience for EYFS children with experienced practitioner and learn about natural environment. **Reach:** Funding for 3 schools so far. 30 children per school to receive a 2hr session or 60 children per school to receive a 1hr session.

Children in Need Covid-19 Booster Grants £8k

Supported Summer Camps for 200 children and additional Speech and language activities in your school.

The project addressed Food Poverty for 40 Bulgarian families. Digital exclusion was addressed by purchasing 40 laptops to support pupil's inclusive learning.

Hardship fund set up to support families unable to access government schemes.

Supporting Bulgarian/Roma families primarily to apply for settled/pre settled status before April 2021 deadline.

Sports England - £3k

Leader Within Me (starting in November) 10 girls aged 10-15, will develop skills (leadership, communication, teamwork) through football.

FINANCIAL REVIEW

Financial Review

For this period, ECP generated income of £84,600.00 (excl. VAT) from memberships fees charged to schools within the partnership, including CU membership/passports, and fundraising.

This included 15 Primary schools, 3 Secondary schools, 1 pupil referral unit and 1 special school.

The charity provides a service to schools to support children and families in disadvantaged communities. The fees paid by schools to access this service covers the total operating costs, including salaries and additional reserves for the charity. This ensures sustainability and continuous service to the community we serve as the operating costs are not reliant on grant income.

Specific projects and initiatives are funded through grants, donations and fundraising activities.

This is part of our income generation strategy that the board is continuously committed to review.

FINANCIAL REVIEW

Reserves policy

The trustees consider it appropriate to build up and maintain a reserves budget to cover the partnership in the event of a shortfall of SLA fees for long term viability. This could also be used to fund temporary grant shortfalls and possible costs associated with staffing including redundancy, pension commitments (including withdrawal liability of the scheme) and long-term sickness. The trustees are of the opinion that £47,000.00 would be sufficient to cover potential liabilities in the short term (where there are no redundancy costs). The Charity aims to build reserves in the long-term.

Going concern

The Trustees have reviewed our financial position, taking into account the level of cash reserves, and the systems of financial control and risk management. As a result of this review, the trustees believe that we are well placed to manage operational and financial risks successfully. Accordingly, the trustees have a reasonable expectation that the Charity have adequate resources to continue in operational existence for the foreseeable future. Therefore, they continue to support the going concern basis of accounting in preparing the annual accounts.

Risk Review

The major risks (Covid-19 and reliance on historic funders) to which the charity is exposed have been reviewed and systems are being established to mitigate those risks; funding risk is being addressed through building new partnerships and diversifying sources of funding.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The organisation is registered as a charitable company limited by guarantee is controlled by its governing document, Memorandum and Articles Incorporated and constitutes a Limited Company, Limited by Guarantee, as defined by the Companies Act 2006.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Recruitment and appointment of new trustees

The directors of the company are also charity trustees for the purposes of charity law and under the company's articles of Association are known as members of the charity. The board meets throughout year and considers such matters as the appointment of trustees, the approval of Annual Reports and Accounts and the appointment of the independent examiner. The quorum necessary for the transaction of business of the trustees is a minimum of two or the number nearest to one third of the total number of members entitled to vote, whichever is larger at the AGM and two at other times. We currently have 4 Trustees and all members give their time voluntarily and receive no benefits from the charity.

They procedure when appointing a trustee is as follows

- The Charity identifies the need for a new trustee either because of a resignation or they have identified a skill that they need to bring in.
- The Trustees agree what skills, experience and knowledge is needed and write it down in the form of a short job description and person specification.
- The trustees then agree responsibilities and a process for recruitment taking care to comply with any specific requirements set out in the charity's governing document.
- Checks are carried out on candidates:
 - 1) They have not been disqualified from acting as a trustee and they are asked to confirm this in writing.
 - 2) If there are any potential conflicts of interest
 - 3) Appropriate checks from the Disclosure Barring Service
- The new trustee is given a letter setting out their duties and expectations of them which is signed and returned.
- Their details are updated with the Charities commission and companies house
- An information pack about the charity is given to them and they are introduced to the other trustees
- The New trustee attends their first board meeting and is duly welcomed. All relevant parties are notified of the new appointment.

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

Expenditure
