Trustees' Report

The Bristol Medico-Chirurgical Society CIO was registered with the Charity Commission on 29 January 2019 with three founder Trustees. It was set up at the wish of the members and Trustees of the previous unincorporated charity of the Bristol Medico-Chirurgical Society which voted in 2018 to have this successor charity formed and to eventually transfer its assets to the new incorporated charity once the new charity had taken over the operations carried out by the society.

The trustees meet at least 4 times a year and once a year at the start of the meeting calendar hold an open meeting for associate members.

The society itself was originally founded in 1874 to advance medical knowledge and for many years has worked principally by organising a programme of meetings running from the Autumn to early summer which are free and open to health clinicians but also open to the Public.

It also operates a website to publicise meetings and signpost any recording of meetings that can be viewed. It made no grants other than those related to operating the charity, its meetings and website.

We have the support of a part time administrator, Ms Samantha Walker, whose employment we intend to formally transfer from the old charity to the CIO.

President's Report for 2019-20

This has been one of the society's more 'interesting' years. It is the first session with the Med Chi in the CIO format, though technically we are running the two Med Chi's in parallel with the same officers to maintain the old bank account whilst the membership subscriptions are being sorted.

I was delighted to have some senior national speakers. I was unfortunately unable to attend the Long Fox Lecture in November as I was in Thailand and Myanmar where I met a lot of Chinese tourists and returned with a bad cough. However the meeting went well!

We then had one of our first meetings for a long time at the BRI medical education centre – which went very well and ran out of space.

Prof Lewandowsky's entertaining and interesting talk on conspiracy theory which concentrated on Trump's claims but also on the vaccination conspiracy theorists seemed prophetic.

But then COVID 19 struck! First it was that that Prof Goddard the president of the RCP had to cancel as he had urgent meetings in London; I was grateful for Dr Jarad for talking to us at short notice on the dangers of Vaping. Then it was that Wendy Burns president of the RCPsych had to cancel as that day she went into self isolation having been at a government evening meeting where a minister then tested positive. EEF charged us for cancellation and I am grateful to the donations we received to help with these costs.

And now it has been isolation and lock down!! A bizarre and testing experience for us all including those who worked for the NHS during this time.

We ended by trying webinars – first a formal one arranged in July with the RCP with Prof Goddard talking on his planned theme from February, and then one arranged at short notice with Dr Mazen Kherallah, a Critical Care and Infectious Disease Consultant at Sanford Health System in Fargo, USA who has had extensive experience of caring for patients with COVID. He was able to talk to us from North Dakota live by Zoom – it just meant he had to get up at 6am – we are grateful for his willingness to do this. I feel his talk was well worth hearing.

These online talks are recorded and are now available to watch online, a first for the society.

For all the highs and lows I have enjoyed being President but I now am returning to be treasurer for both versions of the society and handing over the medallion to Prof Cahill who has assembled an interesting programme. We hope to have some meetings at Engineers House with video streaming and some as webinars.
