Structure and Governance

The Charity was registered as a Charitable Incorporated Organisation on 17 December 2018, having been reconstituted from the previously unincorporated Charity number 209145. The Charity changed its name from the Egypt Diocesan Association (EDA) to Friends of the Anglican Province of Alexandria (FAPA) in June 2020.

The Charity is governed by a constitution which places no maximum on the number of charity trustees that may be appointed; membership is open to anyone who is interested in furthering the purposes of the Charity.

Report of the Trustees

The Trustees present their annual report and financial statements of the charity for the year ended 31 December 2020.

Objects and Activities

The object of the Charity, as defined in the constitution, is to benefit the public by encouraging support with financial grants, prayer and personal service in order to advance the Christian faith in the Episcopal/Anglican Province of Alexandria - to provide and maintain its church buildings and to enable public worship, pastoral care, outreach and witness, training and education, healthcare, the relief of poverty and community development.

The request by the Bishop and Synod of the Diocese of Egypt to transform the Diocese of Egypt with North Africa & the Horn of Africa into a new Province was approved by the Anglican Consultative Council in May 2020. The newly formed Province - the Province of Alexandria - contains four dioceses: Egypt, North Africa, the Horn of Africa, and Gambella which will be established over a five-year transition period. The Friends of the Alexandria Province of Alexandria (FAPA) is called to support the work of the clergy, churches and ministries in Algeria, Djibouti, Egypt, Eritrea, Ethiopia, Libya, Somalia, and Tunisia.

At the 'virtual' Annual General Meeting which took place on 27 June, members agreed to support all four dioceses and change the charity's name to 'Friends of the Anglican Province of Alexandria' (FAPA), and the necessary changes to the Constitution were approved. It was confirmed that Archbishop Sentamu has retired, and that Bishop Mouneer will replace him as Patron on his retirement as Bishop of the Diocese of Egypt. The Rt. Revd Dr Michael Ipgrave OBE, Bishop of Lichfield has graciously accepted an invitation to be Co–Patron bringing to us his experience especially in interfaith relationships and providing FAPA with representation in the House of Bishops of the Church of England.

Prior to the AGM, participants were graced with the presence by Zoom of Archbishop Mouneer and Bishop Samy. Both shared accounts of wonderful growth in the various constituent parts of the Province and some of the many challenges being faced at the moment — especially the the need for recognition by the Egyptian Government of Bishop Samy's election as Co-adjutor Bishop and the formation of the Episcopal/Anglican Province of Alexandria.

Bishop Bill affirmed that FAPA trustees willingly intend to join discussions with JMECA and FACE (Friends of the Anglican Church in Ethiopia) to make the best contribution overall in support of the Province and emerging Dioceses.

The administrative actions required to be undertaken with the change of name have been completed and FAPA 'relaunched' with a new website www.fapa-egypt.org. A drive to recruit new members and partner churches has been initiated – this includes advertising FAPA amongst expatriates currently living/working within the Province via churches and diplomatic missions. Three newsletters were produced in 2020.

The website has been designed to assist us all in growing our prayer support, and it is hoped that members will visit it regularly for items to pray for.

The Future

Trustees have 'dusted off' our Mission Statement and started to give thought to strategic activities for when the Covid restrictions are eased.

Our Mission is to help the Province realise its goals through prayer and financial support, and by sending people out to support, learn from, and encourage the dioceses.

Activities

- Promote awareness of the Province's ministry and seek support for its churches and institutions.
- Link members and churches in the UK with institutions in the Province
- Equip and inspire members to pray for the Province by disseminating regular newsletters and prayer requests on our website: www.fapa-egypt.org
- Relay appeals for financial support, and help channel donations from individual members and churches to ministries and institutions in the Province.
- Organise Study Tours / Pilgrimages to the Province.
- Liaise with theological colleges training ordinands for ministry.
- Promote experience exchange schemes for young people on gap years / student vacations and for ministers on sabbatical.
- Support "cross-cultural placements" in the Province of potential British / Englishspeaking ministers for English-speaking congregations.

Financial Review

The Charity received Unrestricted income of £7,875 from individuals, and £15,808 from individuals and six partner churches as Restricted donations.

The Charity is immensely thankful to all individual donors and partner church donors for their generous donations as this has enabled FAPA to make significant grants to support the activities of the Province of Alexandria. The Trustees are particularly grateful to Vanessa Land for building the FAPA website at no cost, thus saving several thousand pounds.

The charity remitted £18,808 for specific activities of the Diocese of Egypt which comprised income donated for specific purposes of £16,308 and £2,500 from general donations to support Lay leadership training. £4,900 was remitted to be used at the discretion of the Archbishop.

The most significant risk is sustainability of donations.

Reserves

The Trustees consider that approximately £2,500 should be retained to meet future needs of the charity. At 31 December 2020 the level of unrestricted reserves was £2,537.
