The Parish of Bro Cyfeiliog a Mawddwy (registered charity 1185839) is a Ministry Area of the Church in Wales situated in the Archdeaconry of Meirionydd within the Diocese of Bangor. The geographical area of Bro Cyfeiliog a Mawddwy in the North at Mallwyd and ends in the South at Machynlleth and eastwards at Llanbrynmair. Contained within Bro Cyfeiliog a Mawddwy are the communities and Churches of Dinas Mawddwy, Comins Coch, Glantwymyn, Penegoes, Corris (Holy Trinity), Llanwrin (St USt and Dyfrig), Llanbrynmair (St Mary), Machynlleth (St Peter), Darowen (St Tudur), Cemaes (St Tydecho), Mallwyd (St Tydecho).

STRUCTURE, GOVERNANCE AND MANAGEMENT

The Church in Wales is governed by its Constitution, set up under section 13(1) of the Welsh Church Acts 1914, as amended from time to time by its Governing Body. Due to organisational changes currently underway within the Church in Wales the MAC has the same powers as a Parochial Church Council (PCC) with the main difference being the size and coverage of a MAC being much larger than a traditional PCC. The MAC is not a body corporate. Its composition, procedures and powers are regulated by the Constitution, which provides that before assuming office, every member must sign a declaration that he or she will be bound by the Constitution. The Constitution also provides that the members of the MAC shall be: The Incumbent, Vicars and Assistant Curates; two Church Wardens, one appointed by the Incumbent and one elected at the Annual Vestry Meeting (AVM); up to 25 lay members elected at the AVM, 1 co-opted Secretary and Treasurer (if not already ex-officio or elected); and up to 7 further co-opted members. The elected MAC members are elected at the Annual Vestry Meeting by the members of the congregation who are on the electoral roll of the Parish. All persons over the age of 18 who attend services and are members of the congregation are encouraged to register on the electoral roll and seek election to the MAC.

OBJECTIVES AND ACTIVITIES

The Church in Wales is a Province within the Anglican Communion and seeks to advance the Christian religion through world-wide mission. The Ministry Area Council's (MAC) objectives are to ensure that Church life and work within the Parish of Bro Cyfeiliog a Mawddwy help to fulfil that mission, both locally and more widely.

The MAC is aware of the Charity Commission's guidance on public benefit in "The Advancement of Religion for the Public Benefit" and have regard to it in their administration of the Parish of Bro Cyfeiliog a Mawddwy. The MAC believes that, by fulfilling its responsibility to work together with the incumbent in the Parish and co-operate in all matters of concern and importance for the promotion of the whole mission of the Church, pastoral, evangelistic, social and ecumenical, it provides a benefit to the public by:

* providing resources and facilities for public worship, pastoral care and spiritual, moral and intellectual development, both for its members and for anyone who wishes to benefit from what the Church offers;

* promoting Christian values, and service by members of the Churches in the Parish of Bro Cyfeiliog a Mawddwy to their communities, to the benefit of individuals and society as a whole.

The MAC is responsible, inter alia, for the parochial budget and all expenditure thereunder, the care and maintenance of Church fabric and of the Churchyards it owns, and for any action or other matter referred to it in accordance with the Constitution, and is the normal channel of communication between parishioners and the Diocesan Bishop."

Bro Cyfeiliog a Mawddwy annual report 2020

Before the Covid-19 pandemic hit, our church services and activities got off to the usual start including two popular Plygain services in Darowen and Mallwyd, and 'Cawl a Chlonc' fellowship tea to celebrate St David's day.

From March onwards, our worship and outreach had to be adapted to continue without the use of our church buildings, as the government restrictions came in. Our worship services became pre-recorded videos, uploaded to our ministry area Facebook page, where they could be accessed by the public. This proved very popular with people able to watch the service and participate in worship from their homes, and also enabled us to connect with many more people in our communities who previously didn't attend services in churches. Some school assemblies were also delivered by video. For those who accepted the offer of worship materials by post, cards and sermons and prayers were delivered weekly, so that those unable to use the internet for worship could still receive the same sermon message.

Our pastoral care team were unable to visit in person, but kept in touch with people by phone and post. During the times of the year when restrictions were eased, some pastoral visiting took place at people's gates or doorsteps, at a safe distance, or through the hospital window. Some churches were opened for private prayer or for gathered worship within the government guidelines, and an outdoor service in Corris churchyard proved very popular.

Arranging and conducting funerals and bereavement ministry was made more difficult during lockdown, but continued, often with services being held at the graveside or with limited numbers at the crematorium or church.

At Christmastime, unable to host any social gatherings, a stocking of treats and prayers was delivered to the doorstep of each person on our pastoral care list, and individual Christmas cakes were given to each household on the Bryn-y-gôg estate by our pioneering team.

A promise auction held in the summer invited people to pledge donations for items or experiences offered for free by church members or friends, and with engagement from a number of local small businesses, this raised nearly £1500 whilst making new links in the community. We were pleased with the outcome of this new venture, as it replaced any social gatherings were fundraising would usually have taken place.

The year was difficult for everyone, but we learned how to adapt to ever-changing restrictions, how to keep in touch with people from a distance, and how to engage with our wider community through digital means. These are very positive things we endeavour to take forward into the future.

None of us good have imagined how 2020 would have been! With all these challenges we have encouraged people to give via gift direct to help churches have a regular income stream as even if churches didn't open there are still expenses to pay ie Insurance etc. We also going forward need to look at streamlining the number of accounts churches have, to make work easier for the people who have to put into the Finance system we now use.

Fund raising in the Ministry Area.

The 200 club sales again made a good profit which helps reduce the expenses contribution from each church to the Ministry Area Fund.

We also had an 'Auction of Promises' which raised monies to help run the Ministry Area. Our Harvest collections were for the Representative Body of the Church in Wales 'Centenery Appeal'.

A couple of our churches were able to fundraise when Covid 19 restrictions were eased for a short time in late summer/early Autumn.

To conclude:

As with most other organisations within the locality, the lockdowns have been very hard on our income streams, but we must also be grateful to Bangor Diocese and the Representative Body of the Church in Wales for providing a discount on our Bishop's Ministry Fund cost for 2020. We had to use £7,541 from the Ministry Area Central account this year to make up the final shortfalls.

We became a charity in late Autumn 2019, so for all the Trustees and officials there are new ways of operating to get used to. We need to look at our group of 7 churches as a whole and work together for the benefit of those we serve and support. It should be noted that the MAC Trustees are very grateful for the continued financial and volunteer support it receives to the churches from both very generous members, supporter's, and visitors (when allowed).

Idependent Examiner's Report

I report to the trustees on my examination of the accounts of the Bro Cyfeiliog a Mawddwy Ministry Area charity for the year ended 31st December 2020.

Respective responsibilities of Trustees and Examiner

The Ministry Area Council members of the Parish of Bro Cyfeiliog a Mawddwy (henceforth referred to as the MAC) as trustees are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ("the Act").
