CHAIR'S STATEMENT

YEAR ENDED 31ST DECEMBER 2020

Following a comprehensive business review with key stakeholders, 'The Drinks Trust' was announced as The Benevolent's new name on 12th March 2020, with a vision to modernise the charity to fit with the current needs and culture of the modern drinks and hospitality industries.

The planned key goals to deliver on its strategy were as follows:

- Increase the volume of beneficiaries receiving hardship support
- Provide comprehensive wellbeing support services
- Diversify and increase revenue across donations, external fundraising and in-kind partnerships
- · Decrease reliance on the charity's investment income
- Develop and build an industry community service offering wellbeing and vocational support
- Launch new and contemporary events better suited to the modern drinks hospitality industry
- Professionalise the operation by introducing new internal systems across data management, beneficiary assessment, fundraising and marketing

COVID19 and Government restrictions on the drinks and hospitality industries came within days of the launch of the new identity. The pandemic's impact highlighted the importance of changing the services and ethos of the organisation, as the demand for support from colleagues in our industry increased tenfold in the weeks following the first lockdown.

Thanks to the generosity and actions of the businesses and fundraisers who supported the charity at a time of great need, The Drinks Trust was able to support more of the industry workforce than at any time in its history.

The following is a review of how the charity performed given these unprecedented and unforeseen circumstances.

Charitable Revenues

The Drinks Trust earned total income of £2,401,044 which represented an increase of £1,452,037 over equivalent 2019 revenues (£949,007).

This significant increase was achieved through higher corporate donations, Business Partnerships and One-Off Donations. Many donated funds specifically to assist those impacted by COVID19 and for the charity's wellbeing services. Internal fundraising activities, especially events, fell substantially due to COVID19 restrictions. Despite the shortfall in event revenues, the uplift in donor revenues allowed the charity to exceed planned revenue of £868,850.

One of the charity's goals was to reduce reliance on investment fund withdrawals to support operational costs. The charity withdrew £345,000 in 2019 and budgeted to reduce withdrawals to £240,000 in 2020. The pandemic negatively impacted investment returns, so the decision was made to not draw from the fund after March 2020, and a total of £100,000 was drawn in 2020 as a result.

Beneficiary Services - Hardship Relief

The Drinks Trust was successful in achieving its goal to grow the number of beneficiaries the charity helps. In 2020, the charity had supported 4,583 individuals, of these, 999 beneficiaries were supported with periodic financial assistance grants and various Acts of Kindness, an increase of 223 over the 2019 equivalent of 776. Acts of Kindness were shown to beneficiaries by way of one-off grants, TV license payments, Christmas grants and 'goods' such as white goods. This represented an improvement of almost 30% over the number of beneficiaries in 2019.

In addition to the beneficiaries noted above, the charity sought to support those facing hardship related to COVID19's impact on hospitality. In May of 2020, The Drinks Trust launched the first of five emergency grant reliefs, with recipients receiving a one-off £250 grant. This first round was followed by the Festival Bar Staff Emergency Grant, the Brewery Staff Emergency Grant, the Nightclub Bar Staff Emergency Grant and finally the End of Furlough Emergency Grant round.

At the completion of 2020, The Drinks Trust had awarded a total of 2,598 various COVID19 grants to individuals across the UK, as well as a single grant of £22,982 to The BEN, the Scottish Licensed Trade charity, to disseminate in Scotland to individuals qualifying based on the grants already provided through The Drinks Trust. The total value of all COVID19 grants given at year end was £635,632.

Beneficiary Services - Wellbeing Services

The Drinks Trust announced three new and expanded services to deliver more wellbeing support to the industry workforce complementing its existing helpline.

In June 2020, the first of these services, Sleep & Insomnia treatment, from the UK's leading provider, Sleepstation, was launched. The charity had 131 registrations for assessment with 13 going on to complete the full treatment course. The Drinks Trust is now looking to further promote this offering in 2021 with an ambition to increase uptake on licenses purchased and will reassess the service at the end of the year.

In May of 2020 The Drinks Trust announced its Mindful Drinking for The Hospitality Industry service, provided by Club Soda, the leading UK provider of training and education around the management of alcohol consumption. The service has proved popular and uptake for period June to December 2020 was 111 licenses. The Drinks Trust will continue to deliver the service through 2021 and make a full assessment of the outcomes and continuation of the offering at year end 2021.

In May of 2020, The Drinks Trust also launched its Therapy Services, supplied through the Dr Julian web services. The offering comprised of video, telephone, and text therapy services with degree-qualified therapists. Recipients of the service being entitled to three complimentary sessions, increasing by a further three to six where required. In 2020, 40 people enrolled in the service.

In November 2020 The Drinks Trust announced the new helpline service, which offers 24 hours in-the-moment counselling, and several new ways of reaching out including WhatsApp and email. This is an enhanced offering to beneficiaries, both in the availability of counsellors (previously 12 hours a day) and the media which can be used to contact them. The service also offers bespoke guidance on concerns that beneficiaries may have, including debt advice, mediation support and a Managers Advice line.

The increased and improved services now offered by The Drinks Trust across wellbeing have seen successful uptake from beneficiaries, with 986 individuals having received one or more of the services set out above. The charity met its target and will continue to improve these services based on recipient feedback.

In 2020 The Drinks Trust's expenditure on charitable activities was £1,712,832 (83% of total expenditure). Across all hardship and wellbeing services, The Drinks Trust was able to assist 4,583 individuals in 2020, an increase of 2,979 over the 2019 equivalent of 1,604. The combined total direct expenditure on beneficiary services was £1,206,495, rising by £684,889 from the 2019 equivalent expenditure of £521,606. Additionally, this expenditure was £659,756 above budgeted expenditure of £546,739 set for the year 2020. This achievement was made possible thanks to the significant generosity of donors, both businesses and individuals alike.

The Drinks Community

In November 2020, The Drinks Trust began work on its new service the Drinks Community (DC). DC is a dedicated networking portal for everyone working in the drinks industry, from the point of production to the point of sale. The platform provides a space for industry professionals to learn about vocational and wellbeing development and is dedicated to helping the workforce progress in their careers.

Resources on DC are produced by leading industry professionals and provide the learnings they have taken from the successes and challenges in their own careers. It also drives members to produce their own insights and share them with the community, encouraging peer to peer learning and support.

Additionally, DC runs a mentoring program and following its launch in early 2021, it now has 30 mentors and mentees completing the first round of the program. DC will launch another round of mentoring later in 2021.

To date, over 1,000 members have joined TDC and are benefiting from the experience and skills being shared by their colleagues, particularly at a time when many of our colleagues in the drinks and hospitality industry require professional support to re-enter the job market and thrive in the years ahead.

Events & Internal Initiatives

The 2020 strategy called for new and contemporary industry events. COVID19 made most fundraising events impossible, and all events were cancelled throughout the year from mid-March. The Drinks Trust are cautiously optimistic fundraising events will be possible in 2022 and plan to deliver on this goal.

The annual ball event did take place in 2020 and sold out tickets which raised £30,786.38 (vs £43,476 in 2019)

Capability Management

The 2020 strategy committed The Drinks Trust to update its procedures and systems to substantially improve productivity and efficacy. In September 2020, the charity moved its accounting system to Xero and contracted an outsourced accountancy firm specialising in the not-for-profit sector.

In December 2020, the charity implemented a new not-for-profit CRM system that it linked to its accounting system. The new CRM allows for significantly improved management of records, data capability, fundraising tools, and beneficiary management tools. These two systems together have allowed the charity to advance its capability significantly.

Additionally, the charity has produced updated and improved policies across welfare eligibility and processing, GDPR and general operating procedures. All policies have been successfully introduced and allow the charity to operate more effectively and transparently for many years to come.

Summary

2020 proved to be one of the most challenging times in industry history with an unprecedented need for support for those impacted by Government restrictions due to COVID19. The Drinks Trust responded admirably to these challenges, evolved its services and delivered support unparalleled in its history. The COVID19 pandemic came at a time when the charity looked to make significant changes, allowing it to adapt to the changing needs of the workforce. The goals and ambitions set out in early March 2020 were ambitious enough in themselves, but as the pandemic began to take its toll on the industry, the demand on the charity rapidly increased, creating a challenge to deliver on both its vision and the exponential growth in demand.

It has been, we hope, a challenge that we never have to experience again as an industry, and it is also one that The Drinks Trust was able to rise to, firmly re-establishing itself as a pillar of the industry and a lifeline to many thousands of individuals who without it, may have faced significant uncertainty.

It is impossible to provide enough gratitude to the support that The Drinks Trust received from donors and volunteers in 2020. Many businesses and individuals gave this charity the funds, means and time that allowed it to provide support that its beneficiaries desperately needed. They are all named in the subsequent pages, and whilst some donors gave hundreds of thousands in donations, others gave hundreds despite facing significant financial challenges. STRUCTURE, GOVERNANCE AND MANAGEMENT

The principal structure and reporting lines for the charity are shown below:

Trustees are or have been senior executives employed in the Drinks Industry or have been appointed for their expertise. Any new appointees are fully briefed on the aims and objectives of The Drinks Trust (formerly The Benevolent) and receive information and training if required as to their responsibilities as a Trustee. The Board determines the general policy of The Drinks Trust (formerly The Benevolent). The day to day management of the charity is delegated to the Chief Executive. The Board currently comprises 12 members including the Chair and meets four times per year.

The key management of the charity comprise the Chief Executive, the Operations Manager, the Welfare Manager and the Marketing and Communications Manager and the Events Manager. Remuneration for all staff is set by the Trustees when considering and agreeing the annual budget. Consideration is taken of published benchmarking salary surveys such for the sector.

Internal Control

The systems of internal control are designed to provide reasonable, but not absolute, assurance against material misstatement or loss. They include:

- A review of the remuneration of all staff during the budget review process by all Trustees
- Regular consideration by the Board of financial results, variance from budgets, non-financial performance indicators and reviews.
- Delegation of authority, including welfare payments, and segregation of duties
- Identification and management of risks

ORIGIN, OBJECTIVES AND PRINCIPLE AIMS OF CHARITY

The objectives of the Charity, which was formed in 1886, as defined in the Memorandum of Association, are to assist members of the Alcohol Drinks Trades and all ancillary trades, organisations and institutions in the United Kingdom, who are in need in particular:

- By granting regular monthly payments to alleviate financial hardship
- By making one-off grants or payments to help address suffering or crises
- By providing emotional or practical assistance for issues of wellbeing or hardship
- . By providing support to the residents of the homes that the charity used to own and run

Practical, emotional and financial assistance is given to anyone in the drinks trade who is currently employed, or has been employed, and have derived their income principally from the alcoholic drinks business and who meet the criteria for eligibility.

The Trustees confirm that they have complied with the duty in section 17 of the Charities Act 2011 to have due regard to the public benefit guidance published by the Charity Commission in determining the activities undertaken by the Charity.

OBJECTIVES & ACTIVITIES

The Drinks Trust (formerly The Benevolent), acting upon its benevolent origins, continues to meet its objectives by way of support in the form of regular charitable donations and one-off grants and providing additional emotional and practical support to beneficiaries.

The objectives of The Drinks Trust (formerly The Benevolent) are as follows:

Financial

The Charity aims to have a balanced budget at the same time as increasing its welfare grants in line with budget. All areas of cost will be examined and kept within budget, providing the standards of care and support are not jeopardised. Quarterly management reports will be subject to close consideration by the Chief Executive and the Trustees.

Welfare

The objective of The Drinks Trust (formerly The Benevolent) is to increase the number of beneficiaries by actively seeking to find those in need who are eligible for support. This is achieved by a sustained awareness-raising campaign conducted within the UK drinks industry. The planned budget for welfare grants should be considered as the minimum amount to be given by The Drinks Trust (formerly The Benevolent) and the budget will not be considered a restraint on welfare, providing The Drinks Trust (formerly The Benevolent) is able to afford to increase the level of welfare from its reserves, if not from current income.

In pursuing its objectives the charity's activities fall into three main areas:

- 1. Direct Charitable activities: these consist of the following:
 - a) One off grants or periodic financial assistance.
 - Wellbeing provision by way of emotional, practical, and counselling services and an emergency helpline
- 2. Fundraising
- 3. Governance Activities

Progress in these areas for 2020 is reported below with relevant financial information in the Financial Statement pages.

DIRECT CHARITABLE ACTIVITIES

In total the charity provided financial support to over 3,597 beneficiaries in 2020. The cases of financial support are added to by way of emotional support, practical help, counselling services, sleep and insomnia treatment, mindful drinking courses and the helpline. The number of beneficiaries helped across all services has therefore grown to 4,583 and cases of support grown rapidly in the previous 12 months due to COVID19 demand and the the scope of support offered increasing.

Within the total financial support offered, at the completion of 2020, The Drinks Trust had awarded a total of 2,598 various COVID19 grants.

Regular charitable welfare grants to beneficiaries living in their own homes

The total number of monthly grants given during the year was 360 assuming a regular grant paid on a monthly basis as one grant. The standard level of grant was £78 per month but in some special circumstances a higher grant was given.

All new beneficiaries are contacted by the local Welfare Team before a grant is made. This ensures eligibility for the charity as well as checking income and expenditure and the need for financial assistance. Contact and in-house reviews are made on a regular basis to ensure continued help is required.

DIRECT CHARITABLE ACTIVITIES (continued)

One-off welfare grants for the purchase of goods or the provision of support

During the year 268 one-off grants were approved representing a total expenditure of £110,860.58. A proportion of this amount was spent on mobility aids or house adaptions required because of serious illness, disability or old age. There remained the regular requests for household appliances, furniture and home repairs. Requests for help with funeral costs still existed but emergency grants to help with financial crisis were significantly higher.

Enquiries for the above come via trade referrals, word of mouth, The Drinks Trust (formerly The Benevolent) website and others come through organisations such as SSAFA, Royal British Legion, Citizens Advice Bureau, and many other local agencies and charities. In some cases where larger amounts of help have been required this charity has worked with other charities, in particular, the Wine Trade Sports Club Foundation, the LTC and Hospitality Action, to provide what is required. The Drinks Trust (formerly The Benevolent) is able to respond quickly and to take account of the specific type of help, which is considered most appropriate using The Drinks Trust's (formerly The Benevolent) Welfare Guidelines.

The provision of practical and emotional support to those in need

In 2020 The Drinks Trust increased the array of wellbeing services provided to support current and past employees of the drinks and hospitality industry who are in need of practical and emotional support. These new services included the delivery of an updated helpline service from Spectrum, which provides 24 hour a day in the moment emotional and practical support, a new counselling service from the online provider Dr Julian, offering therapy sessions, a mindful drinking course from Club Soda and a sleep and insomnia treatment program from Sleepstation.

Financial and well-being support to residents

We continue to support the provision of life-line arrangements in some of the bungalows in Eastbourne as well as continuing with welfare grants and other on-going support to all our ex-residents.

Additional Christmas Gift Television licences

In 2020 a total of 359 people benefitted from an additional charitable Christmas donation of £78 each, aside from some exceptional circumstances where a larger grant was approved. Television Licenses were purchased on behalf of 68 beneficiaries.

Visits from Welfare Officers

Following the outbreak of the COVID19 pandemic, home visits were no longer possible, and The Drinks Trust will look to develop a new service for home visits later in 2021.

FUNDRAISING

Fundraising refers to all revenue generating activities. No income is received from Government or State funds. Almost all fundraising and voluntary income is generated through the drinks industry.

The charity undertakes fundraising activity, in line with the Fundraising Code of Practice set by Fundraising Regulator, to its supporters via direct mail, telephone, fundraising events, sponsored events, gala dinners and is in line with our Email Marketing, Fundraising Donations and Legacy Pledges, which appears on our website to reassure supporters of our approach. We have robust policies in place regarding vulnerable people and treating donors fairly. We have received no complaints during the year regarding our fundraising activity (2019: Nil).

We continue to receive very important funds through Corporate and Individual Donations. Details of those supporters are shown on pages 4 to 8. These donations increased significantly in 2020, with corporate membership and donation revenue increasing by £842,093 to £1,176,718. Additionally, The Drinks Trust received corporate donations in support of COVID19 related cases of £639,632 and donations in support of wellbeing services of £85,582. Individual Donations increased by £11,302 to £47,798.

FUNDRAISING (continued)

Key Fundraising Events

As a result of the COVID19 pandemic only one event was able to take place in 2020, The Benevolent Ball. The event raised a total of £37,786.

The Vintners' Wine Trade Lunch is hosted and fully funded by the Vintners' Company with all proceeds coming to The Drinks Trust (formerly The Benevolent). The regional associations of the WSTA also continued to support The Drinks Trust.

GOVERNANCE ACTIVITIES

Membership of the Board is reviewed by the Nominations Committee to ensure continuity and an appropriate level of expertise. Board membership and succession plans for future Chairmen and Trustees are also regularly reviewed.

ACHIEVEMENTS AND PERFORMANCE

The Drinks Trust was able to successfully increase membership and corporate revenues significantly in 2020, and this despite the decrease in internal fundraising revenues from events, which were not able to take place. Additionally, The Drinks Trust was able to significantly increase the number of beneficiaries it was able to help.

FINANCIAL REVIEW

A surplus of £436,110 on unrestricted funds was reported at year end. This was partly attributed to the gains in the capital value of the investment portfolio of £113,620 and the charity's actual unrestricted net operating surplus before gains was £322,490. Investments performed in line with expectations during the year. Large falls in the value of investments were noted early in the year end due to the effects of the COVID19 Pandemic but these recovered before the year end. Income increased significantly from £949,007 in 2019 to £2,401,044 in 2020 as a result of a significant uplift in corporate donations in 2020. Expenditure increased from £1,257,426 in 2019 to £2,054,989 due to the increased level of grants provided mainly related to COVID19. The charity delivered a surplus of £346,055 before gains, whilst simultaneously reducing its overdependence on investment drawdowns of previous years. The charity recognises that such corporate donations will likely decrease in 2021 and the surplus delivered in 2020 will be allocated to delivering its charitable activities in 2021 to assist in managing the continued demand from beneficiaries. Investment income in 2020 was £74,257 and we would expect a similar amount in 2021.

Principal Risks

The Board have assessed the major risks to which the charity is exposed, and they are:

Loss of Revenue; a decision by UK drinks companies to terminate or significantly lower their annual corporate partnership donations. To mitigate this, new services have been introduced, in part to widen the breadth of business who would look to make corporate donations to it. These will be assessed across 2020 and 2021 to establish impact.

Data capture and use; the charity lacks information and data to assess outcomes of initiatives, both fundraising and giving. New systems are to be introduced to automate data gathering and carefully measure outcomes, by the end 2021 the charity will have clearer visibility of both fundraising and grant giving details.

Clarity of objectives; in order to deliver clear objectives, priorities or plans, a full strategy review was undertaken in 2019, and key priorities clearly established. New services are being introduced across 2020 and 2021 and assessments of take up undertaken at the end of each year to establish what impact new services have had on beneficiaries and on fundraising.

COVID19: There remains continued uncertainty in the UK drinks sector as to the immediate and long-term effect of COVID19. The charity has ceased all drawdowns from its investments and despite the depreciation of the fund the charity has a very strong balance sheet with large investment and cash balances. Significant sums have been donated in the year to June 2020 and careful assessment of grants is being made in order to deliver maximum and affordable impact.

TRUSTEES' REPORT (continued)

Reserves Policy

The Charity's principal activity is the provision of welfare support for people connected with the drinks and ancillary trades and the provision of monthly and one-off charitable grants to those in need. The income generated from investments is a vital continuing source of income, and also provides some longer-term security in the most extreme case that fundraising may cease or be dramatically reduced. The investment portfolio is treated as part of the general fund, and in an extreme situation of no fundraising being possible, these reserves would be used to allow the charity to continue its obligations to its beneficiaries until such fundraising is resumed.

Given the positive momentum of awareness and help to the charity, existing and new drinks companies in the UK agreeing to support the charity with annual donations and the high regard in which the charity is held, the risks of the charity experiencing significantly reduced income from fundraising in the near future, as stated above, is regarded as low.

At 31st December 2020 unrestricted funds amounted to £5,767,458 of which £5,301,891 is represented by the investment portfolio and £3,185 by tangible fixed assets. As the investment assets are held to provide a regular income for the Charity, the trustees consider that the Charity's free reserves are therefore £462,382. The charity currently receives a significant contribution to its working capital from the investment portfolio. Given the losses incurred with the investment portfolio in 2018 and again in early 2020 and as a result of COVID19, the Trustees have ceased withdrawals in 2021 and in light of this intend to review the reserves policy of the charity in 2021 and set a target for free reserves going forwards as defined above.

Going Concern

The Trustees have assessed the principal risks and formulated a suitable reserves policy as stated above. They are satisfied that the charitable company has adequate resources to continue as a going concern.

INVESTMENT POWERS, POLICY AND PERFORMANCE

Per the Memorandum and Articles of Association, the Trustees have the power to invest the money of The Drinks Trust (formerly The Benevolent) as they see fit subject to the conditions required by law. The Trustees Investment Act 2000 therefore applies.

The Drinks Trust (formerly The Benevolent) uses Credit Suisse (UK) Ltd as its investment advisers and has agreed, in writing, an investment policy with this adviser, which states the scope, limits and restrictions and investment objectives. This policy is reviewed on a regular basis by the Investments Committee. Assets may be invested in stocks, shares, units in collective investment schemes, Government securities, debentures, loan stocks, bonds but not options, futures or contracts for differences. No investment is permitted on an exchange, which has not been recognised or designated by the Securities and Investment Boards, without the written instructions of The Drinks Trust (formerly The Benevolent).

In agreeing the investment objectives The Drinks Trust (formerly The Benevolent) has set a target to be achieved, as well as the balance between capital growth and income. The mix between UK and international equity exposure has also been agreed. Valuations of the investment portfolio will be carefully monitored and will be sent to The Drinks Trust (formerly The Benevolent) every 3 months. The performance of the investments is measured against the relevant benchmarks and has been broadly in line with these.

TRUSTEES' REPORT (continued)

GRANT POLICY

The Welfare Grant guidelines were reviewed by the Trustees to ensure clear criteria and clarity of purpose. New guidelines were developed and issued in 2016 reducing the working tenure required from potential beneficiaries in the UK drinks trade from 5 years to 2 years, or 20% on a person's working life if young.

In all cases, the eligibility of prospective beneficiaries is established in line with the Articles of Association. In many cases beneficiaries are of pensionable age and are in retirement, however The Drinks Trust (formerly The Benevolent) is increasingly helping those within the current workplace that need financial help as well as practical and emotional support.

Potential beneficiaries are contacted before a regular charitable donation is offered to assess their needs and eligibility. In addition, beneficiaries are normally contacted at least once a year by the Welfare Officers to ensure their circumstances remain unchanged.

FUTURE PLANS

Strategy and Business Plan

The strategy review presented in March of 2020 was successfully implemented throughout the remainder of the same year. All goals set out in that document were achieved, except for the development of the charity's events program, which was cancelled as a result of the pandemic. A further update to the strategy review was delivered in February 2021, which set out goals to deliver services and revenues over the volumes achieved in 2019, although lower than those of 2020. This strategy recognises the distinct circumstances created by the COVID19 pandemic and sets out plans to grow the charity beyond its 2019 position and build on the increased visibility and support it received in 2020.

Services

As part of the updated strategy review, The Drinks Trust will look to deliver new services in 2020. These will include skills and vocational services for those experiencing financial hardship and diversity and inclusion services, aimed to develop representation in the industry.

Fundraising

The charity has set out plans to deliver revenues from fundraising and donations below those of 2020, but above those of 2019. The Charity has policies in place to protect vulnerable donors. No complaints were received relating to the Charity's fundraising activities during the year.

The Trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the charitable company's transactions and disclose with reasonable accuracy at any time the financial position of the charitable company and enable it to ensure that the financial statements comply with the Companies Act 2006. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

So far as each of the Trustees are aware at the time the report is approved:

- there is no relevant audit information of which the charity's auditors are unaware; and

1. ACCOUNTING POLICIES

a) Accounting basis

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Statement of Recommended Practice for Charities (SORP 2019), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006. Within the definitions of FRS 102, the charitable company is a public benefit entity.

b) Going Concern

The trustees consider there are no material uncertainties about the Charity's ability to continue as a going concern.

As a result of the significant and ongoing uncertainty created by COVID19, management of The Drinks Trust (formerly The Benevolent) have provided evidence to trustees to show that the charity continues to be going concern in the foreseeable future. This has been evidenced through the sharing of up to date forecasts.

Additionally the charity has a very strong balance sheet with large investment and cash balances.

c) Critical accounting judgements and estimates

In preparing these accounts, management has made judgements, estimates and assumptions that affect the application of the charity's accounting policies and the reported assets, liabilities, income and expenditure and the disclosures made in the accounts. Estimates and judgements are continually evaluated and are based on historical experience and other factors, including expectations of future events that are believed to be reasonable under the circumstances.

d) Fund accounting

Unrestricted funds

These funds comprise accumulated surpluses and deficits on the General Fund. They are available for use at the discretion of the Trustees in furtherance of The Drinks Trust's (formerly The Benevolent) general charitable objectives.

Restricted funds

These funds are those funds subject to specific restricted conditions imposed by the donors.

e) Income

Income is recognised when the charity has entitlement to the funds, any performance conditions attached to the item(s) of income have been met, it is probable that the income will be received and the amount can be measured reliably.

Donations, gifts and donations in kind

Donations and gifts are included in full in the period in which they are received. Donations in kind are valued at the estimated market value of the transaction.

Grants

Grants are included in the period in which they are receivable, unless they relate to a specific future period in which case they are deferred. Furloughing grants are recognised on a receivable basis

NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31ST DECEMBER 2020

1. ACCOUNTING POLICIES (continued)

Investment income and investments

Investment income is accounted for as it accrues. Investments are acquired in accordance with the powers available to the Trustees. Investments are shown at market value. Realised and unrealised gains and losses are included in the Statement of Financial Activities.

g) Expenditure

Charitable expenditure represents the costs of fundraising, housing, welfare and support costs. It includes staff costs which are directly attributable to these activities. Redundancy and termination costs are accrued in the period in which the decision is made and communicated to the affected employee(s).

Support costs comprise all services supplied centrally, identifiable as wholly or mainly in support of direct charitable purposes and include an appropriate proportion of general overheads.

Where costs cannot be directly attributed they have been allocated to activities on the basis of the estimate of the time spent on the relevant functions.

Central overheads are allocated to direct costs, supports costs and grants in two key areas: fundraising and charitable activities. The basis of the allocation is to ensure that the costs within administration related to the management of the Company's assets, operational administration and compliance with constitutional and statutory requirements are appropriately apportioned within these areas.

Governance costs are the costs associated with the governance arrangements relating to the general running of the charity, including costs of strategic planning for the longer term development of the charity. These costs are now included in charitable activities in line with SORP (FRS102).

h) Grants payable

Grants are recognised in the accounts when awarded by the Trustees and notified to the recipients.

i) Tangible fixed assets and depreciation

Tangible fixed assets are stated at cost.

Depreciation is calculated to write down the cost of assets to their estimated residual values over their expected useful lives as follows:-

Fixtures and fittings and equipment - 20% on cost
Motor Vehicles - 20% on cost
IT Equipment - 33% on cost

j) Operating leases

Operating lease rentals are charged to the Statement of Financial Activities on a straight line basis over the term of the lease.

k) Pension costs

The charitable company has arranged a defined contribution pension scheme for its employees. Contributions are charged to the Statement of Financial Activities in the year they became payable.

NOTES TO THE FINANCIAL STATEMENTS

FOR THE YEAR ENDED 31ST DECEMBER 2020

1. ACCOUNTING POLICIES (continued)

Financial Instruments

The charity only has financial assets and financial liabilities of a kind that qualify as basic financial instruments. Basic financial instruments, including trade and other debtors and creditors are initially recognised at transaction value and subsequently measured at their settlement value.

m) Debtors

Debtors and other debtors are recognised at the settlement amount due after any discount offered. Prepayments are valued at the amount prepaid net of any discounts due.

n) Creditors and provisions

Creditors and provisions are recognised where the charity has a present obligation resulting from a past event that will probably result in the transfer of funds to a third party and the amount due to settle the obligation can be measured or estimated reliably. Creditors and provisions are normally recognised at their settlement amount after allowing for any discounts due.

Mike Mackenzie fund

This fund is used to support Mike Mackenzie.

Rebecca Stone treatment fund

This fund was used to support Rebecca Stone's medical treatment until her death in November 2020.

Connect assist helpline restricted fund

These funds represent monies received towards the cost connect assist helpline run by the charity. This was fully utilised for this purpose in the year.

Minds matter restricted fund

This grant is for the exclusive purpose of supporting Grantee's activities to run a services of mental health first aid courses across cities within the UK that will be available for bartenders to attend completely free of charge. Each course will be based in a different city in the UK to ensure maximum exposure across the UK bartending community, and there will be a capacity of 100 attendees for each session.

Vintry fund

These funds represent monies received towards the support of the residents at the Vintry home in Eastbourne. This facility was once owned by The Benevolent (previous name of The Drinks Trust) and subsequent to its sale The Drinks Trust continues to support residents who worked in the drinks and hospitality sectors who are resident there. Support is supplied by way of Lifeline emergency call system grants, gas utility grants, Christmas hampers and the vehicle tax on the minibus for the home.

10. RESTRICTED FUNDS (cont.)

Case-related fund

The case related fund represents donations specifically to assist individual cases being handled by The Drinks Trust. These are most often high-cost cases, where individuals require expert services or equipment, and are often facing significant hardship, mental health concerns or critical illness.

COVID19 Relief Fund

The COVID19 Relief Fund was set up in 2020 to deliver one-off grants of £250 to individuals in the drinks and hospitality sectors who had lost significant income as a result of the pandemic. These individuals were most often made redundant to the closure of business, or on furlough, but on 80% of an already low salary and may have had dependents of hardship concerns.

Wellness events fund

The Wellness Event Fund was developed in 2020 to manage all donations specifically intended for The Drinks Trust to run in person or digital learning events covering wellbeing practices and self or staff improvement.

Wellbeing fund

The Wellbeing Fund was set up in 2020 to manage monies donated to cover the cost of three of The Drinks Trust's wellbeing services. They are; Counselling services provided by the Dr Julian digital counselling platform, Mindful Drinking tuition supplied by Club Soda and Sleep & Insomnia treatment from Sleepstation.

Diversity and inclusion Fund

The D&I Fund was also set up in 2020 to manage grants and donations made with the specific intention of developing greater diversity in the drinks and hospitality sectors.
