#### Objectives of the Church

The mission of The Potters House (Manchester) is the propagation of the Gospel of Jesus Christ, in accordance with the Holy Scriptures in Saint Matthew's Gospel, Chapter 28 verses 18-19.

Our aim is to be an impact locally, nationally and globally.

#### **Review of Activities**

We have experienced great progress and increased income while at the same time the congregation has also increased. This has allowed us to continue our objectives locally through various outreaches such as concerts, drama and special services locally and globally by partnering with our leadership church in sending the financial support to missionaries around the world.

#### Plans for the Future

As in prior years, we are aiming to see our Church becomes an ever more increasing influence in our area, and in the City of Greater Manchester as a whole. # 7. RISK ASSESSMENT

The Trustees actively review the major risks which the charity faces on a regular basis and believe that maintaining the free reserves stated, combined with the annual review of the controls over key financial systems carried out on an annual basis will provide sufficient resources in the event of adverse conditions. The Trustees have also examined other operational and business risks which they face and confirm that they have established systems to mitigate the significant risks.

#### 8. RESERVES POLICY

The Trustees have considered the level of reserves they wish to retain, appropriate to the charity's needs. This is based on the charity's size and the level of financial commitments held. The Trustees aim to ensure the charity will be able to continue to fulfil its charitable objectives even if there is a temporary shortfall in Income or unexpected expenditure. The Trustees will endeavour not to set aside funds unnecessarily.

#### 9. PUBLIC BENEFIT

The Charity acknowledges its requirement to demonstrate clearly that it must have charitable purpose or 'aims' that are for the public benefit. Details of how the charity has achieved this are provided in the Trustees Report. The Trustees confirm that they have paid due regard to the Charity Commission guidance on public benefit before deciding what activities the charity should undertake.

# 8. LEASE OR HIRE PURCHASE AGREEMENTS

No finance leases or hire purchase agreements were undertaken in the financial period.
