#### PASTORAL REPORT 2020

#### Outreach

For the first two months of the year, we held our usual activities, the monthly Guild, Croftfield and Dementia Tea Services, Knit 'n' Natter and Saturday coffee mornings. but in March 2020 all activities had to be cancelled due to the pandemic.

#### Giving

Members have continued to support the Carlisle Foodbank and Carlisle Key where possible. We were also able to make up over 40 shoe boxes for the Hope Christmas shoe box appeal.

#### **Ecumenical**

The church secretary has met on zoom with other members of the Heart of the City Mission community.

#### Worship

From mid-March onwards all services were cancelled with the exception of three in September. Members used a variety of methods to join in worship, including TV, radio, zoom, U-tube. We also distributed written service sheets to those who requested them. We are grateful to the Reverends Dave Harkison, Cumbria URC minister with oversight, and David Pitkeathly, the Carlisle Church of Scotland minister, for providing regular service material. Pastoral care has been maintained by regular communication with members through phone calls and the monthly Bridge magazine.

**Elders' meetings** took place on zoom from May onwards. A brief **Church AGM** was held in September after the morning service to approve the Annual Reports and Accounts. Three elders retired and the remaining elders and officers agreed to continue in place until such a time as an election could be held in person.

#### **Farewell Service**

On Sunday 23rd February we held a memorable farewell service for Nick and Janet Mark, attended by about 100 people, including local and Synod clergy, and followed by a tea in the Tithe Barn.

The COVID-19 pandemic has, of course, restricted all church activities and although our committee has not met for over a year, work to ensure the building is safe and cared for has continued. We are particularly grateful to Trevor who has taken the lead in looking after St.George's. He has overseen the repair of two broken windows, the maintenance of the central heating system, liaison with the gas company as well as other routine tasks.

The intruder and fire alarm systems have routinely been serviced and shortcomings rectified.

The church has, during the closure, had regular visits by the cleaning contractors. Thanks to Pam for taking the lead.

The CCTV camera at church house is operating and gives a very clear view of the entrance and side of St George's.

I would especially like to thank John for his competent stewardship of church finances during this difficult period.

Finally, a big thank you to everyone who has visited the church regularly and reported on anything untoward.

I express my gratitude to all committee members who work diligently to ensure the church functions so well.

This report includes information required by the Charities (Accounts and Reports) Regulations 2008 and the Statement of Recommended Practice for Accounting by Charities 2005 as applicable to charities entitled to prepare accounts on the receipts and payments basis.

#### ADMINISTRATIVE INFORMATION

St George's United Reformed Church Charity is a local church of the United Reformed Church in Great Britain, and is a member church of the North Western Synod of the Church. It was registered on 26<sup>th</sup> November 1965 as Charity Number 234519.

St George's United Reformed Church is situated at West Walls, Carlisle CA3 8UF. The Church building is leased on the church's behalf by The United Reformed Church (North Western Province) Trust Limited from Carlisle Cathedral Development Trust. The lease is for a period of ten years from 4<sup>th</sup> February 2015 to 3<sup>rd</sup> February 2025.

#### STRUCTURE, GOVERNANCE AND MANAGEMENT

The activities of St George's United Reformed Church are overseen by the Elders' Meeting of the Church in accordance with the provisions of The Structure of the United Reformed Church determined by the General Assembly of the United Reformed Church, and supplemented by the rules of St George's United Reformed Church. The governing document of the registered charity is a statement adopted by the Church Meeting.

The Elders' Meeting is responsible for the financial administration of the Church, and the care and maintenance of Church premises and the manse. The Church Meeting (of all members wishing to attend) gives general guidance on the life and work of the Church. The members of the Elders Meeting are the minister in pastoral charge (if any) and members of

the United Reformed Church nominated and elected by the members of St George's United Reformed Church in Church Meeting. Elders serve for five years, retire by rotation and are eligible for re-election. There is no limit on the number of consecutive periods of service. The members of the Elders' Meeting are the trustees of the registered charity during their period of service as elders.

The Elders' Meeting met six times during the year, in addition three meetings were held for the purpose of carrying out risk assessment in connection with the Coronavirus pandemic. Several of these meetings were held online via Zoom.

The Elders' Meeting is assisted in the administration of the Church and its property by committees established for Finance and Property, Social, Fundraising and Communications and Publicity and Technology.

The Church Meeting is normally held quarterly. During this year due to the Coronavirus pandemic only the January meeting was able to be held. A short Church Meeting was convened after morning service on 27<sup>th</sup> September for the purpose of approving the Annual Reports and Accounts for 2019.

#### **OBJECTIVES AND ACTIVITIES**

As a local congregation of the United Reformed Church, St George's United Reformed Church seeks to advance the Christian religion through its activities and the facilities offered to the community by its building, and described more specifically in its mission statement: 'As Christian people we meet together for friendship and mutual care; to find an opportunity for reflection about what really matters in life; to find moments of peace in a busy world; and to find the strength to live our lives more fully and more lovingly and more generously. We look to the life, teaching and example of Jesus for guidance and inspiration.'

The Elders' Meeting is aware of the Charity Commission's guidance on public benefit in "The Advancement of Religion for the Public Benefit" and has regard to it in the administration of the Church.

The Elders' Meeting believes that, the Church provides benefit to the public by:

- providing resources and facilities for public worship, pastoral care and spiritual, moral and intellectual development, both for the congregation and for anyone else who wishes to benefit from what the Church offers;
- promoting Christian values and service by members of the congregation to the community, for the benefit of individuals and society as a whole.

#### **CORONAVIRUS PANDEMIC**

Due to the worsening of the Coronavirus Pandemic the Elders' Meeting decided to suspend worship services and all other church activities after the service on 15<sup>th</sup> March. The Elders' Meeting kept the situation under review.

In the interests of protecting the health of church members only three further services were held on  $13^{th}$ ,  $20^{th}$  and  $27^{th}$  September when infection rates had subsided, with suitable hygiene and social distancing measures in place.

Due to worsening infection rates, all Church activities were again suspended until the end of the year

### Accounts for the financial year 1st January to 31st December 2020

The accounts have been prepared on the receipts and payments basis. Investment funds are held by the United Reformed Church North Western Synod on behalf of the church.

#### **Coronavirus Pandemic**

Due to the Coronavirus pandemic the church suspended all activities after the service on 15th March 2020. Subsequently only three further services were held in September. Church members generously maintained their financial contributions through the freewill offering scheme, donations and standing order contributions which protected the church from possible serious financial loss, however all other income from fund raising activities and lettings of the church to other organisations ceased, resulting in a loss to the church's general account of about £7,200 over the year.

#### **Synod Manse Fund**

The manse at Lowry Hill Road, which was previously owned jointly by St George's URC and Brampton URC, was transferred to the North Western Synod Manse Scheme in 2019. The manse was sold late in 2020, The Manse Scheme Grant of £45,951.84 arising from the sale is held by the North Western Synod on behalf of the church and is included in the capital funds section of the accounts.

#### Independent examiner's report to the Trustees of St Georges Reform Church.

I report on the accounts of the charity for the year ended 31st December 2020, which are attached.

#### Respective responsibilities of trustees and examiner
