The events that we have attended have also been opportunities to educate the public about animal welfare, the need to challenge animal cruelty, and how animals are best cared for.

Animal Canopy promotes animal welfare in the main by making grants to appropriate organisations who have met the grant making policy requirements. Each organisation has followed the application process prior to the grant being released, and has then executed the project/activities which provided the basis for the grant being made.

Animal Canopy is very appreciative of the contributions made by our valued volunteers. They have been very supportive and have offered their time, expertise and suggestions unstintingly.

## Section D

# Achievements and performance

Summary of the main achievements of the charity during the year

Achievements in 2020.

Our activities in 2020 have focused on fund raising and allocation of grants to qualifying organisations, although the Covid 19 pandemic has substantially changed our activities.

We have been unable to conduct our usual fundraising activities with the exception of a single tabletop sale. All other events such as shop and street collections, tombolas at local community/school events such as fairs, carnivals, fetes, craft fairs, other tabletop sales were cancelled. However, we were very fortunate to have been supported by the Cockapoo UK Owners Club who again chose Animal Canopy as their charity of the year. In addition, we received generous grants from grant giving organisations who have been very mindful of the fundraising difficulties of charities such as Animal Canopy caused by the pandemic. It has also been encouraging to receive some donations from individuals on a regular basis. We have also become involved in the distribution of purple poppies – the remembrance of animals killed or injured in war zones (the animal equivalent of the British Legion red poppies). All funds raised in this way were sent to organisations who care for war damaged animals.

A total of £39972 was raised in 2020, which reflects the hard work and commitment shown by the trustees and supporters. It also reflects the generosity of grant making organisations and the Cockapoo UK Owners Club.

We evaluate grant applications twice a year (February and August), and as a result have made grants of £35350 in 2020. Of this total, £25450 was to UK based organisations (40 grants) and £9900 went to overseas organisations (4 grants). It has been very encouraging to hear how the organisations have used the grants to further animal welfare and provide public benefit in doing do. With regard to one of the grants this year, we have set aside our standard priorities such that this grant exceeded our preferred maximum grant (£2000). The recipient organisation (one that we have supported several times in the past) was overrun by animal welfare demands at the same time that their vet refused to extend their credit any further. We decided to provide them with sufficient finance to make them solvent again.

The trustees have had due regard to the guidance on public benefit given in the Charities Act and the Charities (Accounts and Reports)
Regulations 2008 when planning and executing each event.

Plans for 2021.

We will continue to work closely with the organisations that we support. However, the ongoing Covid pandemic means that we cannot realistically plan for 2021 in any detail. We also have long term illness issues, which may affect what we can achieve with the charity. We will carry over a larger sum of money to 2021 than we might otherwise have done, to ensure that we can continue to support small animal recue organisations in a meaningful way in 2021. We believe that this is a prudent course of action to take in view of the uncertainty of being able to attend our usual fundraising types of event.
