The Committee present its report and the financial statements for the period ended 31 March 2021.

***Legal and Administrative***

The Charity is a Charitable Incorporated Organisation governed by a Foundation Model Constitution dated 3 October 2017. The Charity is registered with the Charity Commission under registration number 1174959.

***Principal activities and objectives***

To promote humane behavior towards animals by providing appropriate care, protection, treatment and security for animals which are in need of care and attention by reason of sickness, maltreatment, poor circumstances or ill usage and to educate the public in matters pertaining to animal welfare in general and the prevention of cruelty and suffering among animals by the support of the charitable work of Lucy's Sanctuary for Holy Land Donkeys.

***Organisation***

The Charity is run by the trustees, and the charity has taken on one part time employee, and part time volunteer in Israel, Lucy Fensom's husband Adi who is paid via an agency. Apart from the first charity trustees, every trustee must be appointed by a resolution passed at a properly convened meeting of the charity trustees.

***Review of Activities***

***General***

- Currently supporting the care of 53 donkeys 21 female and 32 male, 3 male horses, 2 dogs and 8 cats at the sanctuary. There is significantly less to report in the way of activities such as outreaches this year due to the ongoing world situation with Coronavirus.

***New Rescues Taken in at Sanctuary***

- Have rescued Leah an elderly battered and abused donkey. Other rescues include donkeys, Stevie, Shanaya, Shayne, Chico and Sergio.

***Castrations Operations***

- Donkeys Stevie and Shayne received castration surgery.

***Euthanasia***

- Sadly donkey Esther's health deteriorated and she had to be euthanised.

***Death***

- Donkey Valerie was found dead due to old age.

*Review of Activities (cont'd)*

*Worming, Medicine and Vaccinations*

Sanctuary

- Worming for 62 animals at the sanctuary every 4 months.

Outreach

- Worming for 70 animals at the outreach clinics.
- Each 8ml dose of worming tablets costs approximately £1.20 per animal.
- Dr Nour held an outreach clinic in a Palestinian village called Amoria. He treated 4 donkeys, 5 mules and 3 horses - treating injuries and oedema, giving anti parasitic, antibiotics and lancing and draining an abscess on a hind leg. He also put a few nose chain covers over the chains used around the animal's noses but he doesn't know if the owners will keep them on.

Total Cost for Dr Nour and an assistant - 600 shekels (amount in £ 133)

*Sanctuary Veterinary Operations*

- Routine eyes cleaned and anti-fly ointment put on, legs are routinely sprayed with anti fly ointment and all animals are routinely groomed.
- Chico had a wounded back but this is now healing.
- Donkeys Sika, Leah, Alan, Katy, Jeremiah, Poppy and horse, Prince are being closely monitored due to their fragile health
- Dr Jaber visited horse Prince for deteriorating general condition and donkey Leah for leg problems.
- All animals wormed.

*Farrier*

- 56 animals farriered in October 2021 and March 2021

*Outreach Veterinary Clinics*

- Clinics were held in April and May in the Palestinian village of Ras Atira.

*Forthcoming*

- The donkey's main shelter roof guttering needs replacing before next winter.
- 4 x 4 vehicle required. Also separated roofed area for older donkeys required to prevent competition for feed areas. Labour required to build this but there are already materials.

*Fundraising*

- Massive thanks goes to Sally Olsen, Dennette Doughty, Pat Abercromby and Brenda Needle, Pia and Stefan Wallin for their fundraising efforts and to Candace Cannichael for a very generous donation.

***Review of Activities (cont'd)***

The Trustees would whole heartedly like to thank Lucy Fensom and her volunteers for the huge amount of incredibly backbreaking, exhausting work they do day and often night. The work is both physically and emotionally exhausting and can only be described as a dedicated labour of love devotion and compassion.

***Financial Review***

Net incoming resources for the period amounted to £16,289 (2020 net outgoing resources: £2,482) as shown on page 6 of the financial statements. All of the charity's assets are held in the furtherance of the charity's objectives and are adequate and sufficient to meet the charity's needs.

***Reserves policy***

It is a policy of the charity to maintain unrestricted funds, that is the free reserves of the charity at a level that will enable the charity to continue it's operations while it looks for alternative funding if it suffers a significant reduction in income.

***Risk Management***

The Committee have identified the major risks to which the charity are exposed and have produced a Risk Assessment policy to put systems into place to mitigate those risks. This policy will be regularly reviewed by the trustees and updated when necessary.

As the charity's trustees you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').


