DIRECTORS REPORT

FOR THE YEAR ENDED 30 JUNE 2020

Too Good To Waste (Ellesmere Port) has had a very eventful and successful year. Taking over the running of "The Wednesday Welcome", where we provide a free weekly meal to approximately 250 community members has continued to be a huge success.



We have been privileged to secure funding to bring on paid staff, as up until this year all of our activities have been carried out by volunteers. This amazing weekly meal has proven beyond doubt how beneficial eating and socialising is to our community. We have joined forces with our local GP practices who have now become united under the One banner. We are in the process of setting up a Friday welcome and once this is up and running, we envisage more welcome days. These welcome days will be associated with a local GP practice and it's our vision that both medical and non-medical staff will be onsite to help serve the food.

These days will also open up volunteering opportunities for local people that the GP or support staff have identified and will help these individuals, many with issues around social isolation and mental health, with the necessary support and interventions they may require.

DIRECTORS REPORT

FOR THE YEAR ENDED 30 JUNE 2020

Building on the success of Wednesday Welcome plans for the next welcome day at Hope Farm are being prepared. At the time of writing, we find ourselves three months into a global pandemic. Our Wednesday Welcome has had to be suspended and plans to open more welcome days have to remain on hold until we have Government guidance. The use of a newly employed, bespoke development manager has been a God send in sourcing additional food when Covid 19 hit. All of our resources have been seconded to support our community food club and making sure our community are supported. We have instigated a caring line to support in excess of 300 people per week by telephone and we have set up a counselling line with three trained mental health counsellors for those in need of more than just a chat. It's not appropriate of offer future plans as none of us will know how this pandemic may dictate the way we engaged with our community in the future.


