My report is for the accounts for the period ended 31 December 2019.

Respective responsibilities of trustees and examiner:

The Charity's Trustees are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ("the Act").

The Charity's Trustees consider that an audit is not required for this year under section 144 of the Act and that an independent examination is needed.

Basis of Independent Examiner's report

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.	Para 1.20	In early 2019 the church appointed Stefan McNally into the role of fultime Lead Pastor. Following his appointment, Stefan worked with the Trustees on a review of ministry and operational functions, with the objective of identifying areas of church life that require strengthening oproper resourcing. The review made a number of recommendations ranging across Pastoral Care, Evangelism, Adult Discipleship and Safeguarding, as well as investing in the regeneration of the church building. During 2019 we have started to address the review recommendations,
		including
		 Delivering Safeguarding training and updating procedures Forming a Buildings Team to oversee church refurbishment Launching an Alpha course Transitioning our Community Pastor to an Associate Pastor role, reviewing existing commitments to free up space to invest in Pastoral Care & Support, Evangelism and Adult Discipleship.
		In addition to the main church service, we also run a Kids Church & have Youth provision on Sundays. There are a range of activities focusing on craft and stories for pre-school children, through to more discussion-based programmes for young people at the church. There are also regular teaching and social gatherings that are put on for young people throughout the year, including attendance at a youth focused festival (Soul Survivor) in August.
		A programme also runs for the men (Manstuff). They meet regularly for breakfast and attend a conference in Bradford, with TPC Women attending the annual Colour Conference in London. Young at Heart continues to be a vital ministry, and runs on Thursday mornings and afternoons. This proves vital for some who are unable to venture out on a Sunday morning.
		Through the work of CAP, beneficiaries have been supported through the process of paying down their debts. Some clients have become debt free, but for many this is an ongoing process. However the friendship and support afforded by the CAP volunteers and staff brings about great emotional and psychological support for them. Furthermore, some clients have decided to become a Christian and taken steps towards joining the church.
		The Foodbank has continued to play a role in the town. At a time when

austerity is causing problems for those on benefits, or on those waiting for benefits to arrive, the Foodbank can play a significant role in making sure that children and adults have a balanced basket of food to eat. By working with other churches, the Foodbank is a town-wide initiative overseen by The Peoples Church.
In addition to these church-led activities, the Trustees have chosen to allow the building to be used by other groups. The church is the main location for the Blood Donors in the town.

Performance of fundraising activities against objectives set	Para 1.41	During 2019 offerings and donations from church attendees were largely consistent with 2018. This enabled the Trustees to continue spending on the direct charitable activities of the church, with a particular focus on activities for the youth and Kids Church. The Trustees approved an extensive programme of essential church refurbishment works during 2019, with a budgeted cost of £135,000. Church attendees raised £29,468 of this cost, with a further £20,000 raised through a council-funded capital grant. The remaining costs were funded in part from existing reserves and in part through an interest-free loan from a church member.

Review of the charity's financial position at the end of the period	Para 1.21	Income for 2019 totalled £227,490, an increase of 19% compared to 2018. The increase was largely the result of capital donations and grants received amounting to £49,468.
		Expenditure in 2019 totalled £322,903, including expenditure on church refurbishment amounting to £135,408 (compared to £7,433 in 2018). Excluding church refurbishment costs, expenditure in 2019 totalled £187,495, an increase of 16% compared to 2018. The increase in operating expenditure resulted from increased staffing costs following the appointment of a full-time lead pastor in March 2019.
		The church refurbishment programme has necessarily resulted in a deficit for the year amounting to £95,413, During the year, the church membership approved the sale of a redundant church manse in order to fund the church refurbishment programme, repay all existing church debt, and to set up a capital fund for future capital expenditure. The sale was completed in March 2020 for proceeds of £315,000, which have been utilised for those purposes.

Amount of reserves held	Para 1.22	As a consequence of expenditure on the church refurbishment programme, unrestricted cash reserves at 31 December 2019 were temporarily reduced to £6,036 pending realisation of additional cash reserves from the manse sale. During the year, reserves were kept under constant review by the Trustees and the church had access to additional sources of loan finance should that have been required. Restricted cash reserves of £3,366 are held to meet future costs of the Foodbank and Pre-school activities.

Details of fund materially in deficit	Para 1.24	At 31 December 2019 the unrestricted fund was in deficit by £76,747, as a consequence of expenditure on church refurbishment. This deficit was recovered in March 2020 following the sale of the manse for proceeds of £315,000.
