The objects of the CIO are the advancement of education in, and the promotion of, the musical arts of Southeast Asia, by promoting cross-cultural artistic links between the United Kingdom and Southeast Asia, providing facilities, services, education programmes, workshops and opportunities more generally to participate in such musical arts, and raising awareness of such musical arts in the United Kingdom; amongst the public in general and in particular but not exclusively young adults from ethnic minority backgrounds; both in the United Kingdom and Southeast Asia.

The key activities of the charity are the advancement of education in, and the promotion of, the musical arts of southeast asia.

TSI was dormant during the year and therefore the main activities were not undertaken, these aim begin in the next financial year.

Achievements and Performance

The Sound Initiative successfully registered a branch of the charity overseas in Phnom Penh, Cambodia. The branch is registered with the Ministry of Foreign Affairs and International Cooperation, which allows TSI to carry out its humanitarian projects in Phnom Penh and provincial cities upon the approval of relevant governmental authorities based on government priorities and TSI field of competence and budget availability. This branch intends to ease local funding and build stronger relationships with local institutions and ministries to do impactful arts work between Cambodia and the UK.

Due to the challenges of COVID-19, TSI has been unable to run activities between the UK and Cambodia as intended. This has affected the ability to raise funds and implement activities in the UK.
