

Minutes of the meeting of parishioners held on Sunday 18<sup>th</sup> October at 2pm.

### Meeting to elect churchwardens

- 1. Opening Prayer
- 2. Election of clerk to the APCM Jill Mulligan. Proposed Janet Whitaker; seconded Lorna Sykes. All in favour.
- 3. Election of church wardens Janet Whitaker and Lorna Sykes reelected until May. All in favour. Shirley expressed her gratitude to them both for all their hard work.

# Minutes of the APCM held on Sunday 18th October at 2pm.

- 1. Janet asked if anyone had any queries about last year's minutes. Eileen Sheller proposed that the minutes were accurate, Lorna Sykes seconded and everyone was in favour.
- 2. Electoral Role: Malane Pickard reported that there were currently 68 names on the electoral role, previously there were 71.
- 3. Annual report 2019-2020 has been prepared and distributed.
- 4.Fabric, Goods and Ornaments report Janet expressed thanks to Friends of St Johns for all their help and support.
- 5. Audited accounts: Melvyn Ward approved the accounts. Joel explained that 2019 had been a good year financially. There was lots of backdated gift aid and a legacy. 2020 is different as there are no hall bookings and very few weddings so our income is lower. We now have some new utility providers so we have made some savings. We are paying half the share at the moment but the aim is to increase that when we can. Joel asked everyone to pray about their giving.
  - Reports: Children's services- ABC is continuing on zoom at 9.30 and Sunday School on zoom at 10.30.

House and Study groups – the groups are meeting on zoom and by telephone.

Sunflower Café- the group are still unable to meet at the moment. The Bereavement group will hopefully meet up in the new year. The Farmer's market is back up and running on the 4<sup>th</sup> Saturday. There is the possibility of some indoor stalls but no café. Churches Together- we are hoping to work with them in the future.

### 2. Elections:

- (i) Members of the PCC: There were three vacancies for the PCC for three years. Meetings are usually held on the first Monday of every month, except in August. Three nominations have been received. Eileen Sheller, Alan Saxton and Shirley Walker were appropriately proposed and seconded and duly elected. Howard Bradley was co-opted to the PCC. The Deanery Synod representative is Bev Tuke; Shirley Walker shared this role but is now stepping down.
- (ii) Mike and Lesley retired from the PCC. Thanks, were expressed to Mike and Lesley for their hard work and contribution to the PCC.
- (iii) All Sidespersons officially 'retire' at this meeting- there is no role at the moment so there will be no elections.
- 3. Chairman's Remarks: Janet began by saying that Lorna and herself were not planning to stand for election as Church wardens next year as it had been such a difficult year. She said it would be lovely if someone volunteered and then could shadow them and learn the role. Next year should be easier as we will have a new vicar and a new parish administrator.
  Janet went on to thank everyone for their support and she thanked Shirley for her work as a Deanery Synod representative.
  Janet expressed her thanks to Revd Sue McWhinney for all her support and said how lost we would have been without her help. She went on to express her thanks to James Webster for all his hard work with the online services.
- 4. Vacancy Update- There were 10 applicants for the post. Gareth Howles was appointed and will be joining us on the 3<sup>rd</sup> of December. His first service will be on the 6<sup>th</sup> of December. We are all looking forward to welcoming him.
- 5. The vicarage is in use at the moment- 3 young people, interns are getting a taste of church life and receiving training.
- 6. Progress in Developing the Church Building- the heating project has been put on hold during lockdown. Ray Sheller is kindly looking at the possibility of using infrared heating. Our current heating is not working well, Lorna is trying to sort something out as a temporary measure for the heating. We have £9,000 saved towards the heating; we will need to do some fundraising.
- 7. Bev Tuke expressed a great big thank you to Janet and Lorna for all their hard work this year and especially for all the love shown to the older members of the congregation.

### Structure, governance and management

The method of appointment of PCC members is set out in the Church Representation Rules. All Church attendees are encouraged to register on the Electoral Roll and to stand for election to the PCC. Elected members may serve up to two consecutive terms of three years, prior to standing down for at least one year, before they may stand for re-election. The intention is to provide both continuity and a range of experience to create a fully active committee. In order to carry out its aims and objectives, the PCC operates through a number of smaller groups, which meet, when required, between full PCC meetings.

### Objectives and activities

From December 6th 2020, the Revd. Gareth Howles has been Priest-in-Charge of St. John's. On December 3<sup>rd</sup> 2020 he was inducted as vicar. The PCC has the responsibility of co-operating with him in promoting the whole mission of the Church, pastoral, evangelical, social and ecumenical. (The PCC Powers Measure 1956). Together we are working to develop our objectives in proclaiming the Gospel and serving God, within the Church and the community.

During the past year, the PCC has continued to work to develop and refine the strategies by which our objectives may be achieved. Areas identified as priorities, including church growth, outreach, pastoral care, care, maintenance and development of the church building, ecological issues, community links, and generosity in serving the community have been further explored in PCC meetings, each month.

# Achievements and performance

The number of parishioners on the Church Electoral Roll at the APCM 2020 was 71. Since then 4 names have been removed, so the total for the APCM 2021 is 67.

#### Review of the Year

There have been eight full PCC meetings since the last APCM with the Revd. Paul Tudge taking the first two and church warden Janet Whitaker chairing the rest, mostly through zoom. The church wardens have met with Sue McWhinney during the year to discuss on-line services.

St John's has seen a year of real change. Paul Tudge retired after many years at St John's and Covid 19 struck closing the church, something that no one could have envisaged. The church wardens with the help of the PCC and Sue McWhinney had to lead the church services. The wardens soon learned to be inventive and resourceful, delivering the clergy letter and notice sheets and other goodies. James Webster was an invaluable member of the church team editing and helping to produce the on-line services along with Sue McWhinney. The Easter services had to be cancelled and the APCM in March was rescheduled until October; all the PCC members continued until the next APCM. New safety measures were put in place allowing the church to open up for private prayer and then Covid friendly communion. The on-line services also continued. We were pleased to be able to support the Pudsey Project by opening up the hall and collecting food items and also laptops, this was a real community effort and everyone pulled together.

Our heating party has continued to research and investigate the replacement of the current heating system with something more efficient, economical and environmentally friendly. We are trialing a system at present in the side chapel. Our continued gratitude and thanks go to Ray Sheller for all his time, expertise and guidance in order to sort out the best solution for our heating. Our gratitude also goes to the Friends of St John's for their on-going fundraising activities which are vital to the continued upkeep, maintenance and development of our beautiful church. Thank you for your hard work and generosity.

We are hugely grateful to Paul and the Tudge family for everything they have done during their time at St John's. They will be sadly missed but we wish them every happiness in their new home and in this next chapter of their life.

We welcomed Gareth Howles and his family in December. Although things were very different at Christmas it was wonderful to enjoy some Christmas services. St John's were able to offer an on-line Christingle service, a drive-in carol service and services on Christmas Eve and Christmas Day. Gareth and his family eventually moved into the vicarage and we look forward to his ministry with us in the years to come.

In spite of everything that the year has thrown at us, prayer, worship, pastoral outreach and giving has taken place. The pandemic has made us all think differently.

Many thanks go to Lesley Gibbens for all her years as PCC secretary and to Mike for all his years as treasurer. Special thanks go to the church wardens for all their invaluable work this year and to Sue McWhinney and James Webster for their continued support and contributions.

Many thanks too to all our PCC members and to all those who work for the good of St John's, your help and support are greatly appreciated.

# Independent examiner's report to the trustees of St John the Evangelist Church, Farsley

I report to the trustees on my examination of the accounts of the St John the Evangelist Church, Farsley for the year ended 31 December 2020.

# Responsibilities and basis of report

As the charity trustees of St John the Evangelist Church, Farsley you are responsible for the preparation of the accounts in accordance with the requirements of the Charities Act 2011 ('the Act').

I report in respect of my examination of St John the Evangelist Church, Farsley accounts carried out under section 145 of the 2011 Act and in carrying out my examination I have followed all the applicable Directions given by the Charity Commission under section 145(5)(b) of the Act.

# Independent examiner's statement

I have completed my examination. I confirm that no material matters have come to my attention in connection with the examination giving me cause to believe that in any material respect:

- accounting records were not kept in respect of St John the Evangelist Church, Farsley as required by section 130 of the Act;
- the accounts do not accord with those records.

I have no concerns and have come across no other matters in connection with the examination to which attention should be drawn in this report in order to enable a proper understanding of the accounts to be reached.

#### Financial review 2020

Charity accounts are split between 'Unrestricted' funds (of which some may be 'Designated' for a specific cause) and 'Restricted' funds. Unrestricted funds relate to money the PCC can spend on anything that fulfils the objectives of the church. Restricted funds record donations and expenditure for specific purposes or projects.

Financially, 2020 was a difficult year for St. John's with the church closed for much of the year, fewer events and the temporary closure of the hall due to lockdown restrictions, we saw a reduction in all our income streams.

2019 was an unusual year in terms of income as we received a legacy of £10,000 and a catch up of gift aid funding totalling around £18,000. So, comparatively it was unlikely that we would meet income levels of last year.

We had lower costs in comparison to previous years as running costs reduced due to less usage of the buildings and our staffing costs reduced. However, this was the first year in many years that we were not able to pay the full Parish Share in the year that it fell due. The Parish Share is the contribution that each parish church in the Diocese of Leeds pays to fund the cost of clergy and housing, and other Diocese costs, from mission to administration. We fully intend to pay what we owe, and have presented the unpaid Share as a liability in the Statement of Assets and Liabilities.

Every five years, each church in the Church of England must perform a 'quinquennial', which is a review of the church building by a qualified person to identify repairs and maintenance work. This review identified a number of urgent repairs required to the church building and grounds which took place in 2020 - the cost of the quinquennial and works for 2020 account for around £6,950 of the £9,967 (2019: £2,264) church repairs. This was partially funded via a £200 grant from borough of Pudsey charity.

As we close the year we are in a more difficult position than we were at the end of 2019. However, with £12,775 in total Unrestricted and Designated funds we have enough to continue the work of St John's. We still have to start building work on the heating project, though this is expected to commence in 2021. This will be a major financial commitment.

Despite the difficulties of 2020 it has been encouraging to see continued donations to the church throughout this time. Thank you to all who donate to the church: be it by standing order, online or by cash or card. St John's has been a beacon of hope to our community in the past year and the money we have invested this year in moving church online, and shoring up the building for future generations of use could not have happened without your generous support.

### Reserves policy

It is PCC policy to maintain a balance on Unrestricted funds of roughly £1,500 at the end of each calendar month, after paying the Parish Share to the Diocese. Previous years' financial reports have expressed the desire to increase this balance to nearer £4,000, to have enough to pay the following month's Parish Share in reserve. We end the year with £1,154 in reserve, which is below the reserves policy. As noted in the Financial Review, the reason for the balance in the Unrestricted Funds not meeting this target is mainly due to the reduction in income. We were not able to pay the full Parish Share to the Diocese as noted in the above commentary.

2021 brings hope that we will again be able to meet up together, as a church, as we have done in the past. We have two major financial commitments for the future: paying the Share and funding the heating project. Both of these commitments will require the generosity of church members, and our wider community, both in terms of generosity of donations, and generosity of time and ideas in researching grants and fundraising plans.

### 1 FINANCIAL STATEMENTS

The financial statements of the PCC have been prepared in accordance with the Church Accounting Regulations 2006 using the Receipts and Payments basis.

### 2 INVESTMENT ASSETS

All funds which are invested in CCLA Church of England Investment Fund shares.

In all cases, the donations have been made to be retained as a capital fund, but the income is for specific purpose, either General funds, Common Fabric fund or Children's and Youthwork fund.

The Children's and Youthwork fund represents accumulated donations and expenditure for children's and youthwork activities.

The Common Fabric fund represents accumulated donations and expenditure for repairs and maintenance to church fabric (i.e. building and fittings).

### Children and Families

### Children's group at the 10.30 service

This will be done only with a thorough risk assessment, paying particular attention to Covid19 guidelines and ensuring compliance with Diocesan safeguarding policies and DBS requirement.

# The Church in Rodley

What a year, nothing any of us could have expected due to the Coronavirus pandemic. It started well, if sadly, with a farewell to Rev. Paul Tudge, Rosie and family early in January. ### Parish Safeguarding

At the beginning of 2020 we were fully up to date with all the specific requirements set in place to cover safeguarding. All leaders of activities at St John's were vetted nationally or completed voluntary assurances of their suitability for the role undertaken. We need to stay vigilant for those with limited access to the outside world as these are the ones that continue to be the most vulnerable.
