Para 1.20	In June 2020 the Trust began to transfer funds for investment, aiming to increase the capital to around £100,000 at which point the annual return should be sufficient to start distributing grants whilst safeguarding the capital for the future. £45,000 was invested during the year with Finn and Co, a company with which the trustees are familiar and in whom they have confidence of appropriate investments being made according to the wishes of the trustees.
