### <u>Annual Report by the Trustees of St.Mary's Pre-School (Swanage)</u> For the year ended 31<sup>st</sup> August 2021

St Mary's Pre-School (Swanage), began in 1971, formally known as The Millpond Playgroup. This was established to provide the children of Swanage an opportunity to learn to play together in a safe environment with trained staff. The Pre-School then moved into the St Mary's School grounds in 1980 in Manor Road and Re-named themselves as St Mary's Pre-School.

St Mary's Pre-school moved into a newly built building in Northbrook Road in February 2015.

There was provision to provide full day care & employ 5 part time members of staff who regularly attended training courses when available.

The Charity was supported by an enthusiastic committee of parents & staff. Some of which were the trustees.

The Pre-school participated in activities within the local community. When possible children and staff visited a local care home to interact with the elderly residents, hosted demonstrations & talks from the Emergency services. The Committee helped arrange family beach picnics, Easter activities and a children Christmas party.

The Pre-School offered inclusive education, if requested. and no child was be refused a place on the grounds of special needs.

The charity depended on council funding for each child as well as parental contrition's for additional hours, and for donations to fund raising activities arranged by the Committee.

Fundraising during this year included the sale of pre-school printed t shirts & jumpers, an Easter bonnet parade, name the bear competition and a raffle at the children Christmas party.

The Charity worked closely with other local & national agencies for early learning and is a member of The Pre-School Learning Alliance.
