Trustees Report for 2020-2021

The trustees present their Annual Report and financial statements for April 2020- March 2021.

Structure, Governance and Management

The Church is governed by its Constitution, in accordance with which there is a requirement that Attenders become Members of the Church by making a public declaration of faith which may be shown through baptism.

The Church Members Meeting normally takes place six times per year and has responsibility for the overall policy of the church. During this year, because of the Covid-19 pandemic, the church has continued to meet as planned, but meetings have been held on Zoom. Those church members unable to get on Zoom have been given opportunity to send any thoughts or questions related to the agenda in advance of the meeting and receive all papers, an agenda and the minutes of the meeting to keep them abreast of discussions and decisionmaking that take place.

In accordance with the Constitution, the members appoint six Trustees, who together with the Minister, Church Secretary and Treasurer (who are also appointed by the Members), are responsible for the day to day running of the church's work and witness, including the financial and legal aspects. All members are encouraged to take an appropriate part in the spiritual and practical tasks involved in the furtherance of the charitable objective.

Relevant matters may be submitted to the Church meeting by the Trustees for guidance, or may be raised by members attending Church meeting for further consideration by the Trustees. Though the Constitution permits decisions to be made at Church meetings by appropriate majorities, the Church seeks to work by consensus wherever possible.

Objectives and Activities

The principal purpose of the church is the advancement of the Christian faith according to the principles of the Baptist denomination to include the advancement of education, community service and such other general charitable purposes in such parts of the United Kingdom and the world as the Church shall determine.

In order to achieve the principal objective which is set out above, the Church would usually provide a variety of activities both to its membership and to the community generally. The aim is to show the love of Jesus Christ in both word and deed and to bring people into a closer relationship with Him as living Lord. Due to Covid-19 activities have been suspended as the church has been closed.

Central to the work and witness of the Church is the provision of regular public services of Christian worship. Over this year, these services have taken place on Zoom each Sunday at 10.30am.

We have had no regular Sunday children's programme happening, though contact has been kept with them through phone calls, birthday cards and gifts, general cards and Easter and Christmas activities. None of the children have attended our services on Zoom, because their parents were unable to connect.

As well as our Sunday work with the children, the Church also runs Youth Club at Trinity (YC@T) so that children who live near the church can have somewhere to meet their friends and learn more about the Christian faith. Once again this has not been able to run this year, but contact has been kept with young people, through cards and Christmas and Easter activities.

The Church operates systems to ensure that all people working with children and vulnerable adults are appropriately vetted and trained with regard to the Disclosure and Barring Service.

The church also makes its buildings available to other community organisations, but due to government restrictions these have not been able to take place. We are however pleased that we could accommodate a regular contact meeting run by Social Services to enable a parent to meet with their fostered child throughout this year.

The church has read the Charity Commission guidance on public benefit, and is satisfied that the activities outlined above clearly demonstrate that the charity is providing a benefit to the public.

Achievements and Performance

The Church does not measure the success of its programmes only in numbers, including financial numbers, but also in less tangible areas like fellowship and encouragement. The Trustees recognise that these are difficult to measure, and have been difficult to put in place due to Covid restrictions.

However, we do believe that 2020-21 was a positive year in the life of the church: It has given us an opportunity to reflect on what we are doing in church life and understand a bit more the impact that technology can have on the work we do. Therefore, as we continue to move out of restrictions, we are looking forward to a new start and direction for the mission of the church in 2021-22.

As a Church family we have not suffered as greatly as others have with deaths due to Covid, but we have had 2 members and 2 non-members who have died of other causes during this year. At 31 March 2021 the membership stood at 32 which was higher than the previous year.

Average attendance at worship services has remained steady during the year, despite the restrictions. The minister has also been involved with the work of the Churches Together steering group who have continued to meet and pray together on Zoom throughout the pandemic

Financial Review

The Church continues to raise the funds which it needs to carry on its activities from within its own membership and congregation. No wider public appeal was made for funds during the year. The most significant expense related to the appointment of the Revd E Blundell as Minister of the Church, to lead and co-ordinate the church's activities including the Sunday Services, to provide pastoral care for the congregation and other people, and to equip and encourage the membership in their life, Christian witness and service.

The Church expressed its part in the life of the wider church by making grants to national and international Christian organisations and societies with Christian aims and objectives compatible with the church's own charitable purpose.

The Church is heavily dependent on its membership working as volunteers in all aspects of the church's activities, many of which run with little or no impact on the church's expenditure, but nevertheless contribute substantially to the achievement of the church's objectives.

The financial results for the year are set out in the accompanying financial statements.

The church was a participating employer within the Defined Benefit section of the Baptist Pension scheme and there were two separate cessation events in 2008 and 2013. Following agreement with the Baptist Union of Great Britain (BUGB) and the Pension Scheme and the church, a payment that was made by the BU in December 2018 has been deemed to settle the cost of the first cessation event and therefore the church's liability of £164,400 has been recognised in the accounts. The Church intends to meet this liability by remaining in the Baptist Pension Scheme, contributing to a Double Cessation Debt Arrangement and has now agreed a Deferred Debt Arrangement. The Church therefore continues to contribute to the deficit within the scheme which is anticipated to be eliminated in 2026. The liability will then cease unless the Pension Scheme deems that the Church's financial position has changed and can demand immediate repayment of the debt owing it is therefore shown as a debt in these accounts.

Reserves Policy

The Trustees currently have no Reserves Policy as there are sufficient reserves to enable the church to function effectively and meet its obligations in the event of a decline in our income or a major cost. Having considered the relevant risks of changes in income and expenditure, Trustees have determined that an appropriate level for cash in hand is in the range £18,000 to £20,000.

At 31 March 2021, the church held a cash reserve of £128,015 of which £30,766 was restricted and £1,390 designated. A restricted reserve of £10,000 has been allocated for the future upgrade of electrical wiring and lighting. Major designated reserves are Fabric £1,235. The total market value of investments held amounted to £13,829.

9. Pension Liability

The Church was a participating employer the Baptist Pension Scheme ("the Scheme"), which was a separate legal entity administered by the Pension Trustee (Baptist Pension Trust Limited).

The assets of the Scheme are held separately from those of the Employer and the other participating employers. The Scheme, previously know n as the Baptist Ministers' Pension Fund, started in 1925, but w as closed to future accrual of defined benefits on 31 December 2011. Prior to this date the main benefit provided through the Defined Benefit (DB) Plan was a pension of one eightieth of final minimum pensionable income for each year of pensionable service together with additional pension in respect of premiums paid on Pensionable Income in excess of Minimum Pensionable Income. Since 1 January 2012, benefits have been provided through a Defined Contribution (DC) Plan. The Church triggered 2 cessation events following the departure of ministers in both 2008 and 2013. The liability for the cessation event in 2008 has been calculated as £90,300 and for 2013 £164,400.

During discussions between the Baptist Union of Great Britain (BUGB) and affiliated churches in relation to the deficit within the Baptist Pension Trust a payment was made of £33m in December 2018 into the Trust by the BUGB. As a consequence of this event it was proposed that the payment by the BUGB would settle the first cessation event in relation to Trinity Free Church of £90,300. This would leave a liability on the church of the second cessation event on 31 March 2013 when it ceased to employ active members in the scheme. These arrangements have now been finalised. The church was making annual payments towards the deficit whilst these arrangements were put in place. The Church has now entered into a Deferred Debt Arrangement with the pension scheme. Under these arrangements the Church continues to make annual payments towards the deficit. If the Scheme becomes solvent then the liability will be deemed settled or the Scheme may demand payment from the Church if it determines that circumstances have changed. The full outstanding liability is shown in these accounts as this can be demanded by the pension scheme.
