# **TRUSTEES REPORT FOR THE YEAR ENDING 30 JUNE 2020**

The Rotary Club of Prescot Trust Fund was registered as a charity in 2006. Its charitable activities are governed by the terms of a Trust Deed dated 16<sup>th</sup> August 2006 which stipulates that charitable funds shall be use for "the relief of the poor and needy or to or for such other charitable purpose institution society or object as the Club shall in duly constituted meeting from the time of direct".

During the year ending 30 June 2020 Prescot Rotary Club held two major fund raising events, a Rise Against Hunger event and a Christmas float. Both events proved to be financially successful.

A Christmas sleigh toured around the area throughout December. The sleigh also appeared at local supermarkets. All funds received were paid directly into the Trust with relevant cost paid by the Trust. A surplus was generated for the Trust. We thank local residents for their generosity and supermarkets for allowing us to collect at their premises.

Some other smaller donations were also received.

We received requests for assistance throughout the year. All requests are first considered and if necessary researched by the appropriate sub-committee of the Rotary Club. Every request together with the sub-committee's recommendation is then considered by the full Club in open meeting where a decision is made.

The Trust accounts show a total distribution of money throughout the year in excess of £27,000.
