REPORT OF THE TRUSTEES
FOR THE YEAR ENDED 31 MARCH 2021

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2021. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

OBJECTIVES AND ACTIVITIES

Objectives and aims

The Charity's principal objective is to relieve the need of parents-to-be and parents with their infants aged 0-2 within the Brighton and Hove area by the provision of parent infant psychological therapy.

BrightPIP's vision is to change the future for vulnerable babies, one baby at a time in Brighton and Hove. We want every baby in our community to grow up feeling safe, secure and loved. Our mission is to intervene at the earliest time with families to support parents to have positive relationships with their children. We intend to ensure parent-infant psychological therapy (PIP) is freely available to all families in Brighton and Hove who need it.

Brighton PIP Ltd is a charity offering intensive support to expectant parents and those with newborn babies up until the age of three. Through individual therapy or group sessions, we help parents fulfil their child's needs by understanding the world through their eyes and by tuning into signals they send out. Our work strengthens the parent-infant relationship, helping to form a loving bond which is crucial for a child's future well-being.

OBJECTIVES AND ACTIVITIES

Significant activities

This year has brought unprecedented challenges in the Covid-19 pandemic and repeated lockdowns. Parents and families needed more in-depth and longer term support in the face of isolation and losing access to support networks and services. Referring partners in health and children's services needed to refer more families experiencing crisis as a result of the pandemic.

We increased access to parent infant psychological therapies and support throughout the year, with emergency Covid-19 funding from National Lottery Community Fund and Sussex Community Foundation. This enabled us to run an increased service within our Covid Family Support Project. We switched to remote telephone, online and video calling support in the first lockdown, and retained face to face provision for families where in-person support was crucial, using outdoor and socially distanced meetings and working in line with government guidelines.

We were particularly pleased that our 'Mellow Bumps' group intervention was pioneering for practice UK and internationally as it was adapted for the first time online by our practitioner who was about to run her first group starting at the end of March 2020 when lockdown began. We have seen high levels of engagement online with four groups running in this year and excellent feedback. The group runs for 6 weeks, 2 hours each week to support pregnant women with particular social and health vulnerabilities, and results in decreased stress levels and increased attachment and bonding.

We have delivered commissioned specialist parent infant psychological therapy to families referred by Brighton and Hove Local Authority Children's Services through a pilot project helping families on the edge of Care. The majority of families helped through this project now have a decreased level of risk and child protection concern, having had their Child Protection Plan reduced or removed.

In total we helped 114 families, which is a reflection of more than a fivefold increase of referrals on the previous year. We have also been successful in proposing a new pilot project to deliver Attachment and Bio-behavioral Catch-up (ABC) method intervention, the first project of its kind in the UK with grant funding from the Winston Churchill Memorial Trust Activate Fund.

Feedback from families and referrers on the Covid family support project

'A brilliant service which was very helpful.'

'It was amazing and I feel like [practitioner] really saved my life.'

'I was so anxious.. I was having endless panic attacks. [practitioner] made me realise it was normal to feel like that after a baby and as a result the panic attacks totally died down. I honestly don't know if I would be here if it wasn't for her.. She really went above and beyond'.

'I just really needed some help. It gave me a load of support'.

We've also had positive feedback from referring partners:

'It is an excellent, much needed service. The therapists are very supportive and the women I refer feel they can open up much more'.

'Helpful, experienced, empathic and friendly'.

'All the parents (mostly mums) that I have referred have been really positive and have felt it was a big help to them at a difficult time'.

Feedback from families on the online Mellow Bumps group:

'The more you open up, the more you will gain. You aren't alone and you'll realise that the further the group progresses. Not sure what I would have done without this reliable group at the moment'

'Using the group has helped me connect with other women in a similar situation to me in a much more deep and meaningful way than I expected'.

'It has helped my birth journey hugely and been a consistent and grounding source of support for the past 6 weeks on a practical and an emotional level, as well as offering me a space to bond with my peers where I feel I have made some genuine friendships That I will go on to treasure'.

'I feel that I would have benefited from this in usual circumstances, but during this unusual period through the pandemic, this group has been a lifeline and was beautifully facilitated'.

'It has been positive on so many levels and I was nervous at what to expect at first but I would say give it a try, as it was a very relaxed and safe space. We shared our feelings and concerns, gained practical knowledge as well as some lovely stories and laughs. This group has turned out to be a very special part of my pregnancy journey'.

Feedback from families and referrers on our Social Care commissioned work:

'Ok, so my client, the one who worked with (BrightPIP practitioner) was diagnosed with EUPD and had a lot of awful trauma. She was very vulnerable, and the local authority was going to put her through court to potentially lose her second child. She was vulnerable and it was really knife edge. She now has insight into her own behaviour, and strategies on how to deal with things when they happen and she said to me this morning actually 'I feel like I'm living a new life'. This is largely due to (practitioner) and BrightPIP. It's brilliant. I'm signing her off soon, she doesn't need me any more. It's really brilliant'

' My client is a very isolated young mum who struggles with her mental health due to childhood trauma. She has struggled to engage with any counselling or therapy since leaving care but has found Bright PIP supportive and helpful'

'(My client) found it very helpful, as he could sometimes be difficult - so I found it an enormously supportive experience'

'it was really good. (practitioner) was very understanding and picked up on a lot of stuff that me and my partner hadn't noticed'.

'Honestly - I just wish I knew about it sooner. I would have been able to put it in earlier. It was recommended to me by (Social Worker) at EPAP. It was so helpful with my mental health issues'

'I did struggle to see the point of it at the beginning - it was only after sticking with it that I realised the power of what (practitioner) does. It has been a lot more helpful than I thought it would be'

Public benefit

The trustees confirm that they have referred to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the charity's aims and objectives and in the planning of future activities.

FINANCIAL REVIEW

Financial review and reserves policy

During the year the charity made a surplus of £12,501 on unrestricted funds which was added to reserves brought forward of £5,236 making a total of £17,737. The charity has a reserves policy which aims to hold at least three months running costs at any one time. In the reporting year the charity met its budget objectives set in the previous year and continued to remain robust despite the difficult financial climate in which it operated.

The principal funding sources for the reporting year are shown in note 3.

FUTURE PLANS

In the next year, we will continue to work towards sustainable growth and providing a city-wide service across Brighton and Hove to meet the needs of local families.

We will build on this year's success in developing diverse funding sources through grant funding, fundraising and service commissioning, and embedding service development through our newly funded Service Development Manager role.

We will also continue to grow and develop the Trustee Board with addition of members with skills and experience in human resources and finance, strengthening BrightPIP's governance and sustainability for the long term.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

Brighton PIP Ltd is a company by Guarantee governed by its Memorandum and Articles of Association dated 14 March 2016 as amended 7 February 2017 and 23 January 2018. It is registered as a Charity with the Charities Commission registered from 9 February 2018.

Brighton PIP Ltd took over the activities of Brightpip CIC (registered number 8356566) on 1 April 2018.

Organisational structure

Day-to-day management of the charity is undertaken currently by founder and Clinical Director Kerry Taylor, with regular reporting and consultation with the Directors of the charity. The processing of referrals of families, direct clinical work, supervision of clinical work, consultation to local frontline professionals and internal audit and processing of outcome data are overseen by Kerry Taylor with some administrative support.

Strategic development of the organisation is overseen by Sarah Andersen. Marketing and communications are overseen by Suzie van der Westhuizen. Charity fundraising and development is overseen by Beccie D'Cunha. Governance and safeguarding are overseen by Lucy Powling. Monthly book keeping is overseen by Lee-Ann Pert at Accountancy 360.

Decision making

The directors shall manage the business of the charity and may exercise all the powers of the charity unless they are subject to any restrictions imposed by the Companies Act, the articles or any special resolution.

The first directors shall be those persons notified to Companies House as the first directors of the charity. Subsequent directors may be appointed by ordinary resolution by the charity.

The directors may delegate any of their powers or functions to a committee of two or more directors but the terms of any delegation must be recorded in the minute book.

NOTES TO THE FINANCIAL STATEMENTS
FOR THE YEAR ENDED 31 MARCH 2021

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS102, have been prepared in accordance with the Charities SORP (FRS102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS102) (effective 1 January 2019)', Financial Reporting Standard FRS102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

The accounts are prepared in sterling, which is the functional currency of the charity. Monetary amounts in these financial statements are rounded to the nearest £.

The trustees/directors consider that there are no material uncertainties about the company's ability to continue as a going concern. The trustees have taken advantage of the various sources of Government support during the COVID-19 pandemic and consider that it will not have a significant impact on the company's ability to continue trading. Income from trading activities is expected to reduce due to the lockdown conditions and steps are being taken to make cost savings. The trustees regard any impact to be short term rather than affecting the company's ability to continue as a going concern. There are no material uncertainties affecting the current year's accounts.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Taxation

The charity is considered to pass the tests set out in Paragraph 1 Schedule 6 Finance Act 2010 and therefore it meets the definition of a charitable company for UK corporation tax purposes. Accordingly the charity is potentially exempt from taxation in respect of capital gains received within categories covered by Chapter 3 Part 11 Corporation Tax Act 2010 or Section 256 of the Taxation of Chargeable Gains Act 1992, to the extent that such income or gains are applied exclusively to charitable purposes

Fund accounting

Unrestricted funds can be used in accordance with the charitable objectives at the discretion of the trustees.

Restricted funds can only be used for particular restricted purposes within the objects of the charity. Restrictions arise when specified by the donor or when funds are raised for particular restricted purposes.

Further explanation of the nature and purpose of each fund is included in the notes to the financial statements.
