Following the success of the 2019 festival, which comprised 3 weeks of arts events, the 2020 became completely virtual due to COVID. The Trustees took the decision to continue with the Arts Festival despite the challenges of COVID, on a substantially reduced basis. The Festival counted on support from its key sponsor and was able to present a series of virtual concerts, a children's harp concert and a dance performance as well as a virtual art sale. Despite the limited scope of the Festival, the Trustees consider it to have been a success in the current circumstances.
