## **A MESSAGE FROM OUR CHAIR**


In common with many other organisations, it has been a year that has been hugely impacted by the global pandemic. The restrictions caused by Covid-19 severely affected, and sometimes curtailed, much of the Foundation's planned activities, both in terms of projects and fundraising.

Elsewhere, our Eyes On Hands On programme, supported by Annington Homes, was temporarily suspended and then resumed with the Eyes On element only, allowing volunteers to check the condition of scattered graves and report back on any concerns. Happily, volunteer numbers and commitment remained high, and we look forward with optimism to resuming the programme fully.

Similarly, with our other main volunteering project, the Kantor Speakers Programme, we were able to adjust our recruitment and training to be delivered remotely via e-learning and even begin delivering some virtual talks by the end of the year. We have recruited over 227 fully trained volunteers and again look forward immensely to these being able to get out and about to talk about the work and history of the Commonwealth War Graves Commission, and share some of the moving and inspiring stories of sacrifice with new audiences and generations.

Membership numbers continued to grow apace, increasing by 48% over the year, and plans are now in place for some brand new fundraising events and activities in the coming year.

Finally, I would like to record my thanks to all those who have supported the Foundation as volunteers, members and donors in the past year, and I would also like to thank our dedicated Trustees, who freely give their time and expertise to provide the requisite governance and strategic oversight to ensure we operate effectively.

### Introduction

The Trustees present their report and accounts, for the Foundation's fourth operational year, ending on 31 March 2021.

### Structure and Governance

The Commonwealth War Graves Foundation ("the Foundation" or "CWGF") is a Charitable Incorporated Organisation (CIO), governed by its Constitution, as registered on 8 March 2017 and subsequently amended on 6 May 2017. The Foundation is registered with the Charity Commission of England & Wales (charity registration number 1171947). The Foundation has also established and registered branches in: Belgium (enterprise number 0689.789.289), and in France (Siret number 850 666 645 00013), governed under the same constitution.

The Commonwealth War Graves Commission ("the Commission" or "CWGC"), an organisation established by Royal Charter in May 1917, is the sole member of the Foundation. The Foundation is a subsidiary of the Commission. The Commission is not a charity as its purposes are not exclusively charitable.

Members of the Foundation's Board of Trustees are appointed by the Commission; the majority of the Foundation's Trustees are not Commissioners. The Foundation's Chief Executive also serves as the Commission's Director General.

Four (virtual) Trustee meetings took place during the year.

New Trustees' induction is provided by meetings with the Foundation's Chief Executive alongside meetings with members of the Commission's senior management team.

### Objectives and activities

The objectives of the Foundation are:

- (a) To promote and support the maintenance and upkeep of graves, cemeteries, buildings and memorials for the burial and commemoration of members of the naval, military and armed forces from countries of the Commonwealth who were killed during the First World War or the Second World War anywhere in the world, in particular (but without limitation) through the support of charitable activities undertaken by the Commonwealth War Graves Commission;
- (b) To advance citizenship among the people of the Commonwealth through the commemoration of members of the naval, military and armed forces from countries of the Commonwealth who were killed during the First World War and the Second World War; and
- (c) To advance the education of the public, especially young people, in the history of the First World War and the Second World War. In particular (but without limitation) through advancing education in the lives of those commemorated by the Commonwealth War Graves Commission and in the history of the cemeteries, buildings and memorials maintained by the Commonwealth War Graves Commission.

The Foundation's strategic objectives are:

- the building of public engagement programmes engaging the wider community in the story of our common sacrifice and shared history initially focussed around sites and war graves in the UK;
- the creation of educational resources and a programme of educational support and activities; and
- the development and sponsorship of internship programmes for youth guides from the Commonwealth, at the Commission's main sites in Belgium and France.

The Trustees confirm that they have referred to the guidance published by the Charity Commission in regard to public benefit when reviewing the Foundation's objectives and planning future activities.

### **COVID 19 and Activities and Achievements**

The COVID-19 pandemic has adversely impacted the execution and achievement of much of the year's business plan objectives. The PGCE Teacher Training Project and the International Schools Commemorative project were both effectively suspended as potential partners and stakeholders were wholly focussed on dealing with COVID-19 and its impacts. Planned participation at the Chalke Valley History Festival also had to be cancelled. Retailing activity was well below the planned level due to the closure of the Commission's visitor centres in Ieper and Beaurains. The COVID-19 pandemic will likely make fundraising more challenging as both individuals and foundations are focussing on pandemic-related causes. The Trustees will continue to monitor the situation and its impact both financially and on the Foundation's ability to deliver the 2021-22 business plan.

Nevertheless during its fourth year of operations the Foundation made progress in the following areas:

- Refreshed and renewed its membership programme growing its Supporter Scheme numbers from 973 to 1,407.
- The Kantor Speakers Programme recorded 227 approved and trained volunteers against the target of 240 volunteers. These speakers delivered 43 talks (online) to 30 groups.
- A digital version of the Noor Inayat Khan exhibition, celebrating the life of Special Operations Executive Noor Inayat Khan, which had been launched physically the previous year at the Runnymede Memorial, transitioned online and has subsequently been widely downloaded. This exhibition was delivered with the Commission and funded by Biffa through a scheme operated by the Association of Independent Museums.
- Volunteering work on the "Eyes On Hands On" project ('EOHO') resumed in October 2020 having been suspended during the first half of the year due to Government restrictions on social distancing. This project, delivered in conjunction with the Commission, encourages volunteer grave care activity at the Commission's more remote and scattered UK sites. The initial focus of the 1,610 volunteers who have been recruited, has been "Eyes On" i.e., "inspecting and reporting". This has resulted in the inspection of 28,748 headstones across 3,438 scattered sites: this has led to the identification of 602 items requiring remedial action, including isolated graves and church signs, of which 227 had been undertaken by CWGC staff by March 2021.
- The Flowers of Remembrance Seeds campaign (part of the CWGC's War Graves Week) launched in January and raised £7,000 for the Foundation.

- The Foundation depends on the support from the Commission, the Commission's volunteers and its own volunteers for their dedication and commitment to the delivery of the charitable activities. In the year, 1,655 volunteers gave their time and energy, an estimated 4,821 hours, with an estimated value of £42k.

### **Business Plan 2021-22**

The Foundation's key deliverables in 2021/22 are planned to include:

- Further improvements in engaging with supporters and growing membership, in order to fund the running costs of the Foundation.
- Recruitment and training target of 2,000 volunteers for the "Eyes On Hands On" project which will provide coverage of between 75-80% of scattered graves in the UK. Volunteers will commence "hands on" grave maintenance following appropriate training.
- Increasing the Foundation's fundraising efforts by: the recruitment of a full-time fundraiser; participating at the Commission's War Graves Week; and, successfully applying for a BBC Broadcast appeal slot.
- *In the Footsteps of our Forces*, a joint fundraising partnership event with The National Museum of the Royal Navy, National Army Museum, and Royal Air Force Museum, for a joint fundraising event planned as an Armed Forces Day sponsored walk that will encourage engagement with the stories of service personnel, memorials and war graves across the country.
- Trialling the Foundation's own first virtual fundraising event using a virtual map to recreate a 100-150km walk through northern France taking in some of the iconic CWGC sites and memorials. Each milestone on the walk will result in registrants receiving bespoke information about the particular CWGC site or memorial and learning of some of the casualty stories. Participants will pay to register and can raise additional sponsorship if they wish.
- The development of a new website and a review of the Foundation's branding with the purpose of bringing it closer to the Commission's branding, ensuring they are more clearly connected and complementary.
- Further developing income streams from donations, and surpluses from the sale of merchandise at the Commission's Ieper Information Centre and French Visitor Centre.

### **Volunteers policy**

The Foundation encourages, welcomes and recognises volunteers. They fulfil a variety of roles including: acting as our eyes and ears on the ground for the "Eyes On Hands On" project; educating and informing the wider public on the Commission's work having received training funded by Kantor; and supporting core Foundation activity by freely lending their time and skills.

### **Remuneration policy for key management personnel**

The Foundation's key management comprises the Trustees, the Chief Executive and the Executive Director; however, Trustees are unpaid, and the Chief Executive is not remunerated by the Foundation. During the year under review the Foundation had just three employees, two of whom were employed on fixed term contracts. The Foundation's approach and policy on remuneration follows that of the Commission, which is that remuneration levels are in line with median market pay data for the not-for-profit sector as established from salary survey and benchmark data. The Commission agreed that during the Foundation's start-up period that it

would provide back-office support free of charge. During this period the Foundation's administrative activities were undertaken by a Commission staff member.

### Top Risks and Mitigation

The Foundation maintains a register of risks and their mitigation. Risks are categorised as Operational, Reputational, Financial, or COVID-19; mitigation measures are identified for each one. This register is monitored by management and the Trustees to ensure it is kept relevant and up to date.

The top risk under each category is:

Operational: Overcommitment on project activity before funds are received – which is mitigated through business planning, comprehensive project management and KPI measurements.

Reputational: Threat of cyber security breach/hacking/website malfunction - mitigated through staff training, internal IT expertise and resources, clear reporting guidelines.

Financial: Insolvency – mitigated by having a reserves policy, financial controls and reporting.

COVID-19: Funders' priorities change (short-term) and fundraising income affected by closures, delays and recession. These are mitigated by pre-planning so that projects are primed to start when restrictions allow, preparing funding proposals, and assessing new funding opportunities and streams.

### Reserves

The Foundation's reported reserves at 31 March 2021 were £413k, but £312k of the reserves relate to restricted activities resulting in free and unrestricted reserves amounting to £102k.

The Foundation has set a reserves target of £48k of unrestricted reserves. This level of reserve is considered sufficient to cover the costs arising on the windup of the Foundation and would:

- Cover the redundancy costs of the Foundation's employees; and
- Make provision for early termination of any other contracts currently in place.

At March 2021, available unrestricted reserves of £102k exceed the target of £48k by 113%.

### Financial results for the year ended 31 March 2021

The Foundation's income was £567k comprising unrestricted income of £213k and £354k of restricted income. Over 75% of unrestricted income, £164k, came from donations and legacies with the remainder from the Supporters' Scheme, £41k, and trading income from retail activities of £8k. Restricted income comprised £335k of donations from Annington for the Eyes On Hands On project and grant funding and contributions of £18k in respect of the Noor Khan project.

Costs of £251k were incurred. Key expenditure items were: grants of £50k to the Commission to fund the Eyes On Hands On project; staffing costs of £116k; £9k for merchandising costs and supporter scheme costs, along with £36k incurred on marketing and professional costs.

The outcome was a surplus of £316k (2020 - £3k). The surplus on unrestricted activities was £67k (2020 - £1k) and the surplus on restricted activities was £249k (2020 - £2k). An increase in unrestricted legacy income is the main factor in the year-on-year increase in the unrestricted surplus, and the increase in the surplus on restricted activities reflects timing differences on expenditure whereby restricted income received in respect of Eyes On Hands On, is not now anticipated to be spent until 2021/22.

The intergroup balance (net) between the Commission and the Foundation was £0.4k at the year-end (2020 £40k).

The balance sheet stock value of £14k comprised gift items, books, maps and pins. A provision has been made for slow-moving stock.

Bank balances at the year-end were a healthy £415k (2020 -£152k) of which 77% related to restricted activities.

The 2021/22 budget anticipates a loss of £285k for the Foundation which will be funded from the Foundation's restricted and unrestricted reserves.

The Trustees are responsible for preparing the Trustees' Annual Report and the financial statements in accordance with applicable law and regulations.

- state whether applicable UK Accounting Standards have been followed, subject to any material departures disclosed and explained in the financial statements;
- prepare the financial statements on the going concern basis unless it is inappropriate to presume that the charity will continue in business.

The Trustees are responsible for keeping adequate accounting records that are sufficient to show and explain the charity's transactions and disclose with reasonable accuracy at any time the financial position of the charity and enable them to ensure that the financial statements comply with the Charities Act 2011, the Charity (Accounts and Reports) Regulations 2008 and the provisions of the trust deed. They are also responsible for safeguarding the assets of the charity and hence for taking reasonable steps for the prevention and detection of fraud and other irregularities.

### **Disclosure of information to auditor**

The Trustees confirm that:

- so far as each Trustee is aware, there is no relevant audit information of which the charity's auditor is unaware; and
- the Trustees have taken all the steps that they ought to have taken as Trustees in order to make themselves aware of any relevant audit information and to establish that the charity's auditor is aware of that information.

## Opinion

We have audited the accounts of Commonwealth War Graves Foundation (the 'charity') for the year ended 31 March 2021 which comprise the statement of financial activities, the balance sheet, the statement of cash flows, the principal accounting policies and the notes to the accounts. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' (United Kingdom Generally Accepted Accounting Practice).

In our opinion, the accounts:

- ◆ give a true and fair view of the state of the charity's affairs as at 31 March 2021 and of its income and expenditure for the year then ended;
- ◆ have been properly prepared in accordance with United Kingdom Generally Accepted Accounting Practice; and
- ◆ have been prepared in accordance with the requirements of the Charities Act 2011.

## Basis for opinion

We conducted our audit in accordance with International Standards on Auditing (UK) (ISAs (UK)) and applicable law. Our responsibilities under those standards are further described in the auditor's responsibilities for the audit of the accounts section of our report. We are independent of the charity in accordance with the ethical requirements that are relevant to our audit of the accounts in the UK, including the FRC's Ethical Standard, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

## Conclusions relating to going concern

In auditing the accounts, we have concluded that the Trustees' use of the going concern basis of accounting in the preparation of the accounts is appropriate.

Based on the work we have performed, we have not identified any material uncertainties relating to events or conditions that, individually or collectively, may cast significant doubt on the charity's ability to continue as a going concern for a period of at least twelve months from when the accounts are authorised for issue.

## **Other information**

As explained more fully in the Trustees' responsibilities statement, the Trustees are responsible for the preparation of the accounts and for being satisfied that they give a true and fair view, and for such internal control as the Trustees determine is necessary to enable the preparation of accounts that are free from material misstatement, whether due to fraud or error.

In preparing the accounts, the Trustees are responsible for assessing the charity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Trustees either intend to liquidate the charity or to cease operations, or have no realistic alternative but to do so.

## **Auditor's responsibilities for the audit of the accounts**

Our objectives are to obtain reasonable assurance about whether the accounts as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise

from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these accounts.

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The extent to which our procedures are capable of detecting irregularities, including fraud is detailed below:

- the engagement partner ensured that the engagement team collectively had the appropriate competence, capabilities and skills to identify or recognise non-compliance with applicable laws and regulations;
- we obtained an understanding of the legal and regulatory frameworks that are applicable to the charity and determined that the most significant frameworks which are directly relevant to specific assertions in the financial statements are those that relate to the reporting framework (Statement of Recommended Practice: Accounting and Reporting by Charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the United Kingdom and Republic of Ireland (FRS 102) and the Charities Act 2011) and those that relate to data protection (General Data Protection Regulation).
- identified laws and regulations were communicated within the audit team regularly and the team remained alert to instances of non-compliance throughout the audit.

We assessed the susceptibility of the charity's financial statements to material misstatement, including obtaining an understanding of how fraud might occur, by:

- making enquiries of management as to their knowledge of actual, suspected and alleged fraud; and
- considering the internal controls in place to mitigate risks of fraud and non-compliance with laws and regulations.

To address the risk of fraud through management bias and override of controls, we:

- performed analytical procedures to identify any unusual or unexpected relationships;
- tested journal entries to identify unusual transactions;
- assessed whether judgements and assumptions made in determining the accounting estimates were indicative of potential bias;
- used data analytics to investigate the rationale behind any significant or unusual transactions;
- tested authorisation controls on expenditure items, ensuring all expenditure was approved in line with the charity's financial procedures.

There are inherent limitations in our audit procedures described above. The more removed that laws and regulations are from financial transactions, the less likely it is that we would become aware of non-compliance. Auditing standards also limit the audit procedures required to identify non-compliance with laws and regulations to enquiry of the Trustees and other management and the inspection of regulatory and legal correspondence, if any.

The principal accounting policies and judgements used in the preparation of the financial statements are:

### **Basis of Accounting**

The Trustees' Report and accompanying financial statements have been produced in accordance with the Accounting and Reporting by Charities: Statement of Recommended Practice (SORP), applicable to entities preparing their financial statements in accordance with FRS102, and applicable United Kingdom Accounting Standards (United Kingdom Generally Accepted Accounting Practice (GAAP) including FRS102). The Foundation meets the definition of a public benefit entity under FRS102. The functional currency is sterling.

The Commonwealth War Graves Commission is the sole member of the Commonwealth War Graves Foundation (Registered charity number 1171947). These financial statements are therefore also consolidated in the results of the Commission on a line by line basis.

### **Going Concern**

The financial statements have been prepared on a going concern basis. The Foundation's financial statements are in a net asset position of £413.5k at 31 March 2021 (2020 - £97.8k). The net intergroup balance owed to the Commission has fallen to: £0.4k owed to the Foundation (2020 -£39.9k owed to the Commission). The Foundation currently has cash balances of £415.1k (2020 -£151.8k) which will cover its grant activities and general running costs in 2021-22. The Foundation expects its membership, donations and other income to both continue and grow over the medium term, as the charity increases its ability to both identify and attract new sources of grant and charitable funding. If required, the Foundation can also draw down additional funding from the Commission's agreed loan facility of £500k in place until 2023. On this basis, the Foundation is considered to be a going concern for a period of at least 12 months from the date of approval of these financial statements.

### **Fund accounting**

The Foundation holds unrestricted and restricted funds.

Unrestricted income funds comprise those funds which the Trustees are free to use at their discretion in furtherance of the objectives of the Foundation.

Restricted funds are subject to specific restrictions imposed by the donors.

### **Income recognition**

Income is recognised once the Foundation has entitlement to the income, it is probable that the income will be received, and the amount can be measured reliably.

### **Donations**

Donations received are recognised once the Foundation has entitlement to the income, it is probable that the income will be received, and the amount of income receivable can be measured reliably.

### **Supporter membership scheme income**

Income from the supporters' membership scheme is treated and recognised as a donation when the amount of income receivable can be measured reliably.

### Donated services, facilities and goods

The Foundation receives services, facilities and goods free of charge in support of its finance, human resources, legal, management and operational activities.

Donated services and facilities are shown as donations in kind and recognised in income with an equivalent amount recognised as an expense under charitable costs. The valuation attributed to these donations is as follows: the Foundation has been allocated 5% of the running costs of both the Ieper Information Centre and the Beaurains Visitor Centre and 0.5% of CWGC's total back-office support costs and 100% of staff support costs. Donations of book stocks from the Commission are recognised in the period that they are received.

The value of time given by volunteers is not included in the Income Statement as their contribution to the Foundation cannot be reasonably quantified in financial terms. During 2020/21, the Foundation used volunteers to educate and inform the wider public about the Foundation and the Commission's work, and to support the Eyes On Hands On project.

### Grant Funding

Funding from organisations supporting the Foundation's objectives is treated as restricted funds and shown separately in the statement of financial activities as this is mandated by the grant agreements. The full income is recognised in the year in which the Foundation becomes fully entitled to receive it.

In the event that a donation or grant is subject to conditions, the income is deferred and not recognised until either those conditions are fully met, or the fulfilment of those conditions is wholly within the control of the Foundation and it is probable that those conditions will be fulfilled.

### Recognition of expenditure

All expenditure is accounted for in the statement of financial activities on an accruals basis.

### Classification of expenditure

The Foundation's expenditure is analysed between fundraising costs, charitable activity costs and other expenditure.

### Expenditure on raising funds

Expenditure on raising funds includes the costs to manage the supporter scheme, marketing and promotion costs to raise income, other direct costs attributable to raising funds including a portion of the donated in-kind support cost from the CWGC.

### Expenditure on charitable activities

Expenditure on charitable activities includes: all expenditure directly relating to the charitable activities of the Foundation; resources expended on managing and administering the charity; the direct cost of delivering the charitable activities; grants payable; and a portion of the donated in-kind support cost from the CWGC.

The support donated in kind from CWGC comprises management, finance, human resources, legal and marketing services. Staff support is provided free of charge whilst the Foundation continues to establish itself, in the UK, Belgium and France.

### Governance costs

Governance costs represent direct expenditure incurred by, or on behalf of, the Foundation, for external audit and legal costs.

### Other expenditure

The expenditure within other gains and losses relates to exchange differences.

### Inventory

Cost for the stock of merchandise is included in current assets. Merchandise, directly purchased by the Foundation's Belgian and French branches, is valued at cost. The Commission's historic stock of books and maps has been donated to the Foundation free of charge.

### Provisions

Provisions for future liabilities are recognised if there is a legal or constructive financial obligation that can be readily estimated and for which there is a reasonable expectation that payment will be made.

### Foreign currencies

Transactions in foreign currencies are translated at the monthly average exchange rate. Currency balances at the year-end are translated at the year-end rate. The net exchange loss was £477 (2020 – gain of £616).

### Operating leases

The Foundation currently has no operating leases. Rent is not currently charged for Foundation engagement activities conducted at Commission locations, i.e. the Ieper Information Centre and French Visitor Centre. The use of the Information and Visitor Centres is donated in kind by the Commission and is accounted for under donations and expenditure in kind.

### Value Added Tax (VAT)

The Foundation's trading activities have not yet reached the VAT thresholds in the UK, France or Belgium and therefore it is not currently required to register for VAT.

### Restricted funds

The Foundation's financial statements include restricted funds for grant activities.

### Significant estimates and judgements

#### Estimates

Where contractual revenue cannot be allocated with certainty, but is related to the current financial period, an estimate of the income is booked within the financial statements based on the anticipated completion value. Costs are allocated on an accruals basis for costs incurred within the current financial period.

#### Judgements

Membership income is recognised in the month it is received rather than being amortised over the twelve-month subscription period. This revenue recognition approach has been adopted because the membership fee is in substance a donation and no substantive benefits accrue to members and no refunds are made.

### 15 Support services and facility costs (continued)

Support costs reflect the services donated in kind by Commission staff for administration and management of back-office functions, estimated at 0.5% of Commission Departmental costs and 100% of staff costs directly attributable to administration of the supporter scheme. Facility costs relate to the Foundation's estimated share, 5%, of the running costs of the Belgium Information Centre and the France Visitor Centre donated in kind by the Commission.

### 16 Related party transactions

The ultimate parent company and controlling party is the Commonwealth War Graves Commission. The largest and smallest group of which the charity is a member and for which group consolidated statements are drawn up is headed by the Commonwealth War Graves Commission. Copies of these consolidated accounts are available on request by writing to the Foundation's registered address.

The Commonwealth War Graves Foundation, has as its sole member the Commonwealth War Graves Commission. Material transactions with the Commission comprised:

- A recharge from The Commonwealth War Graves Commission of direct costs amounting to £8.3k (2020 - £17k).
- £0k (2020 - £0.3k) and £1.8k (2020 - £1.6k) worth of books were donated to the Belgian branch for retailing at the Ieper Information Centre and to the French branch for retailing at the Visitor Centre, respectively.
- The Commonwealth War Graves Foundation owed the Commonwealth War Graves Commission £65.3k (2020 - £82k) at the year-end. The Commonwealth War Grave Commission owed the Commonwealth War Graves Foundation £65.7k (2020 - £42k) at the year end.
- Back office support and services donated by the Commission to the Foundation free of charge, whilst the Foundation continued to establish itself, were valued at £53k (2020 - £22k).
- Lady Lucy French, a Trustee of the Commonwealth War Graves Foundation, is also a Trustee of "Never such Innocence" a charity which aims to give children and young people across the world a voice on war and conflict. Books published by Never such Innocence are retailed by the Foundation at cost price – the total value of the books sold during the year was £nil (2020 - £382).
- In the year, one Trustee was a standard member with a total value of the donation received of £30. Thirty two memberships were purchased, at a cost of £1,152, as gifts for friends, by a Trustee during the year. In 2020 three Trustees were standard members with a total value of donations received amounting to £90.

### 17 Post Balance Sheet Events

Subsequent to the year-end the funding facility granted by the Commission to the Foundation was extended by two years both in terms of the drawdown period, which was extended to March 2023, and the repayment period, which was extended to March 2025.
