Para 1.17 and 1.19	<p>Continued funding of the running costs of Soma Leo Nyiera Academy in Kenya, which we established in 2015.</p> <p>The school provides education, support and nourishment for significantly disadvantaged young children in its community. The school is established as an early years' pre-primary and primary - registered as a primary school regulated by the Kenyan Ministry of Education.</p> <p>During 2021 the school had approximately 200 pupils. The school is non-denominational, with the poorest children from the local community attending.</p> <p>Through a Trustee visit in February 2020, and through regular communication with key stakeholders in Kenya, the Trustees are satisfied that our objectives and activities are in line with Soma Leo's stated purpose and in accordance with the public benefit requirements of the Charity Commission.</p> <p>Clean water and nourishment are a key component for the public benefit provided, helping the children to be healthy and have the energy to learn. The school and our resources</p>

		provided a safe and caring environment for the education and care for our pupils.

Para 1.20	<p>Following 2020's extensive Kenyan government mandated school closures, 2021 was an intense period in the classrooms' with the completion of 2020 curriculum in the early part of the year.</p> <p>By retaining our teachers throughout 2020 and supporting our learning community outside school during closures our children adapted well to the return to school and progressed through the 2021 curriculum in accordance with the government's timetable.</p> <p>We continued to fund Covid mitigation measures to keep the school a safe environment for pupils and teachers and have made infrastructure improvements in accordance with changing guidelines from the Ministry of Education.</p> <p>We have also funded new curriculum books for the children and new uniforms for some pupils.</p> <p>Having facilitated Samwel Manda, our key stakeholder in Kenya, moving to the Nyiera area we now benefit from greater levels of understanding of the priorities at the school, effective implementation of solutions and higher levels of engagement with our beneficiaries.</p>

Statement explaining the policy for holding reserves stating why they are held	Para 1.22	<p>The Trustees recognise that funds received (income) will vary greatly on a month by month (and yearly) basis as such a significant proportion is generated from one-off events. As such Soma Leo will continue to build and hold short term reserves to cover known or anticipated future expenditure, which may include one-off costs for building development work. We have no policy on building and holding reserves beyond this approach to establish reserves in order to afford desirable future expenditure that adds to the public benefit.</p> <p>Significant reserves established in 2019 were used in part to off-set the lack of fundraising events and activity during 2020 due to Covid-19. These reserves have been re-established during 2021.</p>





