Annual Report for Financial Year Ending 31st March 2021

The Charity was established in 2009, to distribute basic food and household supplies to people in need within Farnborough Hampshire. It is managed by a board of Trustees and advised by the Trussell Trust. The Board during the current period are :-

The Charity does not employ any staff, relying on efforts of some 22 volunteers to operate its services. The volunteers contribute 10 hours per week to distribute supplies to 150 people in need. Stocks of supplies are kept in a warehouse at Browning Barracks, Alison Road, Aldershot, rented under a lease renewable every 2 years, with a beneficiaries' local collection point at St Christopher's Church, Cove, Farnborough.

The Trustees regularly review the safety of and risks to volunteers and beneficiaries. They manage the donated and purchased supplies, controlling the finances to maintain the food deliveries.

At the start of our year, April 2020, the Foodbank was presented with an unprecedented challenge. The national lockdown, announced by the government only one week previously, meant that we were compelled to review, and amend as necessary, our operational practices. Our small band of volunteers, working many extra hours, found themselves engaging in social distancing and working in rotas to ensure we complied with the newly imposed laws and guidelines. However, the call on our services did not diminish and in fact did exactly the opposite. This situation persisted throughout 2020 and into 2021, and we are proud that, in spite of the severe restrictions imposed on us, we were able to provide food to the needy of the local area.

Within a very short time of the original lockdown decree, our donated income began to increase rapidly and this continued throughout the year. This was assisted by two large corporate donations, details of which are shown in the notes to the accounts. There was also a very significant increase in the donations arriving from donors via the Just Giving organisation. This increase in our income has created enough reserves to ensure the Foodbank's continued operation for several years hence. We are also extremely grateful to all the local supermarkets and shops for continuous food supplies.

Finally, in an effort to contribute towards the government's pollution reduction initiatives, we exchanged our diesel powered delivery vehicle for a new electric one. The added benefit is also to reduce our vehicle running costs.

We can therefore look forward to providing food, and thus assisting the relief of poverty in the Farnborough area.

Reserves Policy

The Trustees consider that there are sufficient reserves for the Foodbank to continue operating for the next six years.
