
During the period 1 April 2020 to 31 March 2021, Inclusive Mosque Initiative (IMI) has continued to address the injustices that our community faces. We had to pause some of our work and rethink the logistics of delivering our activities through the Covid 19 pandemic. We did this by providing safe and inclusive places for community gathering, spiritual practice and activism. We tested and delivered our events online. We have continued our work with the LGBT+ sector to raise consciousness of how racism manifests so that LGBT+ Muslims may access more and better resources. During this period, we focused on supporting efforts to increase funding in the LGBT+ sector by working in collaboration with fund designers. This work benefits LGBT+ organisations for people of colour, especially Muslims, as funding streams can now be designed with better knowledge of race and the impact of racism in funding.

We have used our role as a feminist, LGBT+ inclusive Muslim organisation to promote justice through feminist principles which extend safety and dignity to all people. We have done this by hosting townhalls on shifting government policy and discourse, in particular The Sewell Report and its impact. This work benefits people of colour and workingclass people in particular, who will feel the negative impact of The Sewell Report.

We have continued to conduct Islamic marriage ceremonies for couples who are usually turned away from mosques including Muslim women marrying non-Muslim men and LGBT+ couples. This gives Muslim women, genderqueer, trans and nonbinary Muslims access to support and services we would usually be denied without the existence of Inclusive Mosque Initiative. This was a particularly difficult service to provide during 2020 and 2021 with the pandemic requiring us to move the service online at times of the year and offer it in person at other times.

We have successfully built better links between IMI and other Muslim organisations that share our aim of tackling issues of social, economic, and political injustice, promoting the welfare of all people. This work is strategic and necessary for our work to impact the wider Muslim community, and for the longevity of anti-racist resistance work.

With the support of our volunteers and Imams we were able to run a full Ramadan programme of events in April-May 2020. The pandemic has marginalised our communities further and being able to gather online has provided much needed support. We were able to convene space for marginalised Muslims to gather with each other in support, solidarity, and worship during a particularly trying time.

The last period has been a time of organisational development for IMI. We spent time and resources exploring the questions 'How do we do here what we are seeking to do in the world?' – Adrienne Maree Brown. We reassessed the support we provide to our volunteers and how we can ensure a healthy organisational culture for our staff and volunteers. We have increased HR support and improved our policies relating to staff and volunteers. This organisational development has helped us to better live by the values we seek to promote and carry out our work with integrity.

Achievements and performance

Our standout event of the period was our Ramadan programme which we managed to deliver online, maintaining our standard of accessibility for disabled people. We demonstrated interdependent ways of working with our volunteers and Imams and modelled the kind of inclusive approach to spirituality and ritual we would like to see adopted by other mosques. This year, our Ramadan programme developed our understanding of our community, their needs and best ways to communicate with each other. We are in a solid position to develop our programming from our learnings this year. This will positively impact those who struggle to access our work online.

We also ran regular Tajweed classes for our Imams, which has greatly improved the quality of the services we offer and provided a space for learning and training in Islamic principles of inclusion that welcomes women and LGBT+ Imams. This is a huge achievement in our mission to end discrimination, build resources for marginalised people and tackle patriarchy and queerphobia.

We built the foundations of long-lasting relationships within the LGBT+ sector, the VAWG sector and the mental health sector. These are the areas we are working in to tackle Islamophobia. Building and maintain these networks through the first year of the pandemic is a significant achievement and we have weathered major changes in funding and staff in each of these sectors. Through this, our work is reaching new audiences and skilled professionals in a position to positively change how Muslims access support in each of these sectors.

In March 2021, we planned and have since launched, a successful and ongoing fundraising campaign. At the time of writing, it has secured \pounds 4,450 from public donations unrestricted funds for our Feminist Imam Programme. This programme of work is now in development.

Overall, moving our work online since April 2020 has brought new audiences to IMI. Our community has grown in numbers and we are in a much better position that previous years to train and grow our team of volunteers.

The charity's principal source of funds is the Joseph Rowntree Charitable Trust (JRCT). Income from JRCT accounted for over 80% of the total income received by the Inclusive Mosque Initiative (IMI) from 1 April 2020 to 31 March 2021. IMI receives a quarterly grant from JRCT of £11,144. The current agreement has been in effect since 19 March 2019, on which date the Trustees of JRCT had agreed to offer IMI a grant of £133,728 for a period of 36 months (3 years). In addition to the quarterly grant, the Trustees of JRCT also offered IMI a grant of £25,000 to help the organisation adapt to the changing circumstances brought about by the COVID-19 pandemic. This one-time grant payment was received in October 2020. IMI's unrestricted income is driven by donations and by income received from community services, such as marriage officiations. IMI started conducting marriage ceremonies from July 2019, and this stream of income continued in the year ended 31 March 2021. However, there was a decrease in income generated from community services, as the number of in-person religious ceremonies and officiations dropped as a result of the COVID-19 pandemic.
