Contribution made by volunteers

The club is totally dependent on volunteers. All club members, including the trustees, are volunteers. However, with an ageing and reducing membership, the club struggles to run events without additional assistance. This comes from a pool of "Friends of Buxton Lions", including several former members, as well as individuals and organisations that have benefited from a club grant, and other local young people.

### **Achievements and Performance**

Summary of the main achievements of the charity, identifying the difference the charity's work has made to the circumstances of its beneficiaries and any wider benefits to society as a whole.

Our achievements with respect to each of our Main Activities detailed above are as follows:

- 1. The club raised £1497over the past year, mainly through direct fundraising activities but also from donations and claims. Fund raising activities were seriously curtailed by the pandemic, including the cancellation of the annual Duck Race. We undertook an unsupervised bucket collection in a local supermarket at Christmas, with an excellent display about the club and including use of our new QR Code. Organised in collaboration with the Nottingham Building Society, our "Reverse Santa" scheme elicited generous public donations of Christmas presents for less fortunate children, with the County Early Help Team and a new local group, Buxton Street by Street, arranging their distribution. Further afield, we collaborated with 5 other Lions clubs in our zone to raise £10k for the new Christie Cancer Hospital in Macclesfield; this included a virtual fun run and a commitment by our club to donate at least £1000 from our funds.
- 2. A total of £3593 was donated in support of local individuals and organisations. Beneficiaries included: a family requiring support to carpet their children's rooms; Fairfield Brass Band; a new High Peak Climate & Environment Youth Forum; and CLIC Sargent (in support of children with cancer). As a strategy to support other organisations providing vital assistance to the vulnerable, and even more so at a time of pandemic, we donated 10 sleep pods to High Peak Homeless Help. We also donated to the international appeal to support the aftermath of the Beirut explosion.
- 3. For the benefit of the community we usually organise or support various events but all were cancelled as a result of the pandemic. Members also concluded that the club no longer had the resources to run the annual Town and Community Bonfire and Fireworks but we were pleased to be able to hand it over for future years to a local community event organiser. Other community events which we usually support, including the Town Carnival in July, the local Rotary Club Bazaar and the town's Christmas Lights Switch-On in November were all cancelled as a result of the pandemic.
- 4. We actively operate a Message in a Bottle Scheme so that vulnerable people living alone have their critical medical information available in an emergency. We placed display stands of bottles in all 6 town pharmacies and also in Chapel en le Frith and Whaley Bridge.
- 5. We aim to work with local schools and ran a highly successful Art Competition with over 200 entries from all local primary and secondary schools bar two. We fund local secondary School Awards for mentoring, we assist at local school mock interviews and we involve local students as helpers in our events.

The charity's principal sources of funds (including any fundraising)	Major fund-raising events – all curtailed this year by the pandemic – usually account for most income, supplemented by donations from members and others. We were able to claim £518 from HMRC against eligible donations and we received £300 in compensation from RBS in response to our complaint about poor service.
A description of the principal risks facing the charity	A dwindling and aging membership: the club now has just six members. Recruitment strategies have so far proved ineffective.
