Report of the Trustees for the Year Ended 31 March 2021

The trustees who are also directors of the charity for the purposes of the Companies Act 2006, present their report with the financial statements of the charity for the year ended 31 March 2021. The trustees have adopted the provisions of Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019).

The Covid 19 pandemic and its global and national impact on all levels of society meant that we at Pagoda Arts needed to change our operational approach to all staff and service users. Due to the uncertainty about Covid 19 and change of regulations daily, PA had focused on community support and translated new government regulations and Covid 19 information in Chinese daily, distributed the translated information through WeChat, which have been shared to over 10,000 subscribers. All classes took places on Zoom, and our community support offer was furloughed from March - June 2020.

At the beginning of 2020, we were approached by many Chinese people reporting hate speeches directed towards them, and a worrying rise in hate related physical attacks throughout Liverpool and other cities. (this is including young people from our orchestra as young as 5). PA was looking for support from other organisations. PA has extended our network in USA, China and across the UK (both cultural and welfare events, especially in relation with Hate crime towards the ESEA community. Our new relationship with NHS England has resulted in the centre's being used for pop up covid test/vaccine centres for the community as well as helping with GP registration. Pagoda Arts has reached out to overseas students/stranded visitors, local homeless and hate crime victims. PA also helped community members reporting cases to police or sharing information through social media and zoom meetings on hate crime awareness.

OBJECTIVES AND ACTIVITIES

Significant activities

In between April 2020 and March 2021, we provided a myriad of support and organised charitable activities for a wide range of groups, people and individuals. These activities are grouped into cultural, training and capacity building, well-being and social support categories.

In June 2020, PA purchased covid test kits, air disinfection machine from Hong Kong to ensure that the centre can be used safely when open to the public again. The Consul General of the People's Republic of China donated masks, thermometers, and Chinese food parcels to the vulnerable.

1: Arts & Cultural

1.1 Pagoda Chinese Youth Orchestra (Fund by ACE)

In between April 2020 and March 2021, the PCYO conducted most of the training sessions on zoom. Before the first lockdown, all orchestra members reported that they had been targeted in schools or public transports, had been spat on, or called Chinese virus. Our music director observed the serious impact on the youngster, she contacted the local education authority, police and the council inclusion department.

LCC Education authority acted swiftly and post emails to all schools, nursery, and higher education colleges to raise awareness of the situation. Police were informed and within a week, our direct and other organisation (Wirral Multicultural centre, Anthony Walkers Foundation) had meeting with Central government representative, calling a stop to using "Wuhan Virus" in all broadcasting.

PCYO resumed face to face practise between July - October with reduced hours and size. However, many parents were unsure with the Covid 19 and didn't let the children come back to practise. In January 2021, PCYO lost more members during the 3rd lockdown. By March 2021, members were reduced to half the size.

Recorded performances were made in October, and January. The young people wrote a song 'Isolate' as part of the Black History Month. 'Isolate' https://youtu.be/IsNzS8L6000 using hip hop and Chinese sounds to explore the various emotions and difficulties of the Chinese communities faced before and during lockdown - including thoughts on racism, isolation, loneliness and space. Instruments and popular sounds from the West and East as well as English and Chinese vocals will be combined to convey their message. In this video, 6 people shared their stories and thoughts.

Also recorded performance of the orchestra was featured in Manchester, Southampton and Liverpool as part of the Chinese new year online celebration, and the national day celebration, reaching to wider cities.

1.2 Leisure entertainment group

Music, dancing and singing are a form of activity that may promote wellness by strengthening the immune system through muscular action and physiological processes. These creative activity also played an important part in everyone's mental wellbeing In the Pagoda Arts centre. We have music and dancing classes for both children and adults with all ages.

During the pandemic, with the funding from Award for All and extra funding from Sport England - Tackling Inequalities Funding and Merseyside Police, enabled us to keep the community activities engaged through zoom and WeChat groups. In the 2nd lockdown, everyone was more prepared, and Pagoda Arts purchased tablets and gave them out to orchestra members or people who have no tablets or computers at home. We ran 3 workshops to show people how to use the gadgets and login in to Zoom. PA set up various groups for children and adults.

a) Creative writing with Writing On the Wall. 34 young people (age 10 - 14) worked with Naomi Chan exploring and expressing in writing on the impact Covid-19 has had on their lives.

Here are two examples:

"I wish I could tell my mum she doesn't understand the racist bullying I go through, I wish she'd give me an English name!"

"I am not someone that is going to eat your dog,

I am not someone who has the answers to every single question

I am not always well behaved

I don't have smaller eyes than you, my are perfectly fine

I don't only have Chinese friend I have others too,

I don't know which Chinese person you are talking about,

I don't know how to write your name in Chinese, isn't it just the same

We will not give you coronavirus because we coughed and

We will not get bullied by you."

- b) Entertainment group on WeChat is a platform where approx. 70 people share their drawing, creative writing, dance video or their karaoke singing with everyone. Two of the members in the group worked with Mrs Li on lyric writing, then recorded as a duet on the Karaoke app as part of the CNY celebration programme. Their song and compositions from one of our young emerging artist were used for Liverpool Culture Company CNY video.
- c) Year of the Ox Mural The Mural project was commissioned by the Culture Company. PA to work with Writing On the Wall, Zapp Graffiti and Alexis from Paris. Over 100 people of all age from the Chinese community took part, in discussion of the storyline and design. Volunteers were helping out with the painting. After the project, Merseyside police gave extra funding for PA, WOW and Zapp Graffiti to work with the local teenagers around Chinatown to design and paint their own mural.

1.3 Young Emerging Artists

Due to lockdown and all works quickly becoming internet based. PA were able to extend the young emerging artist programme to the USA, and China. In May 2020, the young emerging artists and Jah Wobble worked on a 200 year old Cantonese folk song 'Little Rooster' which was live streamed as part of the Phoenix Youth Orchestra (based in the USA) annual performance. 3 generations of a family performed this nursery rhyme. People around the globe watched the performance live, more have viewed it on the YouTube channel later.

GZ Tian released his debut album in April 2020. His single finished on Apple Music top 100 hip hop list, and Single (Yin Yang) was No. 1 on the hip hop chart in Sweden.

John Tianqi was runner up on two of the Wangyi Yun competitions for up and coming independent artists in China, (participant between April - August). He was signed to Kanjian Distribution in China.

2: Community activity

- 2. 1 Training and Capacity Building programme
- " Due to covid most training/capacity building was moved to online Zoom sessions. We managed to complete 3 food hygiene courses in between the lockdowns.
- " As hate crimes and race speech increased towards the ESEA communities Pagoda worked closely with the Merseyside police.
- " All members of staff attended online training and seminars with Chinese communities nationwide regarding how to support each other in the UK Chinese community.
- "We are networking with other communities and organisations such as Writing on the Wall, CoOL, Stop Hate UK, CARG, Anthony Walker Foundation and how to deal with hate issues and speak with those effected.
- "We also teach the community how to report incidents to police/appropriate authorities.

2.2 ESOL and other classes

All ESOL lessons were moved to online during the lockdown period, and returned to the centre in between lockdowns/ and as restrictions began to ease. Social distancing was maintained by using the main hall only. Numbers were restricted to comply with government safety guidelines. Thus only one activity at a time was possible.

2.3 Community Support

Due to daily updates with regulations, new guidelines and lockdowns Pagoda Arts staff have been working hard translating information to distribute via Wechat for chinese speaking families, and vulnerable people.

2.3.1Hate Crime in Liverpool

- " An alarming number of international students informed staff at Pagoda Arts of violent attacks, and hate speech directed towards them. Most cases went unreported
- " Pagoda was set up as a third party hate crime reporting centre.

" A victim of a hate attack was wrongfully prosecuted by the crown court, he came to PA for support. Pagoda worked closely with the Merseyside Hate Crime commission, and 3 Chinese communities in London. 75 Chinese organisations across England, signed joint letters or wrote individually to express concern with the lack of justification of this specific case. The relevant authorities including CPS have admitted to overlooking hate crime issues in this case and have reviewed their guidelines, and will continue to work closely with the ESEA community to prevent similar issues occurring again.

Pagoda Arts is assisting by: -

- " Organising seminars and meetings on Zoom for Student representatives and staff.
- " Sharing information and news on chat groups from BBC news, Newspapers, and reports.
- "Organising discussion seminar on Zoom partnership with Stop Hate and Police Hate commission
- " Meeting monthly with London Metropolitan police and ESEA community leaders for update with Hate crime issues on Chinese community around UK
- " Meeting regularly with Community officer to update with issues with Chinese community in Liverpool and Wirral.

2.3.2 Covid-19 News and Updates

Our centre provides general news and information of Covid-19, including:

- " Updating news from NHS, such as Covid-19 Test and test centres, vaccination
- " Sharing guidelines and information of travelling to China during the pandemic based on the source from Chinese Embassy
- " Passing on health tips, preventions, symptoms
- " Sharing news and information on how to prevent scam from online and in person
- "Translating policies and regulations during and at the end of Lockdown
- " Giving out covid testing kit to centre users.

Covid-19 Financial Support schemes from Government

- " Government Help Scheme (Furlough, Companies Grant scheme, Test and Trace Grant, Green Home Grant) we assist and provide information for people who needed these schemes.
- 2.4 Well-being & Social Support:

Throughout the lockdown, we ran weekly classes on Zoom:

- " 3 Tai chi classes weekly
- " 2 x 20 minutes keep fit classes appropriate for family (where parents looking after children)
- "2 keep fit classes for young people. (6 -12, 13 24)

2.5 Benefit surgery

Benefit surgeries were all conducted on 3 ways calls with interpreter.

Public benefit

The Pagoda Chinese Community Centre has been serving the Liverpool Chinese community for more than three decades.

This group of people face challenges to integrate into the local community and often isolate themselves from society. Pagoda Arts centre provides community open access where we survey, interview and hold discussions with numerous community members to obtain their opinion and ideas to target problems and challenges face by local communities. Our centre is regularly approached by new Chinese immigrants, oversea students, refugees, asylum seekers seeking help, advice and support, including assistance with language barriers.

The trustees confirm they refer to the guidance contained in the Charity Commission's general guidance on public benefit when reviewing the charity's aims and objectives, and in planning all of it future activities.

FINANCIAL REVIEW

Reserves policy

The trustees have set a reserves policy based on the requirement of retaining the equivalent of at least 6 months running costs in general reserves. The optimum range is considered to be between £60,000 to £85,000. The current general fund position, excluding designated funds, meets the requirements of the policy.

The trustees have separately set aside a designated building fund, amounting to £200,000. The building that the Charity operates from, is due to be transferred by its existing owners to the Charity in the next financial year. Once the transfer has completed, the Charity will become responsible for some long overdue repairs and maintenance to the building. The fund balance represents the fair value of works required.

STRUCTURE, GOVERNANCE AND MANAGEMENT

Governing document

The charity is controlled by its governing document, a deed of trust, and constitutes a limited company, limited by guarantee, as defined by the Companies Act 2006.

Future plans

Due to the long lockdown, people will be keen to get back to a routine. People are already expressing they can't wait until the Covid-19 virus is under control. Our financial situation is still strong. The building asset transfer is still uncertain, however, we hope it will be completed in the financial year to 31 March 2022.

Reserves policy

The designation of £200,000 building fund will be ring fenced to be spent when the asset transfer has taken place. At that time, Pagoda Arts will be responsible for the running costs and maintenance of the building. The remaining reserves will cover 6 months of staff wages and project costs.

1. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements of the charitable company, which is a public benefit entity under FRS 102, have been prepared in accordance with the Charities SORP (FRS 102) 'Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2019)', Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

Income

All income is recognised in the Statement of Financial Activities once the charity has entitlement to the funds, it is probable that the income will be received and the amount can be measured reliably.

Expenditure

Liabilities are recognised as expenditure as soon as there is a legal or constructive obligation committing the charity to that expenditure, it is probable that a transfer of economic benefits will be required in settlement and the amount of the obligation can be measured reliably. Expenditure is accounted for on an accruals basis and has been classified under headings that aggregate all cost related to the category. Where costs cannot be directly attributed to particular headings they have been allocated to activities on a basis consistent with the use of resources.

Tangible fixed assets

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.
