The Trustees present their report along with the financial statements of the Charity for the year ended 31 March 2021. The financial statements have been prepared in accordance with the accounting policies set out on page 10 and comply with the Charity's trust deed and applicable law.

1. Objectives and Activities

The objects of the CIO are:

- a) To promote for the benefit of the public the conservation, protection and improvement of the physical and natural environment;
- b) To advance the education of the public in the conservation, protection and improvement of the physical and natural environment;
- c) To promote human rights (as set out in the Universal Declaration of Human Rights and subsequent United Nations Conventions and Declarations) throughout the world by all or any of the following means:

Monitoring abuses of human rights;
Obtaining redress for the victims of human rights abuse;
Relieving need among the victims of human rights abuse;
Research into human rights issues;
Providing technical advice to Government and others on human rights matters;
Contributing to the sound administration of human rights law;
Commenting on proposed human rights legislation;
Promoting public support for human rights;
Promoting respect for human rights among individuals and corporations;
International advocacy of human rights;
Eliminating infringements of human rights.

In furtherance of that object but not otherwise, the Trustees shall have power to engage in political activity provided that the Trustees are satisfied that the proposed activities will further the purposes of the Charity to an extent justified by the resources committed and the activity is not the dominant means by which the Charity carries out its objects.

N1M Trust makes grants to organisations working to support environmental human rights defenders.

N1M Trust engages in public education, efforts to uphold human rights and to protect the environment.

Primarily N1M Trust in the second year of operation (this reporting period, 5 March 2020–31 March 2021) has worked with Not1More, Registered company 11545187, to support four projects with advice and guidance, and also financial funding.

N1M Trust may use staff time, free of charge, provided by members of Not1More up to three working days per month to support The Trust's administrative needs and to support accounting. The Trust will nevertheless remain responsible for all filings, records, meeting minutes and accounts.

4. Achievements and Performance

During this second period of operation the main achievements of N1M Trust were to support research into the drivers of human rights abuses, the impact of the pandemic on environmental human rights defenders, and support to a peer network and programme of support for Brazilian at-risk environmentalists and land defenders.

A grant from Joseph Rowntree Charitable Trust funded research and drafting of a report on human rights violations by UK police against environmental defenders. Alongside this research, Not1More produced a documentary on police violations of human rights. It was first screened privately and shortly after shown by Vice. It has been viewed 492,000 times.

Martin Stanley funded "Violence Footprint" program of work in Brazil and Cambodia. Under the 'Violence Footprint' project N1M Trust gave a grant to Not1More under which:

- Not1More supported Brazilian defenders and platformed their voices on the BBC, aired in the UK and Brazil..
- Publication by Not1More of a research paper that Brazilian defender Claudelice Da Silva Santos presented at European Parliament.
- A paper co-written by Not1More describing the work and necessity of the new group "Geneva Roadmap" was published in 2020, (it went on to win an award in December of 2021.)
- The 'Um Outro Céu' website launched in late 2020 and documentary (January 2021), mapping environmental conflicts in Brazil and showcasing new work by indigenous artists.

With N1M Trust support, Not1More completed research into how governments in South East Asia used COVID-19 regulations to suppress Environmental Human Rights Defenders by interviewing defenders across the region and compiling a report.

Open Society Foundation (OSF) funded work in Brazil to support human rights defenders proceeded from October 2020.

5. Financial Review

The Trustees are happy with the position of the Charity at the end of the second period.

N1M Trust received grants from six main sources:

Joseph Rowntree Charitable Trust;
Patrick Westoo, an individual whose donations have been gift-matched by his employer, Google, and administered by the platform Benevity; Martin Stanley, an individual philanthropist who makes donations via the Charities Aid Foundation (CAF account); United Nations Environment Programme; and Open Society Foundations (OSF)

6. Reserves Policy

The aim is to have sufficient reserves will be held to enable running costs to be met for at least three months. Amount of reserves held £3,620.

7. Structure, Governance and Management

Trustees are selected on their skills relevant to the Charity's title deeds. Every new trustee must be appointed for a term of two years by a resolution passed at a properly convened meeting of the charity trustees.

In selecting individuals for appointment as charity trustees, the charity trustees must have regard to the skills, knowledge and experience needed for the effective administration of the CIO.

Trustees must sign the Trustee Declaration.

The charity trustees will make available to each new charity trustee, on or before his or her first appointment:

- a copy of the current version of the CIO constitution; and
- a copy of the CIO's latest Trustees' Annual Report and statement of accounts.

New trustees will be invited to join conversations or informal meetings with the other board members, and / or with staff of Not1More, the not-for-profit company that is working with N1M Trust to implement a number of projects supported by the Trust.

The charity has no staff but receives voluntary support for administration from the staff of Not1More (see below).

N1M Trust has an Agreement with Not1More, a charitable incorporated company, limited by guarantee, registered in England and Wales, Registered company number: 11545187.

Having identified significant shared aims between N1M Trust and Not1More, the parties have agreed to cooperate, jointly fund and work together on projects when the project objectives and activities are charitable, advance the Purposes of N1M Trust and present an effective way to advance and support the welfare of environmental defenders.

Any joint venture will have educational merit; or will advance human rights, specifically Articles 3, 5, 8, 9, 10, 19 and 20 of the Universal Declaration of Human Rights, or Articles 3, 8, 10, 18, 20, 25, 26, 27, 28, 29, 32 of the UN Declaration of the Rights of Indigenous Peoples; or will contribute to the protection of the natural environment, specifically areas deemed to be of national or international importance, or that play a significant role in mitigation of or adaptation to climate change

8. Risk Management

The Trustees have conducted a review of the major risks to which the charity is exposed. Systems or procedures have been established to mitigate the risks which the Charity faces. All risks fall into the low or medium categories. Internal control risks are minimised as the Trustees authorise all transactions.

Opinion

We have audited the financial statements of N1M Trust (the 'Charity') for the year ended 31 March 2021 which comprise the Statement of Financial Activities, the Balance Sheet and notes to the financial statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard FRS 102, the Financial Reporting Standard applicable in the UK and Republic of Ireland (United Kingdom Generally Accepted Accounting Practice).

In our opinion the financial statements:

- give a true and fair view of the state of the Charity's affairs as at 31 March 2021, and of its incoming resources and application of resources for the year then ended;

In preparing the financial statements, The Trustees are responsible for assessing the Charity's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Trustees either intend to liquidate the Charity or to cease operations, or have no realistic alternative but to do so.

Auditor's responsibilities for the audit of the financial statements

We have been appointed as auditor under section 144 of the Charities Act 2011 and report in accordance with regulations made under section 154 of that Act.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs (UK) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We design procedures in line with our responsibilities, outlined above, to detect material misstatements in respect of irregularities, including fraud. The specific procedures for this engagement and the extent to which these are capable of detecting irregularities, including fraud is detailed below:

- Reviewing financial statement disclosures and testing to supporting documentation to assess compliance with applicable laws and regulations;
- Performing audit work over the risk of management override of controls, including testing of journal entries and other adjustments for appropriateness, evaluating the business rationale of significant transactions outside the normal course of business and reviewing accounting estimates for bias.

Because of the inherent limitations of an audit, there is a risk that we will not detect all irregularities, including those leading to a material misstatement in the financial statements or non-compliance with regulation. This risk increases the more that compliance with a law or regulation is removed from the events and transactions reflected in the financial statements, as we will be less likely to become aware of instances of non-compliance. The risk is also greater regarding irregularities occurring due to fraud rather than error, as fraud involves intentional concealment, forgery, collusion, omission or misrepresentation.

As part of an audit in accordance with ISAs (UK), we exercise professional judgment and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Charitable Company's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the Trustees.

Basis of accounting
