Family Life Groups

Employability Support

We always try to support those needing assistance in securing employment. Offering help in creating an up to date CV, help completing job applications, job search, Universal Credit journal updates, etc. This has been done through our advice services.

However, with the increase in unemployment due to companies not able to withstand the loss of income due to the Pandemic, we estimated there would be more support needed for the community we serve.

We were able to secure funding from the Foyles Foundation to deliver a virtual/digital course offering expertise in Interview skills, Job search, CV's, Job application completion, where to look for jobs retraining opportunities, how to prepare for an interview, tackling our fears, benefits to claim, and answering any questions the learners might have.

This was a successful endeavor and we were able to help many who were struggling from losing their employment, many had never been unemployed before, who needed step by step guidance.

Celebration Meetings

Meeting each week at 10:45am, Celebration is the main church service of the week. Services resumed on Easter Day 2021.



The work of the Place of Welcome has had to be suspended until it is safe to reopen to larger groups. Hoping this won't be for long as many individuals in our Community depend on us for company, friendship and a smile. Praying for a swift end to the limitations on us presently so we can continue our much needed help and support.

We also provide Food Bank Vouchers for families and individuals who are struggling due to some financial deficit. Presently these are being dealt with digitally or via a phone call for an appointment to be made to collect.

We also provide Food Parcels of fresh produce to those who are struggling, these presently are being arranged on a one-to-one basis via a visit to our facilities, where a staff member provides a food and toiletries parcel. For those unable to leave their home, a home delivery is arranged.

Through a successful Grant application from the Government via National Lottery, we were able to employ a temporary part-time Covid Response Worker. He has been able to work with those struggling with the negative effects of the pandemic. He has visited homes, delivered groceries and food/toiletry parcels, given lifts to those scared to use Public Transport, helped with job search for those who sadly lost their employment, benefit claims and has even helped with house moves.

This role has been extended through another grant application to the Community Fund and the Community will continue to benefit from this support until

February 2022.

Centrepoint Support Centre

Centrepoint Support Centre has several arms to it's meeting the needs of our Community. We offer Benefits Advice. We help with residency applications to remain in the UK and help avoid the increasing number of fraudsters that are charging for their services in the area. We also offer Financial Capability, offering clients the chance to chat through their Budget and get help tackling their Priority Creditors.

Thereby, our services have grown in popularity. The service is accessible to all, with a disabled friendly wide door, no steps, a large toilet space with disability aids. Plus, we have access to several translators to interpret the many languages of people that presently live in the Sandwell area from the EU and other countries.

We continue to be part of the Sandwell Providers Network and our work is monitored by

them to ensure good quality standards remain throughout the year. Our Advisors and their Supervisor attend the monthly meetings that are used to discuss and be aware of current changes of policy and to share common good practice. Regular training opportunities are given our advisors to ensure they are fully up to date with all new legislation and practice.

When the first lockdown restrictions were introduced we worked remotely and via telephone. However, we applied for funding to make our building Covid-safe, screens, sanitising stations, laptops for mirror screening, extra furniture to work socially distanced, more telephones, signs, masks, markings, etc. We were successful and so opened our doors to the public quite quickly. We have remained open ever since.





Centrepoint Christmas Giving

Christmas 2020 was another year of showing our Community that we care and that they matter Many families in our Community are struggling to survive, let alone being able to buy presents for their children, and special food and goodies. So through our networking, we asked for

referrals of families that needed provision of toys and goodies for their children. We also sent out a request for those who would like to donate toys and goodies to families who were struggling.

The response for both was good and generous. A team of Church volunteers put together the hampers of food, wrapped toys and goodies for 25 families. The Church also purchased some toys from In Kind Direct at a reduced cost.

The families were very grateful for all they received and so were the organisations that had referred them. We were grateful for the opportunity to give to struggling families. It was fulfilling to us all to give generously and cheerfully. As our Lord teaches us to do.

Centrepoint Supported Housing Project

We continue to provide a House for Homeless men, giving the day to day support that is needed when moving from a place of Homelessness to Independent living. Offering support with benefits, employability skills, health and hygiene, budgeting, cooking and cleaning support. We work in close partnership with Hope into Action, they work with all the admin and landlord responsibilities and together we work in supporting the tenants. We have had a longer term tenancy but also shorter ones too. Endeavouring to remain in contact when they move on, so as to ensure a smooth transition. The ability to welcome people, to give them a sense of belonging and to see wonderful relationships and friendships being forged is a blessing.

Obviously there have been some challenges but it's been worthwhile.

We get fantastic support from Hope into Action and we've

learnt from the challenges. They've made us stronger and better equipped to put that new knowledge into practise.

The volunteers who support the residents enjoy seeing the difference their ongoing support is making. Encouraging independence and the resilience that's needed for our house guests to succeed. Through Lockdown we have continued to support at a distance. Through phone calls checking in how they are doing and if they need any extra support.

However, the loneliness and isolation has been tough on the residents effecting their mental health negatively. They are looking forward to being able to visit the Church and Support Centre again. As we all are.

Financial Report

This years accounts are reflecting differences from other years as it reflects our success in grant applications made and a higher rate of charitable giving. The Grants were applied for as we saw the needs of the Community and our willingness to help with those needs as much as possible. Our greatest aim was to still be available to the Community as much as possible, whilst protecting our staff and volunteers. A Grant from SCVO assisted with this goal, as did a grant from Heart of England prior to this financial year. We needed to employ someone who's primary mission was to help those struggling with the negative consequences of the pandemic, either directly or indirectly. Government funding via the National Lottery provided that income stream, then when that funding come to an end, the Community Fund gave us another grant for same. As mentioned previously, Foyles Foundation funded our 'digitally delivered' employability course. 'Neighbourly' gave us a small grant to help restock our food pantry, which was much needed to continue our food parcels distribution. The SMBC Grant is ongoing presently and it pays the wage of our Half-Time Benefits Adviser.

So, the Church has been well blessed to receive the funding needed to continue our work and increase our service to our community to meet their needs during this pandemic. We are most grateful to each grant provider in this.

Also, a Big Thankyou goes to In Kind Direct. Because of their provision of much reduced toiletries and cleaning equipment, we have not only been able to stay safe as an organisation ourselves but also been able to equip our service users with the means to do likewise. Some of this is reflected in the Charitable Giving figure, however most of it was paid for by generous Church members.
