- Extensive supports were given to members throughout the year through phone calls, counselling, and prayers by the principal officers of the Church
- More welfare packages were distributed to members in cash, food items and other materials as palliatives throughout the year.
- Diadem School of Faith took off with the inaugural 2021 Session seeing online students from the United kingdom and Africa registered and completing the 10 weeks course.

- The foreign mission supports through cash donations to various field missions was to the tune of 10% of all the ministry's income and include support for special mission to Angola through one of our mission partners in Africa.

All donations received were voluntary giving of our members through tithes, offerings, and special giving.

Budget performance in term of expected income and expenditure versus the actual income and expenditure was positive.

VOLUNTEERS:

The church had more volunteers trained and added to the existing work force.
