Accounts for the period ended 30 June 2021 Report of the Trustees



The trustees are pleased to present their report together with the financial statements for the period ending 30 June 2021.

Our purposes and activities

Our purpose is to further such charitable purposes (charitable under English law) as the trustees see fit from time to time by the provision of grants in Colchester and the surrounding areas. Our activities are predominantly the organisation and running of amateur sporting events, principally the Colchester Half Marathon, and other general fundraising activities. The trustees confirm that they have referred to the guidance contained in the Charities Commission's general guidance on public benefit when planning future activities and making grants.

Due to the ongoing restrictions on mass-participation events the Trustees decuded not to hold an event during the period. Balances retained in respect of entries deferred from the cancelled 2020 Colchester Half Marathon have been held on the charity's bank account.

The accounts for the period to 30 June 2021 show no income & expenditure activity. Ttransactions during the year have been restricted to settling outstanding balances from the canelled 2020 event, and maintaining our online presence.

We have maintained close relationships with our charity partners from 2020 and are planning the next event in 2022 with them.

The charity maintains strong links to Colchester Colne Round Table, and all current trustees are current or former members of that organisation.

Independent examiner's report to the trustees of Colchester Half Marathon

I report on the accounts of the Trust for the period ended 30 June 2021, which are set out on pages 1 to 3.
