Para 1.20	Supporting over 25 families within Wrexham by providing them with household items, support in the form of signposting them to legal support, housing support and medical assistance as well as guiding them through their use of various local charities and government departments. Many of the charities are grateful for our assistance as they were previously unable to reach the families. We raised significant private donations through fundraising events (raffle, cake sales) enabling us to pay a Charity Manager. The paid employment of a Charity Manager has enabled us to continue providing our services.

We have paid £2,381.28 for the charity manager salary for the first two months and we pay for a Lockstock unit which we use as a drop off point for items in transit to the beneficiaries. We now hold £16,177.00 in reserves to cover our salary expenses for the next accounting year.

In the near future, our manager will need administrative assistance. We are making applications for grant funding in the hope of securing such assistance.
