## **Objectives and Activities**

Summary of the purposes of the charity as set out in its governing document	Para 1.17	The objective of Coleridge Families is to advance the education of the pupils of Coleridge Primary School in the London Borough of Haringey by providing and assisting in the provision of facilities for education at the school (not normally provided by the Education Authority).  As an ancillary thereto and in furtherance of this object Coleridge Families may:  A) encourage co-operation between the staff, parents and all others associated with the school;  B) engage in activities (including fund-raising activities) which support the school and advance the education of the pupils attending it; and  C) encourage parents to be interested in the education of their children and the activities of the school.
Summary of the main activities in relation to those purposes for the public benefit, in particular, the activities, projects or services identified in the accounts.	Para 1.17 and 1.19	In the 2020 AGM, Coleridge Families adopted a new constitution, using the Parentkind model constitution. As a result of the new governance structure, a number of new committee members were appointed as trustees. Several long-standing members stood down as their children graduated from the school.
Statement confirming whether the trustees have had regard to the guidance issued by the Charity Commission on public benefit	Para 1.18	2020/21 was a year of substantial donations from parents to the newly launched school's Coleridge Voluntary Fund, which has been used to provide £40,000 of ICT equipment, invest £12,000 in training and development of the school's staff, purchase £5,000 of new art supplies, purchase £12,750 of new classroom supplies, deliver school's counselling service worth £25,000, invest £6,000 in new reading books, and spend £2,500 on new dining tables for the infants.  WHAT DID THE CHARITY FUND IN 2020/21? A total of around £37,000 spent on investment including:  - £15,000 on improving toilets - £12,000 on Year 6 garden

In addition there is a network of class reps (representatives) who generate participation in events, fundraisers and help distribute information to the parents.
		The charity was operating in a constrained fund-raising environment due to the COVID-19 pandemic throughout 2020/21 and as such many of our event fixtures have been put on hold. The committee and energised parents are continually seeking ways to innovate and adapt by running events on-line and running different types of events that are suited to virtual participation.
		Some of the new fundraising activities that we ran in 2020/21:  - Coleridge Cookbook that resulted in CF first major publication, with over 170 recipes submitted from within the school and the community  - Pumpkin and Easter Trails  - Online Quiz  - Online Music Bingo  - Coleridge Jokebook – our second publication, with over 200 submissions, including comic strips  - Coleridge Pet Show with over 270 entries from across the school community

Para 1.20	2020-2021 was a year of more limited activities due to the COVID-19 pandemic and yet still very significant fund-raising and development projects made possible by Coleridge Families.  - Major improvement to the school loos facilities  - Installation of green screens on the East site of the school  - Significant contributions from parents via donations  - Significant contributions from Martyn Gerrard our sponsor
		Looking ahead, the charity has earmarked c £157,000 for specific grants to Coleridge Primary school. This includes:
		<ul> <li>c £105,000 towards Coleridge Voluntary Fund (incl. Gift Aid)</li> <li>£17,000 to continue planned redevelopment of the playground areas, making this a safer and more useful area for children and building on c. £59,000 already invested.</li> <li>There is £10,000 held aside to replace the turf on the multi-use games area (sports pitch).</li> <li>There is a further £11,600 dedicated to provide financial support to the school, funded from voluntary financial contributions via donations towards the Learning Enhancement and Voluntary funding of the school. These funds will be deployed when needed to fund areas of the School Development Plan (SDP). Some money will also be used to cover essential school running costs, for example educational resources and premises costs. The Resources Committee of the school's Governing Body will scrutinise spending and will hold the Senior Leadership Team to account, ensuring that the fund is appropriately spent to provide maximum impact.</li> <li>c £4,400 for SEND projects</li> <li>Finally there is £1,500 dedicated to projects to improve the air through the students Clean Air Coleridge project.</li> </ul>
